#### CASE SUPPORT WORKER

The National Inquiry into Missing and Murdered Indigenous Women and Girls (National Inquiry) is seeking experienced Casual, Part-time and Full-time Case Support Workers.

The National Inquiry is independent from the federal government, and employees are appointed on a term basis. We are committed to having a skilled and a highly indigenous represented workforce. We encourage candidates to self-identify when applying.

## **KEY ACTIVITIES**

- The incumbent works in an environment that is focused on supporting family members and survivors of violence who have shared their truths in the Truth Gathering process.
- S/he is required to perform duties that are in keeping with cultural and professional protocols while gathering basic information, providing support, consulting with local nations or organizations to maintain links to families, communities and Indigenous organizations.
- Responsibilities include assisting with the drafting of plans of care; working closely with families of missing and murdered Indigenous women and girls and survivors of violence; making referrals to external support services; developing and implementing a strategy to support families in the aftercare phase of the Inquiry process; and record keeping and client information management.
- The incumbent also provides emotional support by creating an atmosphere of trust as well as providing informational support on the Inquiry process and identifying next steps.
- S/he understands the historical context of Indigenous peoples in Canada and how it contributes to the widespread impact of trauma, recognizes the signs and symptoms of trauma, understanding considerations needed to contribute to wellness and integrates knowledge about trauma into communications and settings and understands how to implement into daily practice.

### Language requirements

- Fluency in oral and written English is essential. Fluency in oral and written French is essential for bilingual positions.
- Fluency in oral Indigenous Language an asset.

• University degree in a related field such as counselling, social work, or a combination of equivalent education and experience.

- Experience working within a Trauma Informed Care organizational structure that involves understanding, recognizing, and responding to the effects of all types of trauma
