

1 [MS. JOLENE JOE]: Casino. [MS. BERNICE TOUCHIE]: The casino had a 2 video of the entire area and it showed on the video. 3 [MS. BERNICE TOUCHIE]: That he was kicking 4 5 her. 6 MR. BREEN OUELLETTE: So they were walking 7 along the railroad and ---8 [MS. MARCINA JOE]: Behind ---9 MR. BREEN OUELLETTE: --- he physically 10 attacked her? [MS. JOLENE JOE]: Behind the casino in 11 Duncan there's railroad tracks. And the recording from the 12 casino caught it on tape. JOLENE JOE]: He was still in the 16 hospital when we went to see her for the last time there. 17 MR. BREEN OUELLETTE: M'hm. 18 [MS. JOLENE JOE]: And then he's the one 19 that told me that. Somebody told him that because we were all told 23 24 at the hospital that she was getting kicked in the face. 25 MR. BREEN OUELLETTE: But then somebody told

JOLENE JOE]: An ambulance. 9 10 MR. BREEN OUELLETTE: An ambulance came? [MS. JOLENE JOE]: Yeah. 11 12 MR. BREEN OUELLETTE: Did somebody report 13 it? Did somebody see it? [MS. MARCINA JOE]: The Superstore security 14 15 guard seen he was dragging -- trying to drag her into the bush by the track. I think he was just going to leave her 16 17 there. 18 MR. BREEN OUELLETTE: So when you say "saw 19 someone dragging her into the bushes" you mean ---20 [MS. MARCINA JOE]: [A.J.]. MR. BREEN OUELLETTE: --- [A.J.]? 21 22 [MS. MARCINA JOE]: Yeah. MR. BREEN OUELLETTE: And do you remember 23 24 who told you that? 25 [MS. MARCINA JOE]: No, just one of my

family members. 1 MR. BREEN OUELLETTE: M'hm. 2 3 [MS. MARCINA JOE]: It was probably Req. MR. BREEN OUELLETTE: Okay. So then an 4 5 ambulance came. Does anybody know when the ambulance came if the police came as well? 6 [MS. MARCINA JOE]: I don't know. 7 MR. BREEN OUELLETTE: No? 8 [MS. JOLENE JOE]: It was like, 2:00 or 3:00 9 in the afternoon. 10 [MS. JOLENE JOE]: None of us remember going 11 with them (inaudible). 12 MR. BREEN OUELLETTE: M'hm. 13 [MS. JOLENE JOE]: It was like, 2:00 or 3:00 14 15 in the afternoon when she got picked up from the incident where it happened and then it was 3:00 in the morning --16 17 approximately 2:00, 3:00 in the morning when she passed 18 away. 19 MR. BREEN OUELLETTE: Okay. 20 [MS. JOLENE JOE]: So 12 hours. MR. BREEN OUELLETTE: So they left that bar 21 around 2:00 in the afternoon? 22 [MS. JOLENE JOE]: Yeah. 23 24 [MS. JOLENE JOE]: I'm not even sure. Ι don't know about that part, if they were at a bar. I don't 25

1 know. [MS. JULIA IDA JOSEPH]: They used to drink 2 3 outside too. [MS. MARCINA JOE]: Yeah, used to drink ---4 5 [MS. JOLENE JOE]: Because they were caught. 6 Where they were is called the Jungle Bunnies. I don't 7 know, that's just the name of the place where like, 8 homeless people, I guess, drink in Duncan. It's like, behind the casino there. Because when I went to try go 9 look for [A.J.] -- because I was trying to look for him 10 after Mom passed to deal with like, banking and stuff --11 and I couldn't find him, but that's where everyone -- they 12 were like, "Go to the Jungle Bunnies." 13 And I tried to look around there and nobody 14 15 had seen him. I guess he left and went to his daughter's in Victoria and I just -- I never ever got a hold of him. 16 17 And then he passed away within six months or so after Mom 18 passed. 19 [MS. JULIA IDA JOSEPH]: Within a year, I 20 think. [MS. JOLENE JOE]: A year? 21 [MS. JULIA IDA JOSEPH]: Yeah. 22 23 [MS. BETTY KNIGHTON]: It was a year. MR. BREEN OUELLETTE: Sorry, he -- when you 24 say "he"? 25

I'm trying -- just so you know 6 for your information, I'm trying to set out the timeline 7 and ensure that we know the steps and ---8 [MS. JOLENE JOE]: Oh, okay. Each steps. 9 MR. BREEN OUELLETTE: --- where we need to 10 look for records, okay? [MS. JOLENE JOE]: Okay. 11 MR. BREEN OUELLETTE: So the ambulance was 12 13 called and she was taken to which hospital? [MS. JOLENE JOE]: Cowichan, Cowichan 14 15 District Hospital. 16 MR. BREEN OUELLETTE: Can you tell me how 17 that's spelled? 18 [MS. JOLENE JOE]: C-O-W-I-C-H-A-N. 19 MR. BREEN OUELLETTE: District Hospital? 20 [MS. JOLENE JOE]: Yeah. MR. BREEN OUELLETTE: And so how was the 21 family contacted to know that she was there? 22 [MS. MARCINA JOE]: The cops came to my 23 24 door. 25 They came to you? MR. BREEN OUELLETTE:

[MS. MARCINA JOE]: M'hm. I don't know how 1 2 they found out. 3 [MS. JOLENE JOE]: From me. Me and my family were on our way to the PNE and we just got over 4 there and we were trying to find a place to stay because 5 the place we were going to stay had too many people so we 6 7 had to find a new place. So we were at Main and Hasting -- or no, 8 9 Main and First Avenue, the Main Street SkyTrain station and 10 we got a phone call saying that my mom was on life support. So me and my family, we rushed to the 11 12 Tsawwassen ferry trying to make it to get back to the island to go see her. And we missed the ferry by five 13 So we waited in line til 5:00 in the morning for 14 minutes. 15 the first ferry and roughly like, 2:00 to 3:00 in the morning my mom passed away. 16 17 So then we caught the first ferry and went 18 straight to the hospital and she was gone already. And I 19 had all my four children with me so they seen me, the devastation that I was in waiting in the ferry lineup. 20 Ι had to go walk away because I didn't want to cry in front 21 of my kids like that. 22 MR. BREEN OUELLETTE: And so the police came 23 24 to your home? 25 [MS. MARCINA JOE]: Yeah.

1 MR. BREEN OUELLETTE: And they told you 2 what? 3 [MS. MARCINA JOE]: That my mom was in the hospital on life support. 4 5 MR. BREEN OUELLETTE: And then what happened 6 for you? [MS. MARCINA JOE]: I came to the island as 7 quick as I could. I was living in the city [Surrey] at the 8 9 time. 10 MR. BREEN OUELLETTE: When did you get 11 there? [MS. MARCINA JOE]: The night before the 12 funeral. 13 MR. BREEN OUELLETTE: And so the funeral was 14 15 which night? [MS. JOLENE JOE]: It would have been the 16 17 29th, four days after. It was in the (inaudible). I can't 18 even remember that part. 19 [MS. MARCINA JOE]: I think it was that long because they didn't have any -- much investigating to do, 20 right, because they knew what happened to her. 21 22 [MS. JOLENE JOE]: I think it was, because I remember after two days I cut my hair. 23 24 [MS. MARCINA JOE]: Yeah, it must have been 25 the 29th.

[MS. JOLENE JOE]: M'hm. 1 MR. BREEN OUELLETTE: So the funeral was on 2 the 29^{th} ? 3 [MS. MARCINA JOE]: (Inaudible). 4 5 [MS. BERNICE TOUCHIE]: Was there an autopsy 6 or any procedure? **UNIDENTIFIED SPEAKER:** I don't think so. 7 [MS. MARCINA JOE]: I don't think there was. 8 9 [MS. JOLENE JOE]: I just -- I remember 10 them, like, after I heard that I didn't understand, like, at the same time they took her off life support without any 11 12 of us even telling them to because they said that if they didn't and if they kept her on life support that it would 13 have been more damage anyways. Like, she would have been 14 15 brain damaged already. 16 [MS. MARCINA JOE]: Yes, she was already 17 going to be able -- like, she was just -- and she was 18 already a vegetable pretty much. 19 [MS. JOLENE JOE]: So none of us had a say 20 and they just took her off life support before any of us 21 got there. 22 MR. BREEN OUELLETTE: Before anyone in the family got there? 23 24 [MS. JOLENE JOE]: Yeah. 25 [MS. JULIA IDA JOSEPH]: No, [M.T.] was

1 there. [MS. JOLENE JOE]: Oh, and [A.J.]. 2 [MS. JULIA IDA JOSPH]: Yeah, and [A.J.]. 3 [MS. JOLENE JOE]: [A.J.]. 4 5 [MS. JULIA IDA JOSEPH]: I think they had 6 this -- like ---7 [MS. BERNICE TOUCHIE]: Probably [A.J.] 8 decided then, eh? 9 [MS. JULIA IDA JOSEPH]: I think [M.T.] did. 10 UNIDENTIFIED SPEAKER: Yeah, I think I just 11 ___ 12 [MS. JULIA IDA JOSEPH]: That's why she's really just having a rough time ---13 MR. BREEN OUELLETTE: Who's ---14 15 UNIDENTIFIED SPEAKER: [MS. JULIA IDA JOSEPH] -- still. 16 17 MR. BREEN OUELLETTE: Who's [M.T.]? 18 [MS. JULIA IDA JOSEPH]: [M.T.] is our 19 younger sister. 20 MR. BREEN OUELLETTE: Okay. She was the only person who made it to the hospital ---21 [MS. JULIA IDA JOSEPH]: Yeah. 22 MR. BREEN OUELLETTE: --- right before? 23 24 [MS. JULIA IDA JOSEPH]: She lives in 25 Duncan.

1	[MS. C.K.]: She lives on Vancouver Island.
2	MR. BREEN OUELLETTE: Okay. I'm just moving
3	back and forth trying to fill in the pieces where they fit.
4	I'll just take one moment.
5	Is [M.T.] able to speak to the National
6	Inquiry?
7	[MS. JOLENE JOE]: Yes.
8	[MS. JULIA IDA JOSEPH]: Yeah.
9	[MS. JULIA IDA JOSEPH] : M'hm.
10	[MS. JULIA IDA JOSEPH]: I'm sure she would.
11	She's just busy working. She couldn't make it.
12	MR. BREEN OUELLETTE: M'hm. Is she still
13	living in Duncan?
14	[MS. JULIA IDA JOSEPH]: Yes.
15	MR. BREEN OUELLETTE: My card has my phone
16	number on it. You all of you are free to share my phone
17	number with anyone who needs to speak to me. I would like
18	to speak to [M.T.] but as I've said before, the National
19	Inquiry won't compel family members to talk. So I would
20	ask if you could ask her if she feels comfortable to talk
21	to me, then she could call me any time, leave me a message,
22	and you know, because I'm in a lot of these types of
23	situations; I sometimes can't get back to people for
24	several days. But I get back to everybody that leaves me a
25	message and I will call her back and we will find a way for

her to be able to share her experience if that's what she 1 2 wants. [MS. JOLENE JOE]: Yeah, because she was the 3 first one there without any of us. 4 5 MR. BREEN OUELLETTE: Okay. So [M.T.] was 6 there and [A.J.] was there as well. 7 [MS. JOLENE JOE]: [A.J.]. [A.J.]. 8 MR. BREEN OUELLETTE: Yeah. Yeah. 9 [MS. JOLENE JOE]: I was so angry when I 10 seen him there. MR. BREEN OUELLETTE: So at 2:00 a.m. --11 2:00 a.m., I think it was said was her passing? And if I 12 understand that correctly it was because the hospital 13 decided to take her off life support? 14 [MS. JOLENE JOE]: Or Auntie did. I'm not 15 16 sure. And Auntie [M.T.] is [M.T.]. 17 MR. BREEN OUELLETTE: [M.T.]. Well, we 18 don't know -- I quess we don't know who decided but the 19 hospital took her off life support at 2:00? 20 [MS. JOLENE JOE]: M'hm. MR. BREEN OUELLETTE: Around 2:00 a.m.? And 21 nobody present is -- for sure has the knowledge of who 22 decided to take her off life support? Okay. 23 24 [MS. JULIA IDA JOSEPH]: I think [M.T.] 25 knows.

1 MR. BREEN OUELLETTE: Okay. Was anybody 2 present in this room asked about taking her off life 3 support? [MS. BETTY KNIGHTON]: No. 4 5 [MS. JULIA IDA JOSEPH]: No. 6 MR. BREEN OUELLETTE: No? Okay. And so 7 after she was taken off life support, where were family 8 meeting to grieve? 9 [MS. JULIA IDA JOSEPH]: [M.T.]'s. 10 [MS. JOLENE JOE]: Auntie [M.T.]'s house. [MS. MARCINA JOE]: Yeah, Auntie [M.T.]'s. 11 12 [MS. JOLENE JOE]: Because I got there at, like, 9:00 in the morning from -- coming from Vancouver. 13 MR. BREEN OUELLETTE: For the record, a 14 15 device fell on the floor accidentally. We'll just take a moment to calm down from that startling moment. Just let 16 17 everybody take a moment and when you're feeling ready just 18 let me know. 19 (SHORT PAUSE) 20 [MS. BETTY KNIGHTON]: Okay. MR. BREEN OUELLETTE: Are you okay? 21 22 [MS. JOLENE JOE]: Yeah. MR. BREEN OUELLETTE: Okay. While the 23 24 family was together and grieving, was there anybody from the police that came to talk to the family? 25

17	went to look for him.

19	homeless?
20	[MS. JULIA IDA JOSEPH]: Yeah.

7	MR. BREEN OUELLETTE: See [A.J.]?
8	[MS. JOLENE JOE]: [A.J.]? No, he'd been
9	gone for
10	[MS. BERNICE TOUCHIE]: On her visit I saw
11	him, but he was in the room when we all went to see her in
12	the hospital.
13	[MS. BERNICE TOUCHIE]: She passed.
14	[MS. JULIA IDA JOSEPH]: He was in a
15	[MS. JOLENE JOE]: He was there before all
16	of us with Auntie [M.T.].
17	MR. BREEN OUELLETTE: So
18	[MS. JOLENE JOE]: But then after that we
19	didn't see him.
20	MR. BREEN OUELLETTE: So he went to the
21	hospital to see her?
22	[MS. BERNICE TOUCHIE]: Yeah.
23	MR. BREEN OUELLETTE: That was which day?
24	[MS. JOLENE JOE]: The 25 th .
25	[MS. BERNICE TOUCHIE]: The day after her

passing, yeah. 1 MR. BREEN OUELLETTE: It was on the 25th? Or 2 the 26^{th} ? 3 [MS. JOLENE JOE]: I think she -- like, it 4 5 was in the morning. [MS. JULIA IDA JOSEPH]: It must have been 6 the 26th. 7 8 MR. BREEN OUELLETTE: Okay. 9 [MS. JULIA IDA JOSEPH]: Because we had to 10 wait for the ferry from the bay too. [MS. JOLENE JOE]: Oh, yeah. 11 12 [MS. JULIA IDA JOSEPH]: First ferry. 13 MR. BREEN OUELLETTE: So people were showing up to the hospital first and so who saw -- who here saw him 14 15 at the hospital? [MS. JOLENE JOE]: I did. 16 17 [MS. BERNICE TOUCHIE]: I saw him. 18 [MS. JULIA IDA JOSEPH]: Yeah. 19 MR. BREEN OUELLETTE: Okay. And at that 20 time, was it known that he had done this to her? [MS. JOLENE JOE]: No, not yet. 21 22 MR. BREEN OUELLETTE: Nobody was aware? [MS. JOLENE JOE]: Because I just kept 23 24 saying, "What happened? What happened to my mom?" And he wouldn't say anything. 25

1 MR. BREEN OUELLETTE: He was quiet? [MS. JOLENE JOE]: But I can tell she put up 2 a fight because she still had dry blood under her 3 fingernails. 4 5 [MS. BERNICE TOUCHIE]: When I saw her I 6 went through the severe grief because I practically raised all my younger brothers and sisters, including Anne and 7 8 Julie right through high school. We -- my sister Vi and I 9 helped them get through school at Nitnaht Lake and Anne and Julie in Campbell River. 10 11 And seeing her gone like that, it was very 12 painful because she helped me with K to 12, K to 6 curriculum and she was a fine stenographer. And why she 13 never had an opportunity to work, I don't know. 14 But she 15 did a fine job for me. To see her like that was such a waste to this. 16 17 And I warned her. I could see. I remember 18 bruises on my face too and when they're old I can tell. 19 She had old bruises on her forehead and I wanted to get angry at that man because I thought he never did look after 20 her best interests to her. And that car accident and she 21 22 was in so much pain from broken ---23 [MS. JOLENE JOE]: Leq. 24 [MS. BERNICE TOUCHIE]: --- legs ---25 [MS. JOLENE JOE]: Legs [wrists], she ---

[MS. BERNICE TOUCHIE]: --- already from, I 1 don't know, car accidents, maybe from former beatings. I 2 3 don't know. But to see her have to be hurt again was very painful. 4 5 And I thought it wasn't my place to get angry at that man there, but I know I was very angry at 6 him. And then I saw my nephew who's passed away now, Reg, 7 8 said that we just heard a video showing that he was kicking 9 her in the head. 10 And somehow the nurses -- I have the impression the nurses told him he'd better leave because 11 12 somebody might hurt him or whatever because Reg was so 13 angry and wanted revenge. [MS. JOLENE JOE]: And I know something more 14 15 happened because a week before, my brother just had his baby in Victoria and I was passing through Duncan. 16 That 17 was the last time I seen her. And I was asking her, "Mom, 18 do you want to come with me?" And I had my van. And I 19 said, "Do you want to come with me? And [L.J.] had his baby. Let's go see her." 20 And she didn't want to come with me because 21 she said her back was sore. 22 So a week before it happened, I know more 23 24 happened, but I just don't know what. Because I would have 25 brought her with me and -- because I told my mom lots of

times -- well, she broke both of her wrists separate times 1 in the past five years before she passed. So she couldn't 2 3 open cans and stuff like that now and I told her, I was like, "Mom, you can come to my house and I'll look after 4 5 vou." 6 And she didn't want to but she just still 7 wanted to, you know, do stuff for herself. But I told her 8 that. I was like, "I would look after you. I'll do everything for you. I'll cook, I'll clean, and do 9 everything." But she didn't want to come with me to 10 Nitnaht. 11 12 But that day I tried to bring her to Victoria to go see her granddaughter. It's her -- my 13 brother's baby was just born and she didn't want to because 14 15 she said her back was sore. 16 [MS. JULIA IDA JOSEPH]: Didn't he just did 17 a residential school settlement? 18 [MS. JOLENE JOE]: Yeah. 19 [MS. MARCINA JOE]: I think he was expecting 20 more. [MS. JULIA IDA JOSEPH]: Yeah, so he had a 21 new truck but it was always flagged that they were stopping 22 it because ---23 [MS. JOLENE JOE]: Drinking and driving. 24 25 [MS. JULIA IDA JOSEPH]: --- drinking and

driving. 1 MR. BREEN OUELLETTE: Your brother's name? 2 3 [MS. JOLENE JOE]: [L.]. [L.J.]. MR. BREEN OUELLETTE: [Spells name]? 4 5 [MS. JOLENE JOE]: Yeah. 6 [MS. JOLENE JOE]: [L.J.]. 7 [MS. 12	funeral happened. Where was the funeral held?

I don't know her She's a Manitoban. 14 last name. 15 [MS. JULIA IDA JOSEPH]: We have a new one now but it's Connie. 16 17 [MS. MAUREEN DONNA KNIGHTON]: Who? 18 [MS. JULIA IDA JOSEPH]: Villeneuve. 19 MR. BREEN OUELLETTE: Connie Villeneuve? 20 [MS. MAUREEN DONNA KNIGHTON]: But she's not 21 there anymore. [MS. JOLENE JOE]: No. 22 MR. BREEN OUELLETTE: And so which 23 24 detachment? Was this RCMP or local? 25 [MS. JOLENE JOE]: Yeah, she was from the

Cowichan. She's not working there no more though. But she 1 even told me that no, he wasn't kicking her. That's what 2 she said. So that was the second time I tried and after 3 that I didn't try again. 4 5 [MS. MARCINA JOE]: It was like they just 6 didn't want to deal with it. 7 [MS. JOLENE JOE]: M'hm. [MS. BERNICE TOUCHIE]: I was just assuming 8 9 something was being investigated and then I heard about his 10 debts. It was not on the news, to me. [MS. BERNICE TOUCHIE]: Whose, your mom's? 11 12 [MS. Is there any other information that anybody remembers at this point 8 about how this unfolded, who was spoken to, if there's 9 anything else that we haven't talked about that is 10 important to how this happened? 11 [MS. BETTY KNIGHTON]: What I heard was -- I 12 was up living in Renfrew at the time, and what I heard was 13 that [A.J.] claimed that she fell. That's how she got her 14 15 injuries. 16 MR. But that's what the person said anyway, that he said and that was his 20 explanation of her injuries, eh, that she fell. 21 MR. BREEN OUELLETTE: If any more details 22 come back on that just let me know, okay? 23 So what was Shirley's life like? 24 25 [MS. MARCINA JOE]: She was just like a real

homebody. She didn't really go out unless she went to 1 Bingo, I guess. 2 3 MS. JOLENE JOE: She was always happy and when she was there for us, she was always there for us. 4 5 The only thing that would take her away and make her not was just the alcohol abuse. 6 MR. BREEN OUELLETTE: M'hm. 7 MS. JOLENE JOE: Other than that, she was a 8 9 really good mom. 10 MR. BREEN OUELLETTE: M'hm. And I mean, Shirley's sisters probably have a better idea of this. How 11 12 did Shirley come to abuse alcohol? Did this stem from residential schools; was it -- you know, it comes down to a 13 question of how was Shirley vulnerable? 14 15 MS. JOLENE JOE: I think it had to do with a lot of her pain because she did, she broke like, both of 16 17 her ankles in her lifetime, both of her wrists, and she 18 got, like, traumatized from our father. She went through a 19 lot of stuff with our dad. MR. BREEN OUELLETTE: So she faced domestic 20 abuse? 21 22 [MS. JOLENE JOE]: Yes. [MS. MARCINA JOE]: Yeah, he just abused her 23 24 too. 25 MS. JOLENE JOE: Almost killed her in front

of us. 1 [MS. BERNICE TOUCHIE]: Oh, you mean [R.J.]? 2 3 [MS. JOLENE JOE]: Yeah. [MS. BERNICE TOUCHIE:] Their father -- well, 4 5 his first -- her first husband. 6 MR. BREEN OUELLETTE: M'hm. 7 MS. JOLENE JOE: [R.J.] abused physical 8 abuse and ---9 MR. BREEN OUELLETTE: [R.J.]? Sorry, I 10 missed that. MS. JOLENE JOE: [R.J.], [spells name]. 11 12 MR. BREEN OUELLETTE: [R.J.]? MS. BREEN OUELLETTE: --- is when she broke 25 her wrists and her ---

He pushed her. And then I 6 think the other ones are like, from falling. 7 [MS. MARCINA JOE]: Yeah, she slipped on 8 ice. MS. JOLENE JOE: Yeah. 9 10 MR. BREEN OUELLETTE: Somebody mentioned a car accident at one point. Do we know the details on that? 11 12 [MS. MARCINA JOE]: She was through a few, 13 eh? [MS. BERNICE TOUCHIE]: M'hm, with [A.J.]. 14 15 MS. JOLENE JOE: Yeah, there's one with [A.J.] in Port Renfrew. I remember she told me there's 16 17 like, a long bridge and when they got to the bridge he was 18 going too fast and it's a turn. They went straight off, 19 straight off the bank. It's like a -- not too big of a 20 bank, but it's a bank so they just went straight down like 21 that. 22 MR. BREEN OUELLETTE: And she was a passenger at the time? 23 24 **UNIDENTIFIED SPEAKER:** M'hm. 25 [MS. JOLENE JOE]: Was she driving?

20	doctor trying to get records too, now that I think of it.
21	MR. BREEN OUELLETTE: Okay. So let's talk
22	about that as well. Do you know the doctor's name?
23	MS. JOLENE JOE: I can't even remember his
24	name.
25	[MS. MARCINA JOE]: Did it start with a B?

MS. JOLENE JOE: I can't remember his name. 1 Because I remember I tried to go there to see him, like, to 2 be a doctor for me. 3 MR. BREEN OUELLETTE: 4 M'hm. 5 MS. JOLENE JOE: But I couldn't for some 6 reason. But I can't remember his name. 7 MR. BREEN OUELLETTE: Do you remember where 8 his clinic was? MS. JOLENE JOE: I can't remember the 9 street. I know where it is in Duncan but I don't know -- I 10 can get it though and ---11 12 MR. BREEN OUELLETTE: Okay, yeah. 13 MS. JOLENE JOE: --- I'll phone you and ---MR. BREEN OUELLETTE: Yeah, if you can get 14 15 the name of the clinic or the name of the doctor that would 16 be helpful. 17 MS. JOLENE JOE: Yeah, because I remember --I can't remember what he said when I tried to ask -- or 18 19 even what I was trying to ask. 20 [MS. MARCINA JOE]: Was it [F.]? MS. JOLENE JOE: Yeah. Yeah, I think it's 21 Dr. [F.]. That sounds right. Dr. [F.]. Dr. [F.]. 22 23 MR. BREEN OUELLETTE: Okay. 24 MS. JOLENE JOE: But yeah, he has where he 25 has the records.

1	MR. BREEN OUELLETTE: He has her medical
2	records?
3	MS. JOLENE JOE: Yeah.
4	MR. BREEN OUELLETTE: Okay. And he wouldn't
5	talk about the circumstances of her death?
6	MS. JOLENE JOE: No. No. Saying I think
7	he's saying that I had to go to the cops or go to the
8	police station to find out about that.
9	MR. BREEN OUELLETTE: Okay.
10	MS. JOLENE JOE: So that day I was like,
11	getting the runaround because I went to the casino, her
12	doctor, the cop shop, and I couldn't get anything.
13	MR. BREEN OUELLETTE: This was the one at
14	26?
15	MS. JOLENE JOE: End of no, the end of
16	August.
17	MR. BREEN OUELLETTE: No? End of August?
18	MS. JOLENE JOE: Yeah.
19	MR. BREEN OUELLETTE: Okay. So you tried
20	the doctor, the casino?
21	MS. JOLENE JOE: For the footage.
22	MR. BREEN OUELLETTE: Yeah, the police. Do
23	you remember anywhere else that you tried to get
24	information?
25	MS. JOLENE JOE: Those were the only three.

1	MR. BREEN OUELLETTE: Okay.
2	[MS. BERNICE TOUCHIE]: The nurses at the
3	hospital but they couldn't say anything very much either.
4	MS. JOLENE JOE: No.
5	MR. BREEN OUELLETTE: M'hm. And so
6	ultimately, at the end of it you weren't able to get any
7	documents about what happened?
8	MS. JOLENE JOE: No.
9	MR. BREEN OUELLETTE: And nobody else was
10	able to get any documents about what happened? Okay. And
11	the only police officer that we have was Constable
12	Villeneuve and we don't know the names of any of the nurses
13	or doctors from the hospital?
14	[MS. JOLENE JOE]: No.
15	MR. BREEN OUELLETTE: Okay. While Shirley
16	was in Duncan, how did she get by?
17	[MS. JULIA IDA JOSEPH]: Was she on welfare,
18	disability?
19	[MS. BERNICE TOUCHIE]: Disability.
20	[MS. JULIA IDA JOSEPH]: Disability.
21	MR. BREEN OUELLETTE: Disability? And how
22	has this whole situation affected the two of you, the
23	daughters of Shirley?
24	MS. JOLENE JOE: Well, it's been a daily
25	struggle for me. Like, I try my best to stay strong for my

four kids. And I know they see it in me. But I try to let 1 things out in a good way, like, a strong way for my kids so 2 that -- I quess so that they don't see how much I'm 3 hurting, because like, every day she shows me signs. 4 5 She really shows me a lot of stuff, like, to keep my strength for my kids up, I believe. Or if my kids 6 see her chart [truck], they'll be like, "Grandma." 7 And I'll be like, "Oh, Grandma's saying hi." 8 You know, just little things like that. Or just in the 9 clouds she'll show me stuff or if my kids see a heart shape 10 in food or anything like that they'll be like, "Oh, it's 11 Grandma." 12 13 So I'm just trying to keep them strong about it. 14 15 MR. BREEN OUELLETTE: M'hm. So what kind of struggles have you had to deal with in your life? 16 17 MS. JOLENE JOE: Well, right now I'm 18 recovering from crack cocaine. But I don't really want to 19 blame it on losing my mom, because like, naturally, you know, I'm hurting. But I just -- I don't want my kids to 20 know, you know, that when they're in pain like that to run 21 22 to, you know, to toxins or -- no, that's not what I want to teach them. 23 24 So they see me and know that I'm reaching

out for help and I'm waiting for treatment right now. And

1 my cousin Maureen (inaudible), she's helping me so I'm
2 going to be going to Round Lake in the Shuswap territory.
3 My dad's from -- my mom and dad actually went to that
4 treatment centre.

5 But yeah, I've lived in Port Alberni now --6 this December would be two years and I've been dealing with 7 that addiction for the last year. And I'm glad I'm strong 8 enough to reach out for help because that's not the path 9 that I want. I didn't have kids to put them through that.

MR. BREEN OUELLETTE: And has the support,
has the ability to get treatment been sufficient or have
there been problems, deficiencies? Has it been too slow?

MS. JOLENE JOE: Yeah, there was problems with one of the counsellors before I started working with my cousin. That was May that my papers should have been all processed but that counsellor missed two pages of my application. So when I went to Maureen she got my two pages in and so my full application's now there now and I'm just waiting for a date.

20 So I was really upset because what if I died 21 in this time waiting?

[MS. JULIA IDA JOSEPH]: There's other 1 2 children too. 3 MR. BREEN OUELLETTE: M'hm. So you're still waiting for your time to go for treatment. You haven't 4 5 been told vet? 6 MS. JOLENE JOE: No. I'm going to -- I want 7 to look into any or anything, a women's group or anything because I need something because it almost seems like it's 8 9 -- like they don't even care. It was two times now I've left my kids with their dad and just been gone. And that's 10 not me. That's not what I want. 11 12 But it seems like it's almost making me be that person because I'm not getting the help while I'm 13 14 trying to reach out. And I just wish, you know, when 15 someone's reaching out that you know, they'll help because that person's reaching out. Because there's people that, 16 17 you know, go for help and don't even want it. 18 MR. BREEN OUELLETTE: Are there any other 19 struggles that you're dealing with? MS. JOLENE JOE: Probably just like, it's --20 I guess it's little but it's big at the same time is 21 between me and my kids' dad. This year we've been together 22 21 years and there's a lot of domestic disputes or is that 23 24 what you call it? Domestic disturbances or I don't know. 25 But we've been -- I've been through a lot.

I've been to Hell and back with him and his family and I 1 don't know. I'm -- try to the best I can for my kids 2 because I didn't have a mom and a dad, eh? 3 [MS. JULIA IDA JOSEPH]: You had to move too 4 5 and you lost your job. 6 MS. JOLENE JOE: Yeah, I left Nitinaht when 7 I moved here two years ago and the reason being, I had nine calls to USMA and if I had one more call I would have got 8 9 my kids taken away. 10 But when that happened, I was just celebrating the end of the year before Christmas holidays 11 with my staff. And their dad decided to drink too and he 12 13 was drinking at home and he decided to drive my truck and he crashed it. 14 15 And so after that I said I had enough and we broke up for a while. Me and my kids were in the 16 17 transition house here. And so we just -- we've came a long 18 way and I just feel like I'm with him for my kids and not 19 myself. I'm doing my best. I think that the 20 treatment will help knowing then, you know, I want to be 21 with him for me and not just my kids, because being with 22 him just for my kids isn't making me feel very good, you 23 24 know? I want to be with him as for a family, not just the fact that I want my kids to be happy, knowing growing up 25

after nine I didn't have a mom and dad. 1 And my oldest is 15 now. And you know, I am 2 like a psychological thinker. Like, you know, with me 3 staying and not with him for me, I'm feeling that naturally 4 5 I'm teaching my kids later on, you know, if they're going 6 to be in relationships like that, that they're going to stay. And I don't want that. 7 8 So I'm going to do my best to work on myself and fix it because there's no way, like, the pain that I 9 feel losing my mom, I don't want my kids to carry. 10 Ιt really hurt to lose my mom. And I couldn't imagine my kids 11 without me. 12 Like, when I lived in Nitinaht, I abused 13 alcohol. Every weekend I drank. Yeah, I had a good-paying 14 15 job and I was a teacher assistant in Nitinaht for 11 years. And when this happened and I had to move away I lost my 16 17 job. So that's another big thing on me probably, you know. I'm used to working for my kids, not being on welfare. And 18 I think that's how I got lazy and you know ---19 UNIDENTIFIED SPEAKER: You're not ---20 MS. JOLENE JOE: --- not really caring 21 because oh, welfare, I'm going to get welfare, you know. 22 Just -- so I just -- I want my life back. I want to go 23 24 back to school and get my teacher aide. 25 Can I just read what I wrote?

MR. BREEN OUELLETTE: 1 Yeah. MS. JOLENE JOE: My dear Mother, I miss you. 2 Thankful for this beautiful life you gave me. You just 3 didn't teach me how hard it would be without you. 4 I know, 5 because you told me lots of times that you were in pain here on earth, a lot to do with alcohol abuse. 6 I'm sorry it happened that way, Mom. I'm so 7 devastated the way we lost you. It hurts so bad I think it 8 just like (inaudible) how much [I didn't get to say goodbye 9 10 and one last] I love you. I don't understand how the story changed. 11 In my heart it didn't just happen. You were murdered. 12 The 13 police said it was on video recording in Duncan. You were getting kicked in the face. Then it changed and you 14 15 weren't getting kicked in the face. How does that change? I'm lost about it. And it hurts to go to 16 17 Duncan police and find out more. You just being gone is so hard to believe. 18 19 I'm so glad you raised me the way you did. My children don't deserve alcohol abuse and I learned that 20 the hardest way by growing up with it. I refuse to abuse 21 alcohol for myself and children's well-being. 22 So I moved to Port Alberni and got into that 23 24 addiction and I've been working with USMA because they said if I got another report my kids would get taken away. And 25

somebody did report me that I was gone but their father was 1 with them. And they know that I'm reaching out for help 2 and I'm in the middle waiting for treatment. 3 And right now, like, it seems that stuff in 4 5 life is just naturally helping me without me trying. Like, 6 a couple of weeks ago Auntie Bernice asked me to go to McCuddy's with her in Neah Bay (phonetic). So I went and 7 8 she got me out of town. And that's like, right when I was in my -- you know, like, almost ready to just give up, 9 like, just who cares about everything? I'm just going to 10 leave my family and who cares now, right? 11 But deep down I'm like, I don't want to be a 12 couch surfer. I don't want to, you know -- I'll like, go 13 way downhill if I lost my kids because they keep me busy, 14 15 right? Four kids is a lot of work. But I'm thankful that Auntie brought me to 16 17 that because that helped me stay clean. And then now, 18 yesterday -- not last night, the night before, before this started, I was thinking about it. Oh, when the kids are at 19 school I'm going to go and do drugs, right? That's what I 20 thought. 21 22 And then this came up and Maureen was telling me for the last couple of weeks that, you know, 23 "You're signed up, you just need a statement." 24 25 And I didn't realize it that all of a sudden

it's here. And I'm like, okay, cool. So now yesterday I 1 got brushed off and when I was at home last night I felt 2 really good. I felt strong. It wasn't -- I wasn't even 3 thinking of it. 4 5 And I was like, okay, this is for real now. 6 Thank God, because I don't want my family to lose me because that's how we lost my cousin Req, my auntie's son. 7 8 Because I quit April 6th and we lost my cousin April 8th. I guit for a month and a half so like, 9 the end of May. So see, when I was trying to get into 10 treatment and stuff I fell off again. But you know, I 11 don't want to lose my life to that. And I want to find 12 justice about my mom. 13 MS. MELODY CASELLA: Can I say something? 14 15 MR. BREEN OUELLETTE: Melody just wants to 16 say something. 17 MS. MELODY CASELLA: I just wanted to say, 18 like, in listening to what you're sharing I think that -- I 19 was a detox program director in my community and the problem that we found with referrals is that we're so 20 limited through the funding for referrals. And then for 21 recommendations, like, through this Inquiry, you know, for 22 our First Nations communities that a lot of us want to go 23 through the grass-roots healing, like, because I know 24 around my treatment centre and how they're culturally 25

raised saying that culture is achievement [treatment]. So
 then a lot of our people want to go that route for their
 healing journeys.

And then so through this Inquiry that the 4 5 recommendations that you have the power to make right now 6 is that through the wait list, through the referral process -- because we're so limited and referring people to 7 treatment centres that are First Nations based, you know, 8 for healing that if, you know, that you feel that through 9 this process that it's prolonged, the healing that you want 10 to start, because I know the first reaching out of your 11 hand is the biggest step in life, to say "I need help." 12 13 And then when you feel like it's not going as quick as it should, which it should, because you know, 14 15 time is always crucial, you know ---

MS. JOLENE JOE: Yeah.

MS. MELODY CASELLA: --- and this is lifethreatening.

MS. JOLENE JOE: Oh, yeah.

MS. MELODY CASELLA: And seeing our

21 struggles of our people all over the province and then that 22 if you feel that that list should be more accessibility, 23 you know, for more treatment centres that are First Nations 24 based, that you can make those recommendations because you 25 know, with the power of your relative to help you and then

1 to make sure the accuracy of paperwork and that there's no
2 excuse for that.

MS. JOLENE JOE: M'hm.

MS. MELODY CASELLA: And that's, you know,
this ongoing systemic issue for our people. And whatever
recommendations you have today will be taken seriously when
the Commissioners see our video and what you recommend
today. And that if you feel there should be more treatment
centres you can recommend those things.

10 So you're not waiting so long, so that when changes hopefully will come up a lot quicker than you like 11 for -- from this process with our people that are here for 12 what you're saying, and that I, you know, encourage you to 13 make those recommendations on what you see because it's 14 15 been happening for a long time for our people. It's -because I was doing this like, 10 years ago as a program 16 17 director.

We put our recommendations forward to our chief and council; "They need more treatment centres but we need detoxes. We need halfway houses but aftercare." So you know, whatever process of -- for your own community in your own area that you would think need to happen that you can recommend those things and ---

24 MS. JOLENE JOE: Yeah, like, see, my sister,
25 she went to one in Alert Bay and that's all women, and

they've told me about Tsow-Tun Le Lum in Nanaimo and it's -1 - the reason why I want to go is because I want to get far 2 away from here. I don't want to even think about here. I 3 just -- I really want to go there. I don't know how long 4 5 it's going to take or if I could phone and check-up or I 6 don't know. But if not, I need to figure out something 7 8 now because I don't think I can wait very much longer. That was like, one of the workers introduced 9 I think her name's Gail -- another 10 me -- was it Gail? worker that does different groups that she introduced me 11 to. And she gave me her Facebook information and stuff. 12 So I was like, anything, like, you know, and just women 13 healing there, you know? Anything like that. I was like, 14 I just need something. 15 Like, I was working with INEO, the 16 17 employment centre and just you know, little things to just 18 try to keep my mind busy because I'm starting to forget 19 about, you know, anything, everything. My kids are my number one and I just -- I 20 want it like that. I -- there's no way that, you know, I 21 22 want to hurt myself or ---MR. BREEN OUELLETTE: So I have some 23 24 questions, Jolene. The paperwork that was misfiled, who did that paperwork? 25

1	MS. JOLENE JOE: His name is [Counsellor 1].
2	MR. BREEN OUELLETTE: [Counsellor 1]?
3	MS. JOLENE JOE: [Counsellor 1], [spells
4	name].
5	[MS. MARCINA JOE]: It's just [spells name].
6	MS. JOLENE JOE: Huh?
7	[MS. MARCINA JOE]: It's just [spells name].
8	MS. JOLENE JOE: Yeah.
9	MR. BREEN OUELLETTE: [Spells name]? No,
10	okay.
11	[MS. JULIA IDA JOSEPH]: I think you said
12	[name].
13	MS. JOLENE JOE: Oh, I thought there was an
14	[letter].
15	MR. BREEN OUELLETTE: So what are his
16	qualifications? Where does he work? How did you come to
17	be connected to him?
18	MS. JOLENE JOE: He well, I knew him
19	because we did, like, couple counselling a little bit and
20	stuff with him in [Community 1] because he travels to
21	[Community 1] too and works for our band.
22	MR. BREEN OUELLETTE: Okay.
23	MS. JOLENE JOE: But he's out of the
24	[MS. JULIA IDA JOSEPH]: He works out at
25	NTC.

MS. JOLENE JOE: Oh yeah, NTC. But he's out 1 of the [office] here in Port Alberni. But yeah, Maureen, 2 when I told her, when I first filed with her to figure out 3 that I had two pages missing she wasn't impressed. She was 4 5 like, "I'm not impressed." MR. BREEN OUELLETTE: 6 M'hm. MS. JOLENE JOE: Because I know if I went 7 through my cousin I would have been to treatment and back. 8 9 I know it. Just because we lost a family relative already, right, and I was really sad because I was like, that could 10 have been me. That really could have been me. And that 11 12 would have been devastating because I'm already reaching 13 out for help. MR. BREEN OUELLETTE: Do you know why the 14 15 mistake occurred? MS. JOLENE JOE: I don't know. He seems 16 dozy. 17 18 MR. BREEN OUELLETTE: Is he still working 19 for NTC? MS. JOLENE JOE: Yeah, he's over there. And 20 I could tell. I could feel the difference in him, walking 21 22 around and trying to get my eye contact. But I won't even look at him because he knows. He knows that he messed up 23 24 because I was waiting and waiting and waiting and nothing 25 from him.

And finally I said, "I can't do this 1 anymore," so I went to my cousin. And I was like, "I wish 2 3 I just went to you right away." I don't know why I went against my gut, just knowing, you know, you can't usually 4 5 work with immediate family dealing with stuff like that, 6 right? MR. BREEN OUELLETTE: M'hm. 7 MS. JOLENE JOE: So I didn't want to go to 8 That's why I went to him. But I shouldn't have even 9 her. 10 went against my gut and I should have just went to my cousin because I would have been to treatment and back and 11 I would have been, you know, on my journey already. But 12 no, here I am struggling. 13 MR. BREEN OUELLETTE: 14 What are his 15 qualifications or his job title? MS. JOLENE JOE: I think he's a Clinical 16 17 Counsellor. 18 [MS. JULIA IDA JOSEPH]: I think he's a 19 Clinical Counsellor. Or is it drug and alcohol? MS. JOLENE JOE: Yeah, actually I think so, 20 drug and alcohol. 21 22 [MS. JOLENE JOE]: Yeah. 23 MR. BREEN OUELLETTE: Counsellor? 24 [MS. JULIA IDA JOSEPH]: Yeah. 25 MS. JOLENE JOE: But no, like, I could sue

What if I died in that time before I went to my 1 him. cousin? What if something happened to me? Then what would 2 3 have happened because I wouldn't have been here to say, you know, that he didn't do his job properly. 4 5 MR. BREEN OUELLETTE: M'hm. 6 [MS. MARCINA JOE]: He, I think, was my 7 counsellor and I started seeing someone else. 8 MS. JOLENE JOE: M'hm. 9 [MS. MARCINA JOE]: I'm seeing (inaudible). MS. JOLENE JOE: It's like he's just there 10 for the money. 11 12 MR. BREEN OUELLETTE: M'hm. MS. JOLENE JOE: He's not -- he doesn't 13 care, it felt like, why my pages were -- two pages missing 14 15 for two months because I've been waiting three months that I thought of it last night. I was like, three months. 16 17 May, June, July, August. It was May, June, July, August. 18 Yeah, three months. [MS. JULIA IDA JOSEPH]: 19 We have been 20 waiting, asking for a different counsellor to come to Nitinaht because if we don't want to -- we're not 21 22 comfortable with him either. And that -- well, we want a female too down there. 23 24 MR. BREEN OUELLETTE: Yeah. 25 [MS. JULIA IDA JOSEPH]: Because there's

lots of dysfunction and lots of help. They want help but 1 they end up falling through because they don't get it. 2 3 MS. JOLENE JOE: Because you know how you're supposed to go to them for advice? Well, when you talk 4 5 about your problem he just seems like he answers with your 6 problem, whatever you're talking about. He doesn't give you advice on what you're going through or -- like, it's 7 not -- doesn't seem like it's helping because I've tried. 8 Me and my kids' dad have tried. And now this happened with 9 10 my application so ---[MS. MARCINA JOE]: Yeah, when I seen him 11 the whole time all he said was "M'hm." 12 13 MS. JOLENE JOE: Yeah. 14 [MS. MARCINA JOE]: Oh, m'hm. That was it. 15 MS. JOLENE JOE: Yeah. [MS. MARCINA JOE]: Like, I didn't get 16 anything out of that. 17 18 MS. JOLENE JOE: No. And I know my cousin's stern on her -- she's stern at work. I know she is. Like, 19 I can just feel the -- you know, the power and the love and 20 the wisdom and the -- you know? All the stuff that she has 21 22 ___ MR. BREEN OUELLETTE: M'hm. 23 MS. JOLENE JOE: --- that all of them should 24 have if they work in that field, you know? It's how they 25

1 all should be.

MR. BREEN OUELLETTE: M'hm. 2 Is there 3 anything else you want to say about that? MS. JOLENE JOE: I'm okay. 4 5 MR. BREEN OUELLETTE: Okay. Marcina, do you 6 want to add anything to that? 7 MS. MARCINA JOE: Just that this pain is, like, never going to be healed. It's always going to be 8 9 there. 10 MR. BREEN OUELLETTE: M'hm. And how has it affected you in your life? 11 MS. MARCINA JOE: Just like something's 12 missing every day. I was already an alcoholic before it 13 happened so I'm not really going to go there because I 14 15 watched my mom drink growing up so I just do that now too. I don't find that I -- like, when I went to treatment I 16 talked about my mom's loss, losing my mom and felt like I 17 18 got a lot of work done there. MR. BREEN OUELLETTE: 19 M'hm. 20 MS. MARCINA JOE: Just a big gap in my -that's how it feels. 21 MR. BREEN OUELLETTE: 22 Oh. MS. MARCINA JOE: Like, I'm usually really 23 24 strong about it and just on her death day though is when it really hits me. Like, I had a rough time last month 25

because I knew it was when we lost her. And actually I 1 just do cultural stuff or draw or write or paint. 2 3 MR. BREEN OUELLETTE: M'hm. MS. MARCINA JOE: And other that 4 (inaudible). But yeah, that's about it, I think. 5 I just 6 hope things do improve so that people don't have to go 7 through what we went through. MR. BREEN OUELLETTE: M'hm. Do either of 8 9 you have children? 10 MS. MARCINA JOE: Yeah, three. MR. BREEN OUELLETTE: And are they affected 11 12 in the same way? MS. MARCINA JOE: Well, two of them were 13 born after she was -- after her death. 14 15 MR. BREEN OUELLETTE: M'hm. 16 MS. MARCINA JOE: I don't know, [J.], I 17 don't know how she feels. They weren't really close. My 18 mom was off and doing her own thing and with her boyfriends 19 or whatever. MR. BREEN OUELLETTE: 20 M'hm. UNIDENTIFIED SPEAKER: You should ask her. 21 MS. MARCINA JOE: I don't think it really 22 affected my kids just because of that. Two of them were 23 born after, so ---24 25 MR. BREEN OUELLETTE: M'hm. Okay, is there

anything else you'd like to say? 1 MS. MARCINA JOE: No. 2 3 MR. BREEN OUELLETTE: No? Okay. I know the Commissioners can't see this from 4 5 the video but it's quite hot in this room and it's probably a little difficult. We have a little bit more to cover. 6 7 Would you like a break first or do we keep going? 8 [MS. MARCINA JOE]: I want to keep going. 9 [MS. BERNICE TOUCHIE]: I'm fine to keep 10 going. MR. BREEN OUELLETTE: Keep going? 11 12 [MS. JOLENE JOE]: Yeah. 13 MR. BREEN OUELLETTE: Okay. We've reached a point where I think we've talked about both of your family 14 15 members. Is there anything else about either of them that you would like to say for the Commissioners, anything that 16 17 I didn't ask you about that you think is connected to your 18 experience? 19 No? Okay. [MS. MAUREEN KNIGHTON]: I think for me the 20 only thing that I know that I got over was the anger that I 21 held for so many years after losing my aunt [Registrar's 22 note: the witness is referring to Florence Violet Joseph, 23 24 cf. Statement Volume 178(a)] and then finding out who he was while I was still in my addictions. I literally wanted 25

to shoot his head off. That's how angry I was because I 1 loved my aunt so much. 2 And when I heard about him he was in the 3 States. I heard he was living in the States and I said, 4 5 "Well, he better stay there." 6 And then, you know, well, I've been sober for guite a few years now and worked on myself and then I 7 found out he was at [Assisted living facility 1]. So I had 8 to push through all that negativity that I had with him to 9 face him again. And that was another struggle in itself 10 and I was like, oh my God, now you got to be a professional 11 12 here. So when I walk around I walk around with 13 this face that looks like it's happy to see you and you 14 15 know, how are you? And I'm like, why are they sending me up here? It's how I felt. 16 17 And then I start thinking at the back of my 18 mind, well, maybe I could start probing and finding out what led to this if he was comfortable with me. And if he 19 20 didn't know who I was maybe he would start talking to me. But that didn't work. 21 But I know I was trying to find my answers 22 too as to why that happened because I knew who my aunt was. 23 And you know, she was a kind, loving, caring person who had 24 two beautiful children. And I just couldn't understand why 25

someone would do that to her. 1 But today, you know, I don't go up to 2 [Assisted living facility 1] very much anymore because he 3 quit wanting to talk too, so that ended that. 4 5 But you know, like I was saying, that anger 6 hung on to me for many, many years and it was probably 1991 when I finally guit going to her gravesite and sitting 7 there with a beer at 2:00, 3:00 in the morning crying over 8 her. It's when I finally said, "I have to let you go now. 9 I have to. I'm getting married," I said. "I'm going to 10 get married." And that's when I finally just let it go. 11 But it took that long and I don't -- you 12 know, I don't think I've gone back to that gravesite since 13 then. But I know that it's caved in a few times. People 14 15 have tried to push the gravel back on it but that's what 16 happens. 17 As for Anne, I held a lot of anger over that Just, you know, I had sat on the sidelines 18 one too. 19 listening too. Like, I'd say, "What's going on? What are they doing? Are the cops involved?" All these questions I 20 was talking to my brother about. 21 22 And he goes, "We can't do anything. They're waiting." 23 "How come?" 24 25 He said, "Well, it's up to the siblings, the

children." 1 And I went, "Oh, that's -- well, I hope they 2 do something." That's all I said. 3 And then see, him too, the guy that, well, 4 5 beat her, I was very upset and angry about that too. And 6 how could he want to be associating with our family again, 7 you know, after doing something that drastic? Pissed right off. 8 And I'm just really glad that I'm able to 9 10 find other ways to release that anger because before, it was through the bottle I went. Now, even though I've done 11 their job, I -- it's safe. 12 13 I just wanted to share that, you know. MR. BREEN OUELLETTE: Thank you. And I 14 15 noticed -- so I've been referring to her as Shirley but she 16 went by the name Anne? 17 [MS. MAUREEN KNIGHTON]: Yes. 18 MR. BREEN OUELLETTE: Okay. I apologize for 19 that. 20 So Anne -- what were Anne's strengths, her resiliencies? 21 MS. JOLENE JOE: Very smart. She was a 22 bookkeeper at the time. Before she hurt her wrists and 23 24 that she Native danced. She was -- she danced. 25 [MS. JULIA IDA JOSEPH]: Didn't she work in

1 daycares too? MS. JOLENE JOE: Yeah. She worked in 2 3 daycares in Ahousaht. [MS. JULIA IDA JOSEPH]: And Port Renfrew. 4 5 [MS. JULIA IDA JOSEPH]: I thought she said 6 she didn't work in Port Renfrew. MS. JOLENE JOE: Yeah. Oh, yeah. So she 7 really worked -- liked working with kids and I think that's 8 9 where I get it from because I like working with kids. Just a kind, loving person. 10 [MS. MAUREEN KNIGHTON]: Sensitive. Always 11 12 wanted to see how you're doing. 13 [MS. MARCINA JOE]: M'hm. [MS. MAUREEN KNIGHTON]: Very respectful. 14 15 [MS. MARCINA JOE]: M'hm. 16 [MS. MAUREEN KNIGHTON]: And wanted to make you laugh. 17 18 MS. JOLENE JOE: Yeah. 19 [MS. MAUREEN KNIGHTON]: I always hear her 20 laughs though. MS. JOLENE JOE: Yeah. 21 22 [MS. MARCINA JOE]: She used to phone every 23 day. 24 MS. JOLENE JOE: To this day I still get a -- like, hard feelings or something whenever I go to Duncan. 25

MR. BREEN OUELLETTE: M'hm. 1 MS. JOLENE JOE: It's still hard to go 2 3 there. I went to her place where she lived at her apartment a couple of months ago now. She planted flowers 4 5 outside there and I went to look at them. I'll always keep going there. It just gives me strength knowing that my mom 6 7 planted those. MR. BREEN OUELLETTE: So was there anything 8 that could have been made available to Anne that would have 9 helped her, any supports, anything that could have 10 prevented this from happening? 11 [MS. BERNICE TOUCHIE]: I think some kind of 12 women's services for -- I think of Anne and it's probably 13 her kindness that she got involved with men in need, you 14 15 know, who were maybe addicted but some of them were artists. But her relation -- her -- they didn't last. 16 But 17 she tried. But surprisingly, the longest one was this man 18 that was very abusive to her. She stayed there the 19 longest. Yeah, a very people person. Like I said, she 20 helped me type out a curriculum without any problem. MR. BREEN OUELLETTE: So ---21 MS. JOLENE JOE: I'm wondering if she had 22 like, a maid or something. She -- because I remember every 23 24 time I wanted to see her it was always a hard time with this for cooking or that for cleaning or you know, stuff 25

like that. I just found out it was a daily struggle for 1 2 her. MR. BREEN OUELLETTE: House care? 3 MS. JOLENE JOE: Yeah. 4 5 MR. BREEN OUELLETTE: Yeah. 6 MS. JOLENE JOE: Yeah, I think if she had 7 someone to help a little bit every day like that, that 8 would have took a lot off of her. 9 MR. BREEN OUELLETTE: It would have reduced 10 her pain; is that ---MS. JOLENE JOE: Yeah, yeah, because I 11 remember her saying, like, [A.J.] would get mad because she 12 couldn't can open cans with a can opener. And she'd have 13 to -- she like, made it like it was a bother to ask [A.J.] 14 15 to open it for her. She didn't even want to ask him for 16 help. 17 MR. BREEN OUELLETTE: M'hm. MS. JOLENE JOE: So I think if she had 18 19 somebody -- like, I was even willing to but I had my own 20 kids, right, to -- or else I would have went and helped her every day if I could have. 21 22 MR. BREEN OUELLETTE: Yeah. MS. JOLENE JOE: Prep or whatever she 23 24 needed. 25 MR. BREEN OUELLETTE: M'hm.

MS. JOLENE JOE: But yes, I know she told me 1 a lot of times that she was in pain and that she doesn't 2 3 want to be in pain any more. But it's sad that it had to 4 be that way. 5 MR. BREEN OUELLETTE: M'hm. I thought of a 6 question that I might not have asked. How long was she 7 with him? How long was ---8 [MS. BERNICE TOUCHIE]: With [A.J.]? Let me think. 9 10 MR. BREEN OUELLETTE: --- Anne with [A.J.]? [MS. BERNICE TOUCHIE]: I just remember the 11 12 one ---13 [MS. JOLENE JOE]: Because they only went 14 (inaudible) then Duncan. About five years? 15 [MS. MARCINA JOE]: Yeah. (Inaudible). 16 Timothy. 17 [MS. BERNICE TOUCHIE]: Hank's not very long 18 and then another artist not very long and the one in 19 Vancouver not very long. 20 [MS. JOLENE JOE]: Jim. She was with Jim for a long time. 21 22 [MS. BERNICE TOUCHIE:] She was [Was she] with him guite a while [?] 23 24 [MS. JOLENE JOE]: Yeah. 25 MR. BREEN OUELLETTE: So three years?

MS. JOLENE JOE: Yeah, about three to five 1 2 years. MR. BREEN OUELLETTE: Three to five? 3 MS. JOLENE JOE: Yeah. 4 5 MR. BREEN OUELLETTE: Okav. MS. JOLENE JOE: Yeah, probably about four. 6 A couple in Port Renfrew, a couple in Duncan, eh? 7 MR. BREEN OUELLETTE: 8 Okav. 9 MS. JOLENE JOE: Well, not even two in 10 Duncan, eh, because they just got that apartment. Yeah. MR. BREEN OUELLETTE: And what's -- you said 11 "women's services, some kind of women's services". And I 12 hear that and I'm wondering if you have more specific 13 ideas. And everybody in the room, if they have more 14 15 specific ideas of what that means and what it looks like? And just to think about it, I don't know 16 want to think about, okay, you know, is -- can it happen 17 18 today? What's the cost, any of that. I just want to 19 think, you know, how can women's services support people to 20 help them to avoid these terrible tragedies? [MS. BERNIE TOUCHIE]: You know, thinking of 21 both specifically services for women when in the small 22 community, as I was saying, there's -- they tend to treat a 23 24 certain amount of nepotism and a certain clique get all the services. And some are just sort of oh, you're not that --25

1 in that clique so you don't get the same kind of attention
2 as someone else.

I remember her joining a women's group in her own community. That women's group took a trip to Hawaii and they didn't bring her. You know, isn't that cliquey? You know, it's -- all of a sudden she's not included in the high pricey things and whatever, however they got money for that.

But just that kind of treatment, and it's so 9 much they can do for women's services is when it's the men 10 who need it, the abusive men. If they can get charged for 11 -- know that they're -- need some counselling if they're 12 known to abuse their spouse then they can -- by someone 13 else. And I know how it took a doctor to tell me I'm the 14 15 one that needed the doctor appointment when they charged my ex-husband. 16

And I got beatings so bad that you know it just slaps, but slapped right to the ground and sat on
and slapped and slapped over and over.

You're too ashamed to tell anyone that.
You're too ashamed to report and be an item in the news, in
abuse. So there needs to be more caring workers who care
for all women and not be selective and ---

24 MR. BREEN OUELLETTE: And when I hear you,
25 it sounds like you're also saying that there needs to be a

way that women in abusive relationships can be protected 1 from scrutiny by the community? 2 [MS. BERNICE TOUCHIE]: 3 M'hm. MR. BREEN OUELLETTE: And from people 4 5 knowing their business and judging them for it? Is that a 6 ___ [MS. BERNICE TOUCHIE]: M'hm. 7 MR. BREEN OUELLETTE: You know, is there a 8 privacy issue that if you speak out that that exposes you 9 to vulnerability in the community? 10 [MS. BERNICE TOUCHIE]: Yeah. 11 12 MR. BREEN OUELLETTE: It does? 13 [MS. BERNICE TOUCHIE]: Small community situations. 14 15 MR. BREEN OUELLETTE: How do you ---16 [MS. BERNICE TOUCHIE]: Even if you get raped you don't want anyone to know that because it's so 17 18 demeaning. 19 MR. BREEN OUELLETTE: M'hm. Do you have any 20 ideas how we protect women from that being shamed and the demeaning exposure? 21 [MS. BERNICE TOUCHIE]: I don't know. 22 [MS. MAUREEN KNIGHTON]: I think there needs 23 24 to be more awareness of the violence against women, whether it's your brother, your spouse, any men, and that there be 25

1	some sort of consequence for it within the community at
2	large. Because it's like when you live in a small
3	community like she's talking about, people don't say much
4	because they speak amongst themselves in the small
5	communities. And they say, "Don't say this, don't say that
6	or you're going to get so and so mad if you say this."
7	But then the only way that that will change
8	is if we all get together and start talking about the
9	abuses that happen and not make that woman feel bad about
10	the abuse and make them feel like it's their fault that
11	this happened because they had a drink.
12	That's the whole thing. We're all women and
13	go, "It's my fault. I shouldn't have had that much to
14	drink."
15	And the reality is, it's not their fault,
16	right? Everyone has the right to drink but they don't all
17	deserve to get hit.
18	So in having more awareness of that, I mean,
19	I talk about this with my staff that they need to aware
20	make our communities aware of the violence that's going on
21	and that it's not going to be kept behind closed doors
22	because we talk about sexual abuse, we talk about spousal
23	abuse, mental abuse, all of these things. But we need to
24	have it more open so that then everybody's more aware of
25	it.

Like, the more I get aware of people who are 1 abusing, I don't keep that quiet. And I'm like, oh my God, 2 oh my God, this can't be happening and I bring awareness. 3 MR. BREEN OUELLETTE: So for you, you see 4 5 privacy necessarily can work against protecting women because it keeps things quiet? And if I understand you 6 correctly, what needs to happen is that the pressure that's 7 put on women for this needs to be reversed. It needs to be 8 put where it belongs, on the men that are causing the 9 10 violence? [MS. MAUREEN KNIGHTON]: Exactly, because 11 there is a stigma of that back -- probably started in the 12 fifties, sixties, maybe even before then where women were 13 told that you shouldn't do this, you shouldn't do that, 14 15 don't drink or you're -- that's going to happen, or if you married him you -- now you got to stay with him. 16 17 So those kinds of things have been brought 18 down to the women and some women are still living by that, 19 thinking that they have to go through an abusive relationship just to save their own self-esteem by the cops 20 about their ---21 So would that also MR. BREEN OUELLETTE: 22

23 mean finding ways to teach the younger generation about 24 proper relationship responsibilities?

[MS. MAUREEN KNIGHTON]: M'hm.

MR. BREEN OUELLETTE: 1 Yes? [MS. JULIA IDA JOSEPH]: M'hm. 2 3 MR. BREEN OUELLETTE: Okay. **UNIDENTIFIED SPEAKER:** The younger children 4 5 -- the anger [boys and girls]. 6 [MS. MAUREEN KNIGHTON]: Yes, grandchildren. [MS. JULIA IDA JOSEPH]: I'm already 7 teaching mine. Bernice lives on the reserve. I do too. 8 9 And I just experienced a home invasion and I didn't know what to do because it's like she said, in the years, it's a 10 man's world. A woman can't get a house on there. I can't. 11 I've been there for four years. I live in a little 12 trailer. I bet you -- I don't know the last time I counted 13 there was eight and it might be less now but that many men, 14 15 single men, in a big house. And it's backlash. I didn't know if I 16 17 should report this man because of what would happen to me. 18 I have to depend on these men that are there for fish, for 19 wood. They can quit doing that for you or their wives can 20 -- who works in the office cannot put your cheque through, make you wait two weeks for your cheque. That's just how 21 22 it is. So I don't know if a safe house would work. 23 Why did she have to leave? She had to leave home. 24 She could have stayed and kept her job. Not end up moving to 25

town and they have addictions she doesn't want. 1 UNIDENTIFIED SPEAKER: 2 M'hm. MR. BREEN OUELLETTE: I ask something on 3 that. How do you see that we find the balance of holding 4 all our Indigenous governments and our Indigenous systems 5 6 accountable without relying too much on a federal or provincial government and then they come in with their 7 colonial system and they don't necessarily make it better? 8 How do we regain that power for ourselves as Indigenous 9 people? Do you have any ideas? 10 [MS. MAUREEN KNIGHTON]: Are you talking 11 like, training? 12 I don't know. But I'm MR. BREEN OUELLETTE: 13 14 raising this personally now, as an Indigenous person. We 15 would want assistance to ensure that we have healthy communities but I think a lot of Indigenous people have 16 found that a system from governments means interference and 17 18 it means meddling. And so I'm just wondering if anybody at 19 this table today has any ideas on how we avoid that? What message do you want to send to the government about that, 20 about how they can assist without meddling? 21 [MS. MAUREEN KNIGHTON]: Well, one thing 22 that I thought about over the years, because I was in 23 24 politics a few years ago. I was a mayor for 13 years working in the -- for our community. And looking at the 25

1	community, when I view it, they all they sat in this
2	meeting and they'll say, "We want a dry clean community,"
3	but there's only one house that says that. And then
4	there's only one council person that's in support of that,
5	and then that one council person gets shunned at.
6	So I've always said the only way we're going
7	to get there is if we have a healthy council all around and
8	an educated.
9	[MS. JOLENE JOE]: M'hm.
10	[MS. MAUREEN KNIGHTON]: That way you've got
11	your education, you've got your health, and then you'll be
12	able to start really looking at the community and keeping
13	it healthy. That was my views.
14	MR. BREEN OUELLETTE: So it's the
15	continuations of trying to overcome the damage that's been
16	
17	[MS. MAUREEN KNIGHTON]: M'hm.
18	MR. BREEN OUELLETTE: caused to our
19	people?
20	[MS. MAUREEN KNIGHTON]: And it's all a
21	lot of it is all I mean, let me go back to the thirties,
22	forties where we still have that generation around where
23	they still are dealing with the residential school traumas.
24	And some were just totally not willing to talk about it.
25	And then that just keeps getting passed down and passed

1 down. But you -- it's then proven now to see how 2 your children really watch you and what you're doing. 3 They say, "I'm doing this because I saw you do this." 4 5 And I did that because I saw my mom sober up. And then after a while my daughter said, "My mom is 6 sober. I'm going to do this now." 7 8 So it's the role modelling and it's true. 9 [MS. JOLENE JOE]: M'hm. [MS. MAUREEN KNIGHTON]: So if we -- that's 10 why I go back into our government and say, "Well, if we're 11 12 going to want a healthy community we need a healthy 13 government as well." [MS. JOLENE JOE]: M'hm. 14 15 [MS. JULIA IDA JOSEPH]: And maybe more healthy events, I mean, like this. 16 17 [MS. JOLENE JOE]: Yeah. 18 [MS. JULIA IDA JOSEPH]: At the reserve level because I never see (inaudible) down there. I see a 19 worker down there once in a while and we're not happy with 20 him. 21 MS. JOLENE JOE: Like, how much they want 22 our members to go to school to work for the band; when our 23 24 people do go to school and work for the band and they try to come back they don't hire them. That's what I've seen a 25

1 lot of.

25

[MS. JULIA IDA JOSEPH]: They're scared of 2 3 educated people. MS. JOLENE JOE: Like, my cousin [B.] 4 5 (phonetic), my Auntie Julie's son, he went to school to get 6 his PE to teach PE. He got it. He went back and they didn't even hire him. How does that make us feel when they 7 were pushing us to go get our education and we come back 8 9 and then what, we got our education for nothing for you 10 quys? Like, that hurts. That really hurt me when 11 I see it in my face like that. Like, I'm saying, what if I 12 am to go and get my teacher, right, and go back? And you 13 know how they hire, sorry, but White teachers, right? 14 And 15 they come in and they get their rent paid, they get everything. 16 17 If I were to go and get my teacher and move 18 home are they are going to do that for me? Like, that's 19 what I thought of, what I looked at. Like, why is it so different when they're pushing us to get our education and 20 we go back but they don't help us after we got our 21 education? 22 Even my late mom, she got her care aide to 23 look after elders, elderly. She went back to try and work 24

and they didn't hire her. So you know, that totally makes

INTERNATIONAL REPORTING INC.

people not happy. And it's important and what they want to 1 see, our people work for our people, you know, so they're 2 3 not just paying some stranger to come into the reserve that you know everybody. But yet they don't help them. 4 5 MR. BREEN OUELLETTE: That funding, we're 6 getting into areas that are outside of my experience and 7 they might be outside of the experience of the people at this table. But I'm going to ask the question. 8 By example, when I worked for the Métis 9 Nation of Saskatchewan almost all the funding came from the 10 federal government and a little came from the provincial 11 12 government. 13 Should the funding have a condition attached that it's to be used to hire people from the community 14 15 first instead of from outside? Does that make sense? Does that address some of what you've talked about, Jolene? 16 17 MS. JOLENE JOE: Yeah, like, see if they have their education for it and then see if -- yeah, that's 18 19 what I think. MR. BREEN OUELLETTE: 20 Yeah? MS. JOLENE JOE: Yeah, that people don't 21 just go and their education for nothing and if we want to 22 get our education we want to help our own people. 23 24 [MS. BERNICE TOUCHIE]: And when the tribe does hire outside when there's no members available, the 25

INTERNATIONAL REPORTING INC.

condition of hiring is only interim and they're willing to 1 mentor somebody from the community as well. I've done a 2 lot of mentoring in my teachers and students. 3 And where (inaudible) of that is Treaty 4 5 Nation are slowly getting through better employment and 6 conditions by bylaws. We cannot just assign a job to anyone. It's got to be advertised. There's no chance of 7 nepotism because they have to go through a process if 8 there's the family to hire. 9 And then -- even then all jobs are on --10 more and more on a contract basis. So in the interest of 11 the community, if the Board decides you need to do more 12 training, I'm sorry, somebody else is going to have to take 13 over your job so that the hurt of being let go isn't so 14 severe. It's for their own interest. They may have a 15 condition of returning if they improve -- increase their 16 17 training. Bylaws protect not favouring that, like sort 18 19 of cut out nepotism. And everybody reacts when they think no, that's nepotism and they find out no, it wasn't. They 20 were fairly hired -- you know? 21 MR. BREEN OUELLETTE: 22 M'hm. [MS. BERNICE TOUCHIE]: I don't know if it 23 24 takes changing the government by treaty before they'll change but that's what happened to our government in 25

1 Ucluelet.

17

2 MR. BREEN OUELLETTE: And so a lot of these 3 things that we've talked about, how to help the people, how 4 -- if the people who have been lost could have been helped 5 if things existed. Like, they're the same on this question 6 but I want to ask this question to make sure that we don't 7 miss anything.

8 How do we make things better for future
9 generations to increase safety and dignity and to get out
10 of or avoid violence for Indigenous women and girls? How
11 do we make things better for future generations?

12 [MS. MAUREEN KNIGHTON]: Through this 13 process by making awareness. And you know, to do this but 14 do it with our youth and all the women of all ages, not 15 just the people affected. That way the message gets 16 widespread.

UNIDENTIFIED SPEAKER: M'hm.

18 [MS. MAUREEN KNIGHTON]: So that way our 19 younger generation here -- like I was saying in the 20 hearings, what happens with alcohol and drugs or spouses who are violent? What can happen, what has happened, and 21 that they don't have to stay in it, like, you know? A lot 22 of us think that we have to stay in these relationships to 23 maintain our dignity. That's the stigma and we want to get 24 away from that. 25

MR. BREEN OUELLETTE: M'hm. 1 I want to share something about myself personally as a lawyer in this 2 3 Commission that helps me to inform the question. One of the biggest concerns that I have as a 4 5 lawyer is that it's impossible under our terms of reference 6 as a National Inquiry, with the amount of time we've been given and the amount of money that we've been given -- it's 7 not possible to hear everyone. It's not possible for 8 9 everyone to come before us and share their experience as we 10 have today. Some people aren't ready yet. Some people 11 live too far away. Some people have things in their lives 12 that just -- they can't do this today. 13 Do you have recommendations about how we 14 15 take care of those people after this National Inquiry is over? Do we need another process that continues after the 16 National Inquiry that gives those people a voice? 17 18 [MS. MARCINA JOE]: Maybe a website. 19 MR. BREEN OUELLETTE: So how do you see 20 that? [MS. MARCINA JOE]: I don't know, just like, 21 adding somewhere to get help or just information upgrade. 22 And that's basically where they can get help and about the 23 24 processes and that. 25 Okav. MR. BREEN OUELLETTE: Is there

1 anything else?

[MS. BERNICE TOUCHIE]: Well, probably as 2 3 she was saying, the men, there's murdered men as well and men who were affected from residential school. They're a 4 whole -- like, it can define with how we want things 5 6 [change] from the culture as well, because when we went 7 through the Treaty process it was assumed that we were just doing a template from other communities when in actuality 8 9 our own culture needs to be interpreted as a way of life and then we feel like we're still of Aboriginal. 10 Their knowledge is coming from our ancestors. 11

12 That connection needs to be there. I don't 13 know. Because there's no accepting around, just changing 14 rules and just have to see where it originated from, how 15 our people survived before, and what were their ways of 16 thinking that you find out if you learn the language, some 17 of the ways of thinking.

18 MR. BREEN OUELLETTE: So language education
19 would be another thing to consider? I think I understand.
20 I've learned a little Cree and it -- when you learn -- when
21 I learned Cree it was a different way of looking at the
22 world.

23 [MS. BERNICE TOUCHIE]: M'hm.
24 MR. BREEN OUELLETTE: Is that what you're
25 talking about?

[MS. BERNICE TOUCHIE]: Yes. The world view 1 and the kind of moral teachings that was involved with the 2 3 original storytellers and what have you, our own education 4 system. 5 MR. BREEN OUELLETTE: Well, I think we've 6 reached a point where everybody has said what they want to say but I want to ask to make sure, is there anything else 7 that anybody wants to say? 8 **MS. C.K.:** I wanted to ask about when a band 9 member lives off the reserve like I do, a lot of times they 10 say, "I can't help you because you're way over there." And 11 I don't know if that's telling me (inaudible) over there 12 but I have a good reason to be in -- living in town. I had 13 14 to move. I'm a stroke survivor. It just happened to be a 15 mild stroke, they said, and then so I have to be near a hospital, not 60 miles as it is in Port Alberni to the band 16 17 or to the reserve, to be there and in order -- if you have 18 -- really have a stroke like that you have to go get help 19 right away. That's what they told me. And else it will just -- you're a survivor or you're -- you just 20 (inaudible). 21 MR. BREEN OUELLETTE: 22 M'hm. MS. C.K.: But when you -- if you're closer 23 24 to a hospital then you have a better chance so you have to do -- otherwise, I would try to see what I can try to live 25

1 there so that -- I miss it so much. [MS. JULIA IDA JOSEPH]: (Inaudible) bigger 2 3 house. [MS. MAUREEN KNIGHTON]: Build a hospital on 4 5 the reserve. 6 [MS. JULIA IDA JOSEPH]: Well, that is another one too is that the women are -- like, I don't have 7 a vehicle, she doesn't have a vehicle, she doesn't have a 8 vehicle. But if we're living on the reserve and we don't 9 10 have a vehicle, what if you do have that emergency or 11 whatever? MR. BREEN OUELLETTE: M'hm. 12 13 [MS. JULIA IDA JOSEPH]: Why don't we have emergency vehicles? 14 15 MR. BREEN OUELLETTE: M'hm. [MS. JULIA IDA JOSEPH]: Like, if somebody's 16 having a heart attack they'll send a helicopter but what if 17 18 it's not that serious? Why don't we have bigger transportation? And like I said before, the entertainment 19 or events. 20 MR. BREEN OUELLETTE: M'hm. 21 [MS. JULIA IDA JOSEPH]: You know, in town 22 what I was hearing is, "We should go to a movie. It's on. 23 Let's go to a movie." You know, that -- you won't see that 24 happening at home. There's no movie theatre, you know, 25

1	that can be should be a part of the week. Everybody on
2	Tuesday gets excited about a movie.
3	MR. BREEN OUELLETTE: M'hm.
4	[MS. JULIA IDA JOSEPH]: Or I mean, like if
5	you're not a alcoholic or a addict or a gambler because
6	they have poker night even, you know, and I don't if I
7	don't want to do either one of that, what are you going to
8	do? You eventually run out of movies if you can't afford a
9	satellite dish.
10	MR. BREEN OUELLETTE: M'hm.
11	[MS. JULIA IDA JOSEPH]: It's the isolation
12	too.
13	MR. BREEN OUELLETTE: The isolation doesn't
14	afford a lot of opportunities to have healthy activities,
15	[MS. JULIA IDA JOSEPH]: M'hm.
16	MR. BREEN OUELLETTE: Yeah, right. And
17	[C.K.], you've been excluded from reserve services because
18	you have to live off-reserve?
19	MS. C.K.: Pretty much.
20	MR. BREEN OUELLETTE: Yeah.
21	MS. C.K.: Yeah, pretty much. They times
22	when they say, "Sorry, we can't help you. You're over
23	there." And then whenever there's a fish distribution they
24	say, like, "You got to go over there."
25	MR. BREEN OUELLETTE: And I suppose that

also isolates you from the community and makes it harder 1 for you to be part of the community? 2 MS. C.K.: To be part of -- yeah, which I 3 miss very much although I -- my late husband lived there 4 5 only three months, I think, since that reserve was there, 6 that community. Otherwise, we were all here and there and 7 there and there. But they said that was the only way they could help us, if we were all together in one place because 8 9 they don't help you anywhere else over there. MR. BREEN OUELLETTE: 10 M'hm. MS. C.K.: It's just the same but that's the 11 12 way it is, how -- why it's up there where it is, the 13 reserve is now. MR. BREEN OUELLETTE: 14 M'hm. 15 MS. C.K.: I forget what you call it now but that's it, a lot of it. 16 17 MR. BREEN OUELLETTE: Okay. 18 [MS. BERNICE TOUCHIE]: Well, it's province. 19 Not even the -- I think the farmers were having a hard year 20 from a drought and they got compensated. I've never heard of a west coast First Nations getting compensated for a 21 poor fish run. 22 And our mode of transportation used to be 23 24 always boat and traditionally you helped to make our own before. But now that's gone. Has there been any way they 25

compensated by having buses around the west coast? No. 1 It's a struggle. We're not a tax base. Women are 2 hitchhiking left and right. That's not safe. 3 MR. BREEN OUELLETTE: Okay. I can tell 4 5 people are hot and just a little tired. And I just want 6 you to know that even though we're ending this now, you have my contact information and you can contact me if 7 8 anything else comes to mind after this. 9 And I thank you all for having the courage 10 to come and share your experiences with us so we can try to move this forward in a better way for future generations. 11 12 Thank you. 13 [MS. C.K.]: If I had some points to ask, where -- do you live here? 14 15 [MS. JULIA IDA JOSEPH]: Did you get a card? [MS. C.K.]: Yeah, I did. 16 17 MR. BREEN OUELLETTE: I'll tell you all 18 about it in a minute. I'll stop the recording so the 19 Commissioners don't have to listen to that. They know 20 about it. It will just take a second. Thank you. [MS. JOLENE JOE]: Thank you. 21 22 [MS. BERNICE TOUCHIE]: And thank you. 23 24 --- Upon adjourning 25
