

4	MS. SHEILA MAZHARI: Did you have a
5	different (indiscernible).
6	MS. E.G.: I saw the picture and I was
7	scared, and I said "That's me; I'm a missing child." And
8	then I said, "No, I'm not." And then later on the picture
9	had triggered memories.
10	About a month later, I called the Quebec
11	Missing Children. They had the information about [A.C.] on
12	file and took a report and told me an investigator would
13	contact me, but no one ever did.
14	So then I went to the RCMP in Moncton, New
15	Brunswick, and my first encounter was with a woman officer.
16	I told her about finding [A.C.]'s picture and that I
17	believed that I was her. And the woman said "Who do you
18	think you are?" And I said "[A.C.]". And she said, "How
19	can you be missing? You're sitting here in front of me."
20	I said, "Are you serious?" And she said, "Yes." I said,
21	"Are you going to help me?" And she said, "No."
22	At my family doctor, I tried to prove
23	or disprove if I was her. I was trying to gather evidence
24	from my own life to verify one way or the other. So I
25	asked my family doctor to help me obtain my medical files

from when I was young. He told me to do it myself. I then 1 requested my files from the Moncton Hospital. They told me 2 they only had files from the hospital only and anything 3 from the family doctor would have been destroyed as he 4 retired. 5

2

Then I went to the school district to obtain The police were called and I asked them to take records. me down and take my fingerprints and investigate me for the missing child. He then assaulted me by trying to break my nose. My injuries aren't filed with the hospital. He said I was resisting arrest. He put me in the cell for about five minutes and released me without taking fingerprints or laying charges.

I filed a complaint to Ottawa against the RCMP officer for the assault. I found out that my statement was tampered with. The part about the missing child was removed from my original statement.

In 2016, I called Quebec Missing Children They no longer had [A.C.] on file as a missing child anymore. The picture had been changed to a different name and the name was [D.C.].

I was watching a TV episode of the Missing and Murdered Indigenous Women and Girls, and one of the age-progression pictures that I have came up on the screen. This is when I figured out that [A.C.] was one of the

missing girls. I contacted multiple ministers for help in 1 this matter, to retrieve my medical files and to have help 2 in proving or disproving that I'm her. I did this under 3 the Right to Information Act. Some refused me and others 4 did not respond. 5

In 2017, I had an interview concerning the assault that I had filed a complaint against the officer. In the interview, I asked about my statement, and they said that they attached the original to the documents they sent to Ottawa, and I replied that the man in Ottawa said, no, there was no mention of the missing child in my statement The acknowledged the [A.C] kidnapping and they at all. told me that they could not help me, that the crime happened in Montreal and I need to go there. interview was recorded, so it should be all documented.

So on September 4th, 2017, I arrived in Montreal. There's a woman at the OPN, the Women's shelter, she's a counsellor named [B.], and she called Quebec Missing Children on my behalf. They said they could not help me as I was claiming to be [A.C.], not [D.C.]. I said, "I'm claiming to be the child in the picture." I asked them to do facial recognition and they said it was not the same child and they refused to help me.

Then I went to the Montreal Police on Papineau. I told them that I do not even -- they told me E.G.

1	that I do not even look like her at all. They called my
2	father back in Moncton. He told them that I refused to do
3	a DNA. He lied. I told the police officer, I said,
4	"You're trained to tell if people are telling the truth.
5	I'm sitting here in front of you. Am I lying?" She never
6	responded.
7	Then I was informed that the crime never
8	happened. They said they had no report of the kidnapping.
9	She looked at me and said, "I'm not even going to make a
10	report that you came in here with these allegations." She
11	then said, "Go home. Montreal is not safe." She said this
12	several times.

October 2017. They took my statement, my fingerprints, and

made a report. They gave me a file number. They told me
they do not have the technology like the RCMP for facial
recognition. It would also take them longer with the

fingerprints for some of the same reasons. I haven't heard

5 back from them yet.

November 2017, I went to Ottawa and while I was there I found out that Minister Bennett and the Assembly of First Nations were meeting. I went to the building, and someone from the Assembly of First Nations told me that he had all the pictures of the missing, and a woman was with him and she gave me her card. We emailed each other. I gave her my information, my documents, and she said somebody would be contacting me. No one ever did.

On January 18, 2018, I went to Quebec City where Mr. Trudeau was holding a Town Hall meeting. I planned on speaking, but I got nervous. So I gave my copies of my documents to one of his employees instead of speaking publicly. We emailed each other and she told me she gave my documents to the Ministers and that they would be contacting me. Then she forwarded my information to someone in the Minister's office who informed me about this inquiry here today and told me this was a good place to come and tell my story, and here I am.

Some memories I had my whole life, like being in a toy store where [A.C.] was kidnapped. I went to

1	a toy store here in Montreal called the Bric and Brac. I
2	asked a man if the downstairs looked a certain way, like
3	the one in my memory of the toy store I had my whole life,
4	and they said, "Yes, that's how the store looked." And
5	then I asked him if the owner was a tall, dark man, tall
6	man with dark hair, and he said yes.
7	Another one is camping, and my mother making
8	me go back in the trailer for my father to rape me. A lot
9	of adults sat outside and they just all let it happen.
10	Another one was going to the doctor, whose
11	files that I'm trying to obtain, but they're telling me
12	they're destroyed. I was eight years old and he was giving
13	me a pap test, and he tried to put a woman's inside of me
14	and he said "It doesn't fit". And recently I asked my
15	sister about that, and she said it was for birth control.
16	That's why I was there.
17	MS. SHEILA MAZHARI: Do you have the
18	doctor's name?
19	MS. E.G.: Dr. R.M. He's supposed to be
20	deceased now.
21	MS. SHEILA MAZHARI: [Spells name]?

1	memories have surfaced that I came from Paris, and the
2	passport and my fingerprints are on file. I contacted
3	again, trying to verify if my memories are correct or not.

5	tried again, I had been blocked. They blocked me from
6	contacting them.
7	Another is that I was very, very young and I
8	was kept in a cage, and I escaped and I was running in a
9	field. I can't remember the rest.
10	Another one is that they drugged me. I was
11	older then. I had my children. They came in my home and
12	they drugged me and they raped my children, and all my
13	three children were screaming and crying, and I was yelling
14	"Get out!" I woke up from a nightmare with that memory
15	coming back.
16	I spoke to my family doctor about bringing
17	my children back then to be checked, and he did no
18	internal. He did the same thing recently with my
19	grandchildren. We had them checked for sexual assault, and
20	he did no internal on them recently as well.
21	I hope by doing this today I receive help
22	for the answers I am looking for.
23	I recommend that an independent party look
24	into these matters as the Canadian employees are not doing

After I couldn't find 3 [A.C.] on the Quebec Missing Children, I could still Google 4 her name, and as you can see, it comes up "Child Cartier -5 6 Missing" in the search bar. And then when you look at this one, it's the 7 same child, but it comes up with a different name. This is 8 what Quebec Missing Children has now, the same picture but 9 under [D.C.]. 10 And then there's just some more pictures of 11 just [A.C.]. And then there's a document in here of my 12 original statement that I wrote against the RCMP officer 13 and the one that they sent to Ottawa. 14 15 MS. SHEILA MAZHARI: Do you want to leave any of those? 16 MS. E.G.: No, they're for me. 17 18 MS. SHEILA MAZHARI: Did you want to mention what you think? 19 MS. E.G.: I believe I'm [A.C.] because it's 20 her name that they're trying to hide. If I would have went 21 into the police station the first time and they would have 22 said that they looked into the investigation and came back 23 and said that I wasn't her, I probably would have stopped. 24 But that's not what's been happening. It's like everywhere 25

7	MS. SHEILA MAZHARI: So you think you were
8	kidnapped and now your name was changed. And what about
9	your parents; would they be not your original parents?
10	MS. E.G.: No, I don't believe they're my
11	original parents. I was raised by my grandfather. He was
12	allowed to do as he will with me. I have blocked a lot of
13	memories, but since acknowledging her, I have been
14	diagnosed with PTSD and now the memories of the actual rape
15	are starting to come back.
16	MS. SHEILA MAZHARI: And were there ever
17	any charges laid against your father or grandfather?
18	MS. E.G.: No, he's deceased now. I tried
19	- I don't know if it was 2015 or '16, after they wouldn't
20	help me with [A.C.], I went back as [E.] and I said, "I was
21	raped as a child and all these adults partake by not doing
22	nothing, and they're still around minors," and they
23	wouldn't even investigate.

SHEILA MAZHARI: And is there any indication that what you're saying could be verified by 16 17 them? MS. E.G.: Well, my sister-in-law -- my 18 sister [H.], when I asked her why she took me for a pap 19 test at eight years old, she said it was for birth control. 20 That was before I came to Montreal. I had an argument with 21 her on the phone. She verified the memory. 22 23 MS. SHEILA MAZHARI: And when you say you 24 have PTSD, are you working with a therapist?

MS. E.G.: Yes, 32 weeks.

8	your heritage?
9	MS. E.G.: No.

19	is 2017. Somebody told me the real [E.G.] was given up for
20	adoption and I was put in her place. I can't verify that

23	I was also told that the subdivision that I
24	grew up in was kept off the city maps for so many years,
25	and that the three lawyers that registered it, Lambert,

2	judges now. And [D.C.] was the city employee. He became
3	mayor of Moncton.
4	MS. SHEILA MAZHARI: And so what are you
5	what are the pieces that you need?

7	facial recognition to tell if I am that child, because
8	they're telling me that [A.C.] don't exist, so how do you
9	contact the family to continue correct? I don't know.
10	MS. SHEILA MAZHARI: What else do you think
11	that you would need, what other records?
12	MS. E.G.: I'd like to have my medical
13	files, but I don't know if it's even going to be
14	documented.
15	MS. SHEILA MAZHARI: And you said that
16	doctor is deceased and they said the files are gone?
17	MS. E.G.: Yeah. I tried to call the
18	College of Physicians and the Minister of Health, but they
19	didn't even respond to me.
20	MS. SHEILA MAZHARI: And what year was that?
21	MS. E.G.: I think it was 2016. It was
22	around the time I went to the school district. I did this
23	request under the Right to Information Act and they still
24	said no. Still nothing. That's law. That's why I say the
25	government employees are not doing their job.
