

- 3 11:55 a.m.
- 4 MS. DEBBIE BODKIN: Okay. The time is
- 5 11:52 a.m. and it is still February 14^{th} .
- 6 (Off-the-record housekeeping)
- 7 And so I'm going to let you introduce
- 8 yourself, and tell us whatever it is you're comfortable
- 9 sharing today.
- MS. JOLENE GOOGOO: Okay. My name is
- 11 Jolene Googoo, and I'm from We'kogma'q, Nova Scotia. Um,
- 12 well, there's so much to say. So, when I don't really know
- 13 where to start, I usually just start from the beginning.
- MS. DEBBIE BODKIN: Perfect.
- 15 MS. JOLENE GOOGOO: So, so I'll just say,
- 16 make a little bit -- I'll tell you how, maybe how it all
- 17 started. How I grew up a little bit. I grew up in a,
- 18 like, an alcoholic, um, home, kind of abusive. My, my
- 19 father was abusive with my mother and, um, they drank and
- 20 stuff. And it, I have, there's me and there's my -- I have
- 21 two sisters: one is, she's a year older than me; and the
- 22 other one was, or it, or was five or six years older than
- 23 me. She's passed away, now, in 2009.
- But, um, but me and my mother we were
- 25 really close growing up and stuff. She was a good, she was

- 1 a good person. Like, um, she, she did drink. She did have
- 2 a problem drinking and stuff and it's because I think she -
- 3 her mother walked out on her and her seven sisters when
- 4 she was young. So I think that, kind of, she had a hard
- 5 time with that.
- 6 She, so, um, so that left my older sister,
- 7 Mellissa, to kind of take care of us. She took care of us.
- 8 I remember she took me to my first day of kindergarten, and
- 9 I cried for her. I was so attached to her, and, um, so,
- 10 yeah.
- 11 And, um, like, I, I don't really remember,
- 12 like, a whole lot of good things, I would say about my, my
- 13 childhood. No, no a lot of good things. Like, I remember,
- 14 the first thing I remember, I think my very first memory
- 15 was waking up in the middle of the night and I heard my
- 16 mother yelling, and she was saying, "No, [M.]." That's my
- 17 dad's name. "No." And then we ran out to the, to the
- 18 hallway, and I seen my dad and he pushed her down the
- 19 stairs from, from behind, like, we had, like, 12 flights of
- 20 stairs going down. And I was probably four or five because
- 21 I didn't really, like, register what was going on. And she
- 22 fell down the stairs, and she was at the bottom, and she
- 23 was crying. And then he ran down and I, I remember
- 24 thinking he was going to go help her, but when he got to
- 25 the bottom of the stairs, he started, um, like choking her.

- 1 And I was like, "Oh my God," you know. So me and my sisters
- 2 ran down and my, my, my mother told my older sister to go
- 3 get my grandfather my dad's dad because, you can, so I
- 4 didn't -- they didn't really call the cops a lot. They
- 5 just got my grandfather, and he would come over, and he
- 6 would take my dad away for a few hours, and he'd come back,
- 7 like, sober and sorry and whatever. So --
- 8 MS. DEBBIE BODKIN: And where was that?
- 9 Where were you growing up when this happened?
- MS. JOLENE GOOGOO: In We'kogma'q, in the
- 11 same house. He lives in, he's still there. So. Yeah.
- 12 And so, um, like, even though my, my parents they both
- 13 worked, um, we still, we weren't very, we were kind of
- 14 poor. Like, um, like, we didn't really have, like, a lot
- 15 of breakfasts, and sometimes we didn't have any breakfast
- 16 stuff and, you know, or lunches and stuff like that, and,
- 17 like, that we needed. So when my sister -- and, like, um,
- 18 the music would always be so loud. Like, in the middle of
- 19 night when we were going to sleep. Like, we used to all
- 20 sleep together me and my sisters and, um, so I could
- 21 kind of, like, sleep through stuff. I think that's having
- 22 to sleep through stuff from when I was younger.
- 23 And so, my sister, I think she always felt
- 24 like she was taking care of us. She wasn't much older, but
- 25 she always kept an eye on us and got us to school and took

- 1 care of us, and when she got a little bit older, she
- 2 (inaudible) [went and] got a part-time job when she was 15
- 3 at the store and made sure we had lunch for the next day
- 4 and, um, you know, sandwich stuff and food, you know, just
- 5 stuff like that.
- 6 And, um, my mom, she was always, my
- 7 parents, both of them were always, they always juggled with
- 8 rehab and stuff like that. They always went back and forth
- 9 and then they'd do good for a little while and then they
- 10 wouldn't and then they'd go back and -- we went to a lot of
- 11 graduations.
- 12 MS. DEBBIE BODKIN: And just to interrupt
- 13 you there, do you know -- was there a cause in your
- 14 parents' background that caused the alcoholism?
- 15 MS. JOLENE GOOGOO: Um, like -
- MS. DEBBIE BODKIN: Were either of them in
- 17 residential school or anything like that that you know of?
- 18 MS. JOLENE GOOGOO: I don't know. I don't
- 19 think so. I think they're a little bit young for that.
- 20 Um. I know my dad, his, um, his dad was, had alcohol
- 21 problems, and was abusive to his mother. And with my mother
- 22 her, her dad was, um, had alcohol problems as he grew up.
- 23 MS. PAULA FOLEY: And then you said your
- 24 mother's mother left.
- MS. JOLENE GOOGOO: Yeah. And went, and

- 1 things got kind of worse when my mom's mom, my grandmother
- 2 -- she wouldn't really let us call her Grammy when we grew
- 3 up, she was really (inaudible) [grinchy] and, um, she, so,
- 4 because when she ran away to Boston, when they went to go
- 5 and find her and bring her back, and she wouldn't come
- 6 back. So they weren't really too happy about that. So I
- 7 think that's where it all kind of happened, yeah. And, um,
- 8 (inaudible) [beyond that] I'm pretty sure that my great-
- 9 grandfather was also an alcoholic, too. So I think it just
- 10 kind of runs in the family.
- MS. DEBBIE BODKIN: Yeah.
- MS. JOLENE GOOGOO: And, um, yep, so, um.
- 13 So my sister, yeah. She always took on that role and she
- 14 was, um, really, really great with us, and then it got, she
- 15 got a little bit older and then like a teenager, she wanted
- 16 to keep going to school, but she was having a hard time,
- 17 and she wanted to work and, you know, take care of us at
- 18 the same time. And, um, so when I was 11, she moved to
- 19 Truro. I was so devastated, I cried so hard when she left.
- 20 But she would come back on the weekends and stuff like
- 21 that, and, um, um, shared -- my aunt's husband [Uncle 1],
- 22 he's [identifying information redacted]. Um, he, he paid
- 23 for the motel and bought her clothes and stuff like that
- 24 for --
- 25 MS. DEBBIE BODKIN: For her move to Truro?

- 1 To look after her in Truro.
- MS. JOLENE GOOGOO: Yeah, yeah.
- 3 MS. DEBBIE BODKIN: Okay.
- 4 MS. JOLENE GOOGOO: But, um, like, she
- 5 later on talked about it, and it wasn't really, like,
- 6 somebody doing something nice for a person without, you
- 7 know, expecting other things. And that must have been
- 8 really hard for her, too, because at that time because that
- 9 she, that she didn't do, like, any drugs and that she
- 10 didn't drink and she didn't do, like, none of that stuff.
- 11 So she -- that must have been really difficult for, to kind
- 12 of have to --
- MS. PAULA FOLEY: Live through that.
- 14 MS. JOLENE GOOGOO: Yeah. So I think
- 15 that's were things kind of started going really, kind of,
- 16 going wrong for her at that time.
- 17 And then, um, so ever since that, she
- 18 ended up with a Mohawk guy from Kahnawake and, um, she got
- 19 pregnant with, with his son, and then she moved to
- 20 Kahnawake with him until she was, um, six months pregnant,
- 21 and then she moved back home with us, and she stayed, and
- 22 she stayed with us, I think it was, like, three or four
- 23 years after that.
- 24 And, um, I would help her with her son,
- 25 and, you know my nephew and, like, I always felt like I

- 1 needed to help her back, kind of, for helping us when we
- 2 were growing up. So I always felt like I, kind of, like I
- 3 owed it to her and stuff. And then, um, but I was also
- 4 close with my mother, too. Like, um, when -- let's see. So
- 5 my sister ended up going out with this guy who she ended up
- 6 marrying, [Mellissa's Husband]. And she ended up going out
- 7 with him, and, um, and then that's when she moved to Truro
- 8 and she got pregnant with her second kid.
- 9 MS. DEBBIE BODKIN: Okay. Moved to Truro
- 10 for a second time.
- MS. JOLENE GOOGOO: Um hum.
- MS. DEBBIE BODKIN: Okay.
- MS. JOLENE GOOGOO: And then, um, and then
- 14 she moved to Halifax when she got pregnant with her third
- 15 child.
- And then I was 17 at the time and, um, my
- 17 other sister, [Sister], she, she was going out with a guy
- 18 in the Marines and, um, she got pregnant when she was 16
- 19 and then she -- with his kid. And then she dropped out of
- 20 school, and then, so, um, he was -- I think he was about
- 21 four months old when Mellissa started having problems. Not
- 22 really so much her, but, um, like, child services started
- 23 being called on her because her, um, boyfriend was in the
- 24 drugs and stuff.
- MS. DEBBIE BODKIN: Okay.

1 MS. BARBARA JOHNSON: She wasn't at that

- 2 time, but he was. So they were watching her and stuff and
- 3 she was struggling to like take care of them and stuff, so
- 4
- 5 MS. DEBBIE BODKIN: And where were they
- 6 living then?
- 7 MS. JOLENE GOOGOO: Um, they moved to
- 8 Halifax and she was pregnant with her daughter, [Niece],
- 9 and, um, yeah.
- 10 So, so I would go out and visit her, and
- then I realized she really needed help so I decided to move 11
- 12 up there and finish my grade 12 at QVH. So, um, I told my
- 13 mother about it in the summer and she was devastated, and
- 14 she was like, "Oh, I can't stay here without you and if you
- 15 move, I'm gonna move and stuff like that." She was like,
- 16 "You can't leave me with your sister and your father." And
- 17 I was like, I was like, um, I said -- well, you know, my
- 18 other sister, too, she just had a son and stuff, and but
- 19 they, but her and my mother always butt heads and stuff and
- they had a hard time getting along. And I was like, "Well, 20
- 21 you can stay here for her and all that." And she's like,
- 22 "No." And she was crying.
- So I didn't really think she would. 23
- 24 thought she would stay, but, um, I moved anyways, and I
- moved in the middle well, not middle of the -- it was 25

- 1 around 11 or 12 at night and I didn't have much stuff. So
- 2 at the time, Morly (ph) Googoo was the Chief and he had a
- 3 truck, so I asked him if he could, um, move us, well, move
- 4 me into Halifax because he was traveling back and forth.
- 5 So he said, "Yeah." So I packed up all my stuff and my mom
- 6 stayed in her room the whole time. She wouldn't come out.
- 7 She was really upset. So just figured I'd give her a few
- 8 days and then, um, so I went to Halifax and then. Oh, it
- 9 was, maybe, like, two weeks -- and I enrolled in school, I
- 10 started going to school, and helped my sister and stuff.
- 11 And, um, it was probably about two weeks
- 12 later my mother calls and she's like, "Guess where I am."
- 13 And I was, like, "I don't know. Where?" And she was, like,
- 14 "In Shube, in Indian Brook. I moved." She was, like, "And I
- 15 moved all my stuff." And all this, and I was, like, "Oh my
- 16 God. You did?" And she was, like, "Yeah." She said, "I
- 17 told you I wasn't going to stay here if you left." And I
- 18 felt so bad. Well, I felt bad for my other sister and her,
- 19 right? So I was, like, oh. So, but at the same time, I
- 20 was kind of happy because I did miss her. So it didn't
- 21 take her long. She got a job right away, pretty much, at
- 22 the daycare and she came down the weekends and we spent
- 23 weekends together and stuff and, um, we'd get our hair done
- 24 and all that, and, um. So my mother started going out with
- 25 her old, her old boyfriend from when she was a teenager,

- 1 and, um, so -- yeah. So they started going out. And I
- 2 kind of, I heard a lot of really bad things about him that
- 3 he didn't treat his other girlfriends very nicely and he's
- 4 abusive and stuff, but I didn't meet him. And then, um,
- 5 um, we talked every night.
- 6 And then she would, she called me up and
- 7 she told me that, um, he or not that he but she fell
- 8 down the stairs and she, um, sprained her, she fractured,
- 9 broke her arm, or, in, like, three places or something.
- 10 She had a cast on and stuff. And I started getting
- 11 suspicions at that time.
- 12 And then so I was, um, and then a couple
- 13 more weeks went by and I remember this really well
- 14 because it was around middle of November and my sister was
- 15 about eight months pregnant, Mellissa, the one I was
- 16 staying with and it just started snowing that day, and I
- 17 promised my other sister back home, [Sister] and my dad,
- 18 that I'd go home for the weekend and so my mother called
- 19 and she's like, "I'm coming down this weekend." She told me
- 20 and I was like, "Oh. But I already got a ride and I
- 21 promised [Sister] and dad I'd go see them." And, um --
- MS. DEBBIE BODKIN: What year is this?
- MS. JOLENE GOOGOO: This is in 2002. And,
- 24 um, so she's like, "Oh, but I said wanted to see you." And
- 25 I was, "Well, we can spend next weekend together, you know,

- 1 and we'll make up for it, (inaudible) [but they're really
- 2 lonesome] and stuff."
- 3 So, I end up going back to We'kogma'q and,
- 4 but it was like bad snowstorm all the way. So we stopped
- in Truro because it was so bad for the night, and my cousin 5
- 6 drove me. And it was kind of like a sign. And so I even
- 7 called my sister Mellissa, and I was I, kind of, got a bad
- feeling in Truro. I was like, "I don't know. I feel like 8
- 9 taking the bus back to, um, Halifax." I said. I didn't. "I
- 10 feel like things are keeping me here, like, you know, bad
- 11 weather and stuff like that." I just didn't feel right
- 12 about it. And she was like, "Well," she goes, "We're all
- 13 right." And I was, like, I asked her how she was doing.
- 14 She was like, "We're okay." She was, like, "You should
- keep going." And I was, like, "All right." So I kept going 15
- 16 and then the wipers stopped working and then the rain
- 17 started and then we, we couldn't make it any further than
- 18 Afton. So we stopped in Afton. And then somebody from
- We'kogma'g came to pick us up. So it was just really a 19
- 20 struggle getting home. And so, I got home. And then when
- 21 I got home, my dad and my sister weren't even there.
- was nobody even there. It was, like, oh my God. Why did I 22
- even come back here? So I went to, um, my friend's house 23
- 24 and, um, so I just dropped off my duffle bag and I went to
- 25 his house. And I wasn't -- I was there maybe an hour, and

- 1 anybody who knew, they knew where to find me. So they --
- 2 my cousin did end up coming over and she's like, um, she
- 3 says "Jolene, Jolene." She's like, "Um, you have to come
- 4 over Grammy's." She's like "It's your mother. She, um, she
- 5 fell down the stairs and she's, um, she's not really doing
- 6 too good." I was like, "She fell down the stairs? Like,
- 7 that's kind of weird. Like. Why wouldn't she be doing too
- 8 good, "right? "It can't be that bad." And she was, like,
- 9 "No, it's really bad and she's getting, um, air-lifted from
- 10 Shube to Halifax. " And I was, like, "Air-lifted? Oh my
- 11 God." So I went up to my, my grandmother's and we were
- 12 calling the hospital and stuff and the, um, news wasn't
- 13 good. She had to go to surgery to relieve some of the
- 14 pressure from her brain, and um, so -- and my, my sister
- 15 was pregnant. She was there. So she signed the consent
- 16 forms, kind of, to buy us more time to get there, too.
- 17 So, um, we all traveled, and it was a
- 18 really emotional trip. And we traveled to get there, and
- 19 then we got there and, um, she was just getting out of
- 20 surgery when we got there and, um, my, my sister was trying
- 21 to prepare us for what we would see, but there was no words
- 22 that could ever prepare you for what you were going to see.
- 23 I'll never forget. But she was in the ICU and when we
- 24 walked in, she, um, there was a lot of fluid built up,
- 25 like, from the surgery and stuff, right? And they shaved

- 1 her head and she had, like, a band-aid on and stuff, and
- 2 she was um, they put her on life support, like, you know.
- 3 It was just an awful, awful, like, sight. Like, and, um --
- 4 MS. PAULA FOLEY: Just breathe. Yeah
- 5 MS. JOLENE GOOGOO: -- and so. So we were
- 6 all, like, you know, we were all there. There was? There
- 7 was two sides of the family, like, my sister -- my mom had
- 8 a big family. And my dad had a big family, too. So they
- 9 were kind of clashing, right? Like, um, and we were, it
- 10 was, like, like, probably, like 20 something, 23, I think,
- 11 first cousins on one side, and I think 24 first cousins on
- 12 the other side and, like, 5 on the side of my dad's side
- 13 and then there's, like, 6 on my mom's side. And, you know,
- 14 so there was a lot.
- 15 And then so the, the doctor kept
- 16 coming out and giving us all updates on how she was and,
- 17 you know, she wasn't doing very good at all. And they said
- 18 -- so she started having, like, strokes on, like, the
- 19 second day and this -- by that time, my whole family was,
- 20 like, really arguing with each other so we had to, like --
- 21 I kind of had to say, you know, we've got to bring somebody
- 22 in, like, to mediate, and, um, from now on, doctors are
- 23 going to talk to me and my sisters and my dad. And then
- 24 we'll tell, you know, the mediator, and then he'll tell my
- 25 family members, right? And then because my aunts were,

- 1 like, already arguing about, like, like, the wake the
- 2 funeral, and, like, she wasn't even gone, yet. And it was
- 3 really upsetting.
- 4 But, what was really the most upsetting
- thing, I'd say, what upset me, really, the most was one of 5
- my aunts, um, snuck in her, her boyfriend at the, you know, 6
- 7 she was staying with.
- 8 MS. PAULA FOLEY: Your mother's boyfriend?
- 9 MS. JOLENE GOOGOO: Yeah. And to the ICU
- 10 when we were gone and when my sister's getting washed up or
- 11 something. One of my cousins told me, and I was really
- 12 upset about it, and I was, like, he's probably, he's
- 13 probably trying to make sure that she's, you know, gone and
- 14 that she can't tell on him. And I, like, suspected him
- right away, right from the beginning, I had a really bad 15
- feeling that he, you know, pushed her. And, um, so I asked 16
- 17 about, I asked about the cops and if they were
- investigating it, and they said they weren't because they 18
- said that, um, that they weren't investigating it because 19
- 20 she was still alive and that they weren't going to
- 21 investigate it until she died. And then, I was, like, I
- 22 wasn't happy about that because I was, like, all the
- evidence will be gone and stuff, you know. And, um --23
- 24 MS. DEBBIE BODKIN: How did the police get
- 25 there? Like, how did they get involved? Like, did one of

- 1 you call them? Or do you remember?
- 2 MS. JOLENE GOOGOO: Well, I think they
- 3 were involved from the beginning.
- 4 MS. DEBBIE BODKIN: Okay. So you think.
- 5 MS. PAULA FOLEY: Like, and 9-1-1 call?
- 6 MS. JOLENE GOOGOO: Yeah. Well, my aunt
- 7 did call 9-1-1. When, when she went looking for my mother
- that day, she said she walked in, and, um, [Mother's 8
- 9 Boyfriend] - his name was - he was sitting there having a
- 10 bologna sandwich, sitting at the table with his brothers,
- 11 and she said, "Where is my, um, sister?" and all that. And
- 12 then, he was, like, "Oh. She went downstairs to do laundry
- 13 a long time ago, and she never came back up. " And when they
- 14 went down, she was already laying down at the bottom of the
- 15 stairs and the blood was really thick, they said.
- 16 nobody has really any idea how long she was even laying
- 17 down there. And it wasn't even that many stairs.
- 18 was probably, maybe, like, six or seven stairs. And
- there's no railings going down, but, you know, she wasn't 19
- 20 really that clumsy. But, anyways, um --
- 21 MS. DEBBIE BODKIN: And sorry. Before you
- 22 go on. What's [Mother's Boyfriend] full name?
- 23 MS. JOLENE GOOGOO: Um, [first name] --
- 24 MS. DEBBIE BODKIN: It's okay that you
- 25 don't remember right now.

- 1 MS. JOLENE GOOGOO: -- [last name].
- 2 MS. DEBBIE BODKIN: [Mother's Boyfriend].
- 3 Okay. Thank you.
- 4 MS. JOLENE GOOGOO: And um, so, yeah, so,
- um, back at the hospital --5
- 6 MS. DEBBIE BODKIN: And the police, you
- 7 mentioned.
- 8 MS. JOLENE GOOGOO: -- so I'll get back to
- 9 that part. But then at the hospital she started having all
- 10 these strokes and stuff and then all those good parts of
- her brain were gone, like the personality and that humor 11
- 12 and all that good stuff, right? But her heart was really
- 13 strong. Like, her body was strong. She never smoked or
- 14 nothing. She was in good shape, right? And so, um, the --
- 15 I remember, I remember I was crying, um, and I was hugging
- her and stuff and, um, she kind of, like, I don't know, she 16
- 17 coughed, but she -- the way I felt when I was hugging her,
- 18 crying, it was like she was gone already. It felt like she
- was dead already. So I was just, kind of, crying. So when 19
- 20 she, kind of, like, jumped up like that, it felt like she
- 21 was coming back to life and it really scared me. And I
- even, like, jumped back and I got scared, right? And I --22
- and then my aunt was like, "It's okay. It's okay. 23
- 24 just coughing." But I was still really shooken up by it,
- 25 and I had nightmares about it, for years after that about

- 1 her, like, sitting, coming back to life, and like, you
- 2 know, looking over and, you know.
- 3 Um, so, then the, um, the doctor came and
- 4 he talked to us, and he said that, um, if, if we were going
- 5 to take her off life support that we would have to make
- 6 that decision, like, right away, because, um, because there
- 7 was that window was closing, and like, and she would be
- 8 kept like a vegetable and I know she wouldn't want that.
- 9 And it seemed like my sisters and my, my dad, they were
- 10 like, in, in shock, like, they were just, kind of, dazed,
- 11 like. They weren't really hearing what was being said,
- 12 and, um, like, they just weren't. I don't know why. She
- 13 just -- some people get really shocked with, I think, when
- 14 traumatic things happen. I can -- I don't get shocked. I,
- 15 kind of, skip that part. It hits me, I don't know, like,
- 16 right away.
- And, um, so, so I told the doctor, um, to
- 18 take her off life support right away, like, as soon as you
- 19 can. But, I wasn't going to tell my family that because
- 20 they would want, like, my aunts and stuff, they would want
- 21 to keep her around no matter what. And, um, like, even if
- 22 she wasn't, like, in the hospital (inaudible) or anything
- 23 like that. And so, um, the doctor did do that, and he took
- 24 her off and she did last, she lasted 13 and a half hours
- 25 off life support, and it was horrible for two and a half

- 1 hours because she was, just, like, like, like struggling,
- 2 her every breath, like, it was so horrible to see that.
- And I kind of felt bad about. I always felt really quilty 3
- 4 about it.
- 5 But, um, like, my family started arguing
- 6 about it after that, you know, they wanted to have an open
- 7 casket, they wanted her, um, to be, her wake and her
- funeral to be in Shube, but I was, like, 100 percent sure 8
- she was pushed downstairs. I didn't want her to be buried 9
- 10 in Shube, and she lived in We'kogma'q for 25 years, so she
- 11 kind of made that her home. So I knew we were bringing her
- 12 home and I, I kind of called all the shots because my
- 13 sisters and my dad they were too, like, like, dazed and
- 14 like --
- 15 MS. PAULA FOLEY: They weren't able?
- 16 MS. JOLENE GOOGOO: No. They weren't able
- 17 to make any kind of decisions at all. And even after, too,
- 18 even after she died, I went to the funeral place, and I, I
- said "It's going to be a closed casket." Even though my 19
- aunts wanted it to be open, because she was really, really 20
- self-conscious about her looks and stuff, and she wouldn't 21
- 22 want anybody to see her like that. She wouldn't even have
- wanted us to see her like that, let alone everybody, right? 23
- 24 So I did feel bad for her aunts, though.
- 25 I mean my aunt, her sisters -- because I have sisters,

- 1 right? So I said, "Okay. So, I said, "Well, I'll let them
- 2 have the wake for two days and a night in Shube, but not at
- the reserve. Outside of the reserve. Like, in the, on the 3
- 4 other side, at the funeral parlor." And I said, "Then
- we'll have the wake in We'kogma'q, and then she'll be 5
- buried in We'kogma'q." 6
- 7 So I went to the funeral -- we all went,
- 8 but, I picked out all the cards and the poems and that and,
- you know, the separate cards for both separate places, and, 9
- 10 you know, made, picked her outfit and all that, and, um,
- 11 the tears [pictures] and stuff, and, um, I picked out of
- 12 casket. And, um --
- 13 MS. PAULA FOLEY: A lot of (inaudible),
- 14 eh?
- 15 MS. JOLENE GOOGOO: Yeah. But, you know.
- 16 So, so, well, um, we all went back to We'kogma'q after
- that, and then, we had -- the family was really, they were 17
- 18 so mad. Her sisters were so mad about I was taking her back
- home to be buried that, um, I think only one or two of them 19
- 20 showed up for the funeral. They were that mad. And they
- 21 stayed mad for years. And like, seven years after that,
- 22 that's how long they stayed mad for until, until, um, my
- sister passed away. That's how long they stayed mad at us 23
- 24 for. So, just like, stubborn.
- 25 And, um, so a couple of months after, not

- 1 even -- maybe about a month after my mom passed away, um, I
- 2 stopped going to school and I moved back to We'kogma'q.
- 3 And, um, I went to Shube to go there for, um, and I stayed
- 4 with my aunt, but I didn't tell her what I was doing there,
- 5 but I told my cousin. And I got him to drive me around and
- 6 stuff. And I stayed there for a week and I went to the
- 7 police station and stuff. And, um, I looked at the
- 8 statements from when that was there, and I read year ago's
- 9 statements, and then I asked about, like, asked the cops --
- 10 they were really nice, and they were, like, you know,
- 11 friendly and stuff. They were trying to help. I think
- 12 they felt bad for me.
- 13 MS. DEBBIE BODKIN: What police service
- 14 was it.
- 15 MS. JOLENE GOOGOO: Um. Just the RCMP.
- MS. DEBBIE BODKIN: RCMP gentlemen.
- 17 MS. JOLENE GOOGOO: In Indian Brook.
- 18 MS. DEBBIE BODKIN: In Indian Brook?
- 19 Okay.
- 20 MS. JOLENE GOOGOO: Um hum. So, you know,
- 21 they -- I asked them if I wanted to get her case re-opened
- 22 or get it re-investigated, you know, what to do? And they
- 23 said that I should take, um, re-take their statements and,
- 24 um, they told me how to do it. Like, you know, either
- 25 write it down or get them to write it out and make sure

- 1 that they read it or you read it to them and they sign it
- 2 at the end.
- So that's what I did. So I took 3
- 4 everybody's statement again, and it was totally different
- from the one I read. And the last person I did was 5
- 6 [Mother's Boyfriend], because I didn't really want to meet
- 7 him, but I did anyways.
- 8 MS. DEBBIE BODKIN: Who were the others?
- 9 What you say "everybody". How many?
- 10 MS. JOLENE GOOGOO: It was, like, I think,
- 11 two or three of his brothers, the neighbour that lives
- 12 across the road. They were all drinking that day.
- 13 And like, because, and she had, like, a
- 14 \$900 paycheck, and, like, none of her money was in her
- account and there's, like, you know -- that's not like her. 15
- 16 She was always saving money and, like, she kept track of
- 17 every cent, so it was weird that that money was gone.
- 18 And so, I went to -- so my cousin drove
- 19 me. My sisters thought I was crazy for going back
- 20 (inaudible) and I really felt like I needed answers.
- 21 needed closure, right? And so, I was so nervous before
- going. My cousin said, "Are you sure you want to go in?" 22
- "Yeah, I'm going to do this," I said. And he's like, "I'll 23
- 24 wait right here. If you need, if you need help, "he said,
- 25 "just yell for me or something." And I said, "Okay."

- 1 So I went in and, um, as soon as I walked
- 2 in, he, he recognized me. Because I look a lot like my
- 3 mother, and then, so, um, as soon as he seen me, he said
- 4 um, he asked everybody, his brothers to leave and to talk
- 5 to me alone. So they left and then, so, I sat down, and I
- 6 was, like, kind of nice to him well not nice to him but
- 7 I was, like, you know, it was really hard for me to do
- 8 that.
- 9 So first I asked him to tell he what
- 10 happened that whole day, from the beginning to the end,
- 11 like, step-by-step, like, every little thing. And so,
- 12 like, he, he told me and he walked me right through it.
- 13 And then he told me, like, she, she fell in the, in the,
- 14 um, and hit her head on the corner of the entertainment
- 15 stand in the living room; and then she fell and she hit her
- 16 head on the, um, the side of the bathtub, and stuff; and
- 17 then her clothes got bloody; and that's why she was going
- 18 down to the basement to wash her clothes that were bloody.
- 19 And she wasn't, she wasn't, like, really even that clumsy
- 20 of a person, even when she was drinking, right? And then,
- 21 so I wasn't buying it at all. I knew, I just knew he was
- 22 lying. And when, even when he walked me through everything
- 23 and said what happened, and we went down to the basement,
- 24 there was even still, like, the, um, chalk outline of where
- 25 she was, because that's how, like, how close everything

- 1 happened, which was not that long ago, right?
- 2 And so, so then we sat down and then I got
- 3 him to, to tell it to me all over again, but slower, and
- 4 that time I wrote it down and I wrote it down, what he was
- saying, and it was, like, so many pages, and then I read it 5
- 6 back to him, and then I got him to sign the bottom of it,
- 7 and then I, when I was leaving, I told him, I said, I said,
- "[Mother's Boyfriend]." I said, "I really don't like you." 8
- 9 I said, "And I really think that you pushed my mother down
- 10 the stairs, " and I said "I hope someday you will pay for
- 11 what you did to her." So, I said, "I might not be able to
- 12 prove it, " I said. But I said, "You know, maybe somebody
- 13 could someday." And then so, he didn't say nothing, and I
- 14 just walked out and, you know, it was really kind of scary.
- 15 MS. PAULA FOLEY: Um hum.
- 16 So I went back and I, MS. JOLENE GOOGOO:
- 17 I thought I would feel a lot better, but I didn't. I
- 18 didn't really feel much better, because I thought -- you
- think you would do some things and you'll feel a lot 19
- better, but you didn't. So I went back to the cops and I 20
- 21 told them, and they were really, like, being my friends, by
- 22 this point. Because every day I was there for, like, a
- week, and you know, they felt really bad. And so they knew 23
- 24 that the statements that I took and the statements that
- 25 they took before in the beginning were, like, totally

- 1 different --
- 2 MS. PAULA FOLEY: Um hum.
- MS. JOLENE GOOGOO: -- like, really, 3
- really different. And they didn't match up at all. And 4
- then, um, so, they, they said you might have a better 5
- 6 chance if you -- they told me I could file, like, for
- 7 wrongful death because there should have been, um, you
- know, railings going down, but there wasn't. And I said, 8
- you know, "That's not really what I want, and that's not 9
- 10 gonna really bring, you, any feeling of justice from that."
- 11 So I didn't, and I didn't pursue that there.
- 12 And so, um, by this time, um, my sister
- 13 was -- and she was just having the baby and, um, she was,
- 14 um, nine months, and, um, it was in December --
- 15 MS. DEBBIE BODKIN: Still 2002?
- 2002? 16
- And, um, or no. 17 MS. JOLENE GOOGOO: Yeah.
- 18 No, yeah. End of November, that's right. And, um, she had
- my, my niece [Niece], so, um, it was after that that she 19
- started doing drugs. She really, really couldn't cope 20
- 21 with, um, the loss of my mother and stuff, like, I mean it
- 22 hit all of us, like, it really, really hit her hard, like,
- she couldn't, she couldn't cope with it at all. 23
- 24 And she turned to drugs and she started
- 25 using, and, um, so then I was, you know, so I went back. I

- 1 was back and forth trying to help her take care of the kids
- 2 and stuff. And then, um, the kids, they got, um, taken
- 3 away and, yeah. They got taken away from family services.
- 4 And then, so, in order to get them back, I mean, um, she
- 5 went to rehab and all this stuff, and then, um, she went to
- 6 stay at the, um, treatment center in the reserve. And I
- 7 would stay there with her. She stayed there about -- I
- 8 have it was, like, 11 months that she stayed there, and I
- 9 stayed there with her most of the time.
- 10 And then she got pregnant with her, her,
- 11 um, her fourth son, [Nephew 2], she had him. And then she
- 12 had him there and then, um, she was doing good, and then,
- 13 so, they let us out and, but she was still on conditions
- 14 not to see, um, [Mellissa's Husband], because he wasn't
- 15 participating in the drug tests --
- MS. PAULA FOLEY: Yes.
- MS. JOLENE GOOGOO: -- and the conditions
- 18 were no contact with him, and, um, um, drug tests for
- 19 herself.
- 20 So we moved in to Port Hawkesbury, about
- 21 half an hour off the reserve. We moved into a house there,
- 22 and we took care of the kids and stuff, and that was, like,
- 23 probably, like, a really happy time in my life, I'd say. It
- 24 was good times there, and, um, I don't know how long -- I
- 25 would say we lived there for quite a while, and, um, it

- 1 was, I think, Canada Day weekend and, um, we went to -- oh
- 2 no. We went to court and then they, the judge said that
- 3 the case was closed so we were, you know --
- 4 MS. DEBBIE BODKIN: This is your mom's
- case or to do with the --5
- 6 MS. JOLENE GOOGOO: Oh no.
- 7 MS. DEBBIE BODKIN: -- kids?
- 8 MS. JOLENE GOOGOO: Mellissa's. Because
- 9 my mom's case was, it never got re-opened.
- 10 MS. DEBBIE BODKIN: Okay.
- 11 MS. JOLENE GOOGOO: And, um, it wasn't,
- 12 no.
- 13 MS. DEBBIE BODKIN: So this was the family
- 14 court case?
- 15 MS. JOLENE GOOGOO: Um hum. So we were
- 16 really happy about that. And so, but nobody told us that,
- um, like, the conditions still stuck. 17
- 18 MS. PAULA FOLEY: Oh, okay.
- MS. JOLENE GOOGOO: -- until, um, a couple 19
- 20 of weeks after, until, like, the paperwork was final. And,
- 21 like, you, so, we went home and we were so happy, and we
- 22 were celebrating and stuff.
- 23 And then that weekend, I went home, I went
- 24 home for Canada Day weekend. And, um, so I was drinking
- 25 and stuff and I lost my cellphone, and then, um, I quess

- 1 Mellissa was texting me and it was raining that night and
- 2 my, um, my cousins ended up finding it. And they hair-
- 3 dried it and they turned it back on and they read it and
- 4 then it said, it was texts from my sisters, and it said,
- 5 "Jolene, don't come back today because, um, I let
- 6 [Mellissa's Husband] visit the kids for a couple of hours."
- 7 She's like, "Don't worry, we're not back together." She's
- 8 just, like, "The kids just really wanted to see him, so I
- 9 let, let, I'm letting him see them for a couple of hours."
- 10 And then, so, um, my aunt went to the
- 11 grocery store to get a roast or something, and she took it
- 12 to my sister's knowing that [Mellissa's Husband] was there,
- 13 right? And I didn't know even know none of this was
- 14 happening. And then, so, um, she walked in and she seen
- 15 him sitting on the couch, and then so she left the roast or
- 16 the ham, right over there, and she went and she, she
- 17 called, um, children's services right away. And, like, I
- 18 think not even 45 minutes later, um, they showed up with
- 19 the cops and they apprehended the kids (inaudible) [on the
- 20 spot] and stuff.
- 21 So like, so he left and the kids, you
- 22 know, were gone, and, um, her youngest son was eight months
- 23 old I remember at that time, and, um, she was so
- 24 devastated. We were both devastated. I felt like I lost
- 25 my own kids, like, it really, it was so much hard work,

- 1 for, you know, and I thought we were, I thought we are done
- 2 with all that. And it just happened all over again. So it
- 3 was really, really hard.
- 4 And then, so she started, um, doing drugs
- 5 again after that. So -- and then, and then she got back
- 6 together with [Mellissa's Husband] after that. And then,
- 7 um, my family ended up getting, like, custody, well, of the
- 8 kids. They were taking care of the kids, and, um, they
- 9 told, they said that, you know, "If you say with
- 10 [Mellissa's Husband], you'll never get your kids back and
- 11 stuff." And they got all lawyered up, and I guess [Uncle 1]
- 12 was paying my aunt's, her husband was paying for lawyers
- 13 to, um, keep those kids away from her.
- And then, so, meanwhile, like, she was
- 15 going back and forth to court and then I went with her, and
- 16 then, so, she thought by marrying [Mellissa's Husband] they
- 17 would stop, but it made them -- they're really stubborn,
- 18 too. And it made them even more, too. And they kept the
- 19 kids, even, you know, more after that, and then they
- 20 started threatening her with, like, adoption, and then said
- 21 they were going to adopt her kids and stuff and -- so she
- 22 was pregnant with [Nephew 1], her fifth kid, and, um, so
- 23 she, she was afraid to have her in the hospital, but she
- 24 ended up having her at, um, [Mellissa's Husband]'s cousin's
- 25 I think in the bathroom, she delivered her. And, um,

- 1 she went to the, it was a snowstorm and stuff. She went to
- 2 the hospital and she was, like, um, premature, and so she
- 3 was there for a little bit and I didn't even get a chance
- 4 to go to the hospital and I met up with her. And I was,
- 5 like, "What are you doing out here?" And she was like,
- 6 "Oh," she said, "The nurses said I could get a few things
- 7 and, you know, since I'm going to be at the hospital for a
- 8 while, they said that they could, that they'd watch [Nephew
- 9 1] and, um, while I get shampoo and all the stuff that I
- 10 need." And so she was, like, really happy and in a good
- 11 mood, and I seen her and I told her I'd come visit her
- 12 later that day, and then, um, when she went back there,
- 13 there, there was, like, four cop cars outside and they
- 14 wouldn't let her back in. So she didn't get to go back in.
- 15 And then my cousin, my first cousin came and started taking
- 16 care of my, my niece, and so, she was really devastated
- 17 after that. Like, that, that was so devastating to her,
- 18 it, it did something to her. Something that doesn't ever
- 19 make somebody the same. Like, it permanently --
- MS. PAULA FOLEY: Changed.
- 21 MS. JOLENE GOOGOO: -- changed her, right?
- 22 And, um, like, her fear was really, really high at the
- 23 time. But she kept going to court and she kept, you know,
- 24 trying to fight for the kids back and, um, her husband, he
- 25 was, um, he was abusive. He -- well, he started to get

- 1 abusive I think after a while.
- MS. DEBBIE BODKIN: 2 Is this [Mellissa's
- 3 Husband]?
- 4 MS. JOLENE GOOGOO: Um hum.
- 5 MS. DEBBIE BODKIN: What's his last name?
- MS. JOLENE GOOGOO: [Mellissa's Husband]. 6
- 7 MS. DEBBIE BODKIN: Okay. We did stay
- [say] that. 8
- 9 MS. JOLENE GOOGOO: And, um, yeah.
- 10 Because, and then so, she got into a big fight with my
- 11 sister, my sister, [Sister]. So, they, they weren't really
- 12 speaking, but she called me up one night and she said that
- 13 was, that she was coming home and she had everything, the
- 14 truck all packed up and stuff. And my dad's house is the
- 15 name, [one line redacted - personal information]. So I
- asked [Sister] if she minded which I shouldn't done, but, 16
- 17 I can't (inaudible) [say shit about it] now that - but, you
- know, [Sister] said no. She didn't want her to come back. 18
- So she didn't let her come back, and then I told Mellissa 19
- this, and I was, like, "Oh, I'm sorry, but [Sister] said 20
- 21 that she doesn't want you here." And she was, like, "What
- do I do now? My God." And she was, like, "I have to take 22
- them back and unload everything, " and you know. 23
- 24 crying, she was crying. I was so upset and it was really
- 25 emotional. I was so mad at my sister for that.

- 1 And so, she went back to him. And she
- 2 stayed there, and then, like, it was around that -- and
- 3 then she went to, we were going back and forth to court, so
- 4 I moved to Port Hawkesbury to be closer to her. And, um,
- 5 so, we would meet up there and she would stay with me and -
- 6 or I did stay in Chapel Island with her and -- but I'd
- 7 get into it with her husband a lot. We would butt heads
- 8 sometimes.
- 9 And, you know, so, um, she started getting
- 10 suicidal. And then, um, about a year and a half, probably,
- 11 before that she really did it, she got really suicidal.
- 12 And probably, like, a couple of weeks out of the month, I
- 13 would stay with her, and, um, until she felt better, and
- 14 then I'd go back home to We'kogma'q. And during all this
- 15 time, I told my sister [Sister], I said, "You know,
- 16 Mellissa, "I said, "She's going to kill herself, you know."
- 17 And then she's, like, "Don't say that, don't ever say
- 18 that." Because, um, Mellissa -- I mean, [Sister]'s son's
- 19 father was in the Marines, eh? And he, um, he hung himself
- 20 when, um -- it was, I think it was in 2004 he did that?
- 21 [Four lines redacted pursuant to Rule 55]. And so she was,
- 22 she was mad, like, at the world, but she was mad about
- 23 that, too, and she was, like, "You know that (inaudible)
- 24 killed himself. Why would you say that? " And I was, like,
- 25 "Well, I thought you'd want to know what our sister's going

- 1 So I'm just telling you, that's what's going to
- 2 happen." And she was, like, mad about it. "I don't ever
- want to hear that again. " And then it's, like, "All right. 3
- 4 Whatever."
- 5 And so, she was mad at me for going back
- 6 and forth and she was, like, "Oh, I need you here, too.
- 7 And why do you always have to choose her over me?" And
- stuff, and it's like, you know, so I went to court with 8
- Mellissa one day and, um, it was my aunt there and my 9
- 10 cousin, um, that came up to her and told her that, um, that
- 11 they, that the adoption went through and that she was going
- 12 to get papers saying that two of her kids were adopted by,
- 13 by --
- 14 MS. DEBBIE BODKIN: By your aunt? By the
- 15 aunt?
- 16 MS. JOLENE GOOGOO: Yeah. And Mellissa
- 17 was crying, she was so upset. And she was, like, um, "How
- 18 am I gonna get -- I don't want to only get two of my kids
- 19 back, and I can't get the other two back, " and all this
- 20 stuff. And I was, like, "They can't, no way can they have
- 21 adopted the kids. It's no way can they have done it this
- 22 fast." And it's like, I said, "Don't even listen to them,
- they're lying and stuff." 23
- 24 And so right from the courthouse, we went
- 25 to the post office, and she checked the, um, her mailbox,

- 1 and there really was a, a brown envelope from the lawyer,
- 2 and I was gonna reach for it, I was reaching for it and she
- 3 shut it, and she thought it was the, um, the, you know,
- 4 saying that the kids were adopted. And she broke down and
- 5 she's on the ground and she was, like, crying and stuff
- 6 and, um, by this time, [one line redacted personal
- 7 information], but that she didn't tell anybody. Um, I
- 8 knew. And, um, but she was still suicidal. And, um, what
- 9 I, I thought was really on odd because she was, um,
- 10 Catholic --
- MS. PAULA FOLEY: Yes.
- MS. JOLENE GOOGOO: -- [Seven lines
- 13 redacted pursuant to Rule 55]. I was, like, "Well, no,
- 14 you're not. Don't, don't kill yourself, then," I told her.
- 15 And I thought, [three lines redacted personal
- 16 information]. She was still suicidal, and that, that's
- 17 when, how I really knew that, like, that she really wasn't,
- 18 like, mentally, like, completely --
- 19 MS. DEBBIE BODKIN: Stable.
- 20 MS. JOLENE GOOGOO: -- yeah. Like, she
- 21 wasn't the person that she really, was, right?
- 22 MS. DEBBIE BODKIN [MS. PAULA FOLEY]:
- 23 Because (inaudible) those were gone.
- MS. JOLENE GOOGOO: Yeah.
- MS. PAULA FOLEY: Oh. Sorry.

- 1 MS. JOLENE GOOGOO: Well.
- 2 MS. PAULA FOLEY: Okay.
- 3 MS. JOLENE GOOGOO: But, um, so, um, like,
- 4 I knew she was, like, a total different person. Like the
- Mellissa I know and knew and all this stuff, she would 5
- never harm anybody else, [one line redacted personal 6
- 7 information].
- 8 And then so I was like, [one line redacted
- 9 - personal information], but it didn't. And it kind of
- made her think she -- it, it, it made her flash back to 10
- 11 when they took the last baby away from her from the
- 12 hospital and stuff like that, and she wasn't gonna let that
- 13 happen again. [One line redacted - personal information].
- 14 Like, she really thought that was a, like, a solution, a
- 15 real solution. [One line redacted - personal information],
- 16 And, um, so, I'd, like, I would talk her
- 17 out of it and stuff like that, and, you know, cheer her up
- and stuff. But it was only a matter of time before she got 18
- depressed again. And, so, yeah. 19
- 20 And then she was, [one line redacted -
- 21 personal information], and, um, that's when -- I was home
- 22 in We'kogma'q, and I didn't have my phone. I didn't have
- minutes for my phone. But I used to lie in bed at night. 23
- 24 I used to think what I'm gonna say to her the next time I
- see her to talk her out of it? Like, what new things I 25

- 1 would say or how -- what different things I could say to
- 2 make her feel better or talk her out of doing that, so I'd
- 3 be ready, when she, you know, got suicidal again.
- 4 And, um, so I was sleeping one night, and
- 5 I was sleeping and I had a terrible nightmare that, um,
- 6 that she died, and I was so, so devastated that it really,
- 7 like, hurt, like physically hurt. And, um, but then I woke
- 8 up and I was, like, oh, thank God. It was just a
- 9 nightmare, right? And then somebody, but I woke up and
- 10 somebody was knocking on my door. And then so I went out,
- 11 I opened the door and they came in. My, my sister and two
- 12 of my friends, closest friends, and I could tell just the
- 13 way they were looking at me, that (inaudible) [I] knew
- 14 already what happened. I was, like, "Say it." And I was,
- 15 like, "Just say it," I told them. And then they said,
- 16 "It's your sister. She --," and then they said, "She died
- 17 this morning. She killed herself." And then I just broke
- 18 down right away and I started crying and I was crying
- 19 really, and I was, like, "Ow, it hurts, and it hurts," and
- 20 I was, like, that -- and I was so devastated.
- 21 And then my family started showing up and,
- 22 um, I was kind of mad at them. So, you know, and then
- 23 there was a whole bunch of people in my house and they,
- 24 nobody would leave me alone. Like, they, they thought that
- 25 I was going to be suicidal just because she was, but,

- 1 really, I just wanted to be away from everybody because I
- 2 was so mad at everybody. And, um, so finally I just, like,
- 3 freaked out and I said, I told everybody to leave, and then
- 4 my sister and my dad started leaving and I was, like, "Not
- 5 you guys." I was, like, "Everybody but you." And then, so,
- 6 because I said, "You guys all act like you care, now," I
- 7 was, like, "Where have you been the past two years?" And
- 8 I'm like, you know, "You guys are a big part of the reason
- 9 that she did this." And I said, "And now she's gone and
- 10 [one line redacted personal information]." They're,
- 11 like, "Oh my God. [one line redacted personal
- 12 information]?" and I was, like, "You had -- Just go."
- 13 Right? So they left.
- And then, um, um, so, because Mellissa,
- 15 she wrote, I know, I read all the letters that she wrote to
- 16 her kids and stuff before she, you know, did it. Because I
- 17 knew she was going to do it. And she wrote me a letter,
- 18 like, a week before, and I still have it somewhere. But, I
- 19 was more of, like, um, not, like, because I knew I kept
- 20 trying to get her to leave [Mellissa's Husband] and she
- 21 kept trying to say, you know, if -- well she kept -- so we
- 22 did make a plan to leave, and then she backed out of that
- 23 plan at the last minute and I was so, I was so mad at him,
- 24 and I was so devastated. And I was, like, "If you go back
- 25 to Chapel Island, "I was, like, "You're, you're going to

- 1 kill yourself. You're not going to come back." I was,
- 2 like, "I'll never see you again," and all this stuff, and
- 3 we got into a big argument and, um, so. Yeah.
- 4 The last time we did talk, we did argue
- 5 and we fought, but we made up and we hugged and stuff, but,
- 6 you know when you're going to see -- you're never going to
- 7 see somebody again. This, that's the feeling I had. Well,
- 8 I knew that. So it's gonna happen, and there wasn't really
- 9 much I could do about it.
- 10 And so, um, I thought about, um, making up
- 11 with [Mellissa's Husband] for her sake, like I did so many
- 12 other times, just to be with her. So I did call, um, and,
- 13 um, he said she was sleeping. So I ended up going home to
- 14 We'kogma'q. And then that's when it happened. It was a
- 15 few days after that.
- And so, after that happened, I was really,
- 17 um, lost, I would say. Pretty devastated and lost and
- 18 stuff, and, um, so I start making up with my family on my
- 19 mom's side because I wasn't as mad at them as I was my
- 20 dad's side, you know, for how they treated my sister and
- 21 stuff. Because [Social Agency] was my family. Like, my
- 22 family was [Social Agency], like, um, workers, and stuff.
- 23 They worked in -- so I think that's why I was so mad at
- 24 them, too. Like, they gave her no hope at all. Like, it
- 25 was no hope. It was a hopeless situation when all that

- 1 they, all they had, all they had to do was say, you know,
- 2 do this, this and that, and then you'll get your kids back,
- 3 you know. But there was never any of that. It was, like,
- 4 you're not getting your kids back. And that's, that's what
- 5 did happen, you know. You should stop fighting, but she
- 6 was, she didn't stop fighting. And, and they just, it was
- 7 a really hopeless situation, and I was so mad at them for
- 8 that because they were [Social Agency] and [Social Agency]
- 9 should have given her hope. Because that's all she needed
- 10 was a little bit of hope and she would have hung on. And,
- 11 um, they didn't give her any hope. So she didn't hang on.
- 12 And instead they did the opposite, and they're both telling
- 13 about the adoption and it kind of shooked her, and I was
- 14 mad about that, too.
- 15 So I went to Halifax and I was there for,
- 16 um, a few months, and, um, you know, I just needed to be
- 17 away from everybody, and, um, um, so I started going out
- 18 with this guy, and he was, um, he worked a lot, he didn't
- 19 do drugs, and he didn't drink. So that was really good.
- 20 And so we didn't really see much of each other, but, you
- 21 know, I stayed there, and, um, you know, I'd get to hang
- 22 out with my aunts and stuff a lot. And you I kind of,
- 23 like, was able to make peace with everything that happened.
- 24 You know. Like, come and accept it a little bit more.
- 25 Like, not be angry about it because there's, I couldn't

- 1 change nothing. So -- and not to feel so guilty. Like, I
- 2 struggled feeling guilty for a long time, for a long time,
- 3 but, like, I, I dealt with all those emotions, like, kind
- 4 of on my own.
- 5 And, um, so yeah. So I think I was doing
- 6 pretty good, and, um, I was trying to find, you know, my
- 7 way, like, like, trying to find things, positive things to
- 8 do. And then, um, I was hanging out with these, my friends
- 9 and they had a boat and stuff, and then, so, the, um, my,
- 10 like, um -- I couldn't say purpose, but, like, something
- 11 like that came through them. They said, you know, "We have
- 12 a boat. Why don't you ask your band if you can get the
- 13 tuna license and, you know, we'll give you 50 percent of
- 14 the, um, tuna license. And, um, you don't even have to do
- 15 any work, you can just stay on the boat. So, I made that,
- 16 like, you know, my goal.
- 17 So I started traveling back and forth from
- 18 We'kogma'q to Halifax. And, um, so I was meeting with Phil
- 19 Drennon (ph), the Director of Fisheries and stuff, and I
- 20 told him my idea, and he thought that, he said it was a
- 21 really good idea and, you know, so, we worked on that plan
- 22 for a while, and, um, a couple months, and, um -- can I use
- 23 the bathroom?
- MS. DEBBIE BODKIN: Sure. Sure.
- MS. JOLENE GOOGOO: Okay.

- 1 MS. DEBBIE BODKIN: I'll shut the
- 2 equipment off for a bit.
- 3 MS. JOLENE GOOGOO: Okay.
- 4 MS. DEBBIE BODKIN: You can have a
- 5 stretch.
- 6 MS. JOLENE GOOGOO: Oh my goodness.
- 7 MS. DEBBIE BODKIN: It five after one.
- --- Whereupon the session is in recess at 1:05 p.m. 8
- 9 --- Upon resuming at 1:30 p.m.
- 10 MS. DEBBIE BODKIN: Okay. It is 1:30 p.m.
- 11 and we've just turned the equipment on and, um, just a
- 12 couple things I wanted to clarify. Number one, you are an
- 13 incredible young lady, incredibly strong and brilliant and
- 14 well-spoken and someone who's gone through so much and, you
- 15 know, thank you for being able to share it with me.
- 16 honoured to be a part of here and to help you. Um, I
- wanted to ask, whereabouts is [Mother's Boyfriend], now? 17
- Well, um, he died. 18 MS. JOLENE GOOGOO:
- 19 MS. DEBBIE BODKIN: Okay.
- 20 MS. JOLENE GOOGOO: So back to that, I was
- 21 just gonna finish saying that.

- MS. JOLENE GOOGOO: That's okay. 8
- 9 (Cellphone keeps ringing)
- 10 (Cellphone keeps ringing)
- 11 MS. DEBBIE BODKIN: It's possessed. It's
- 12 off. Sorry.
- 13 MS. JOLENE GOOGOO: That's okay. And, um,
- 14 so he took me to the side of the band office and the band,
- 15 like, he was probably about my age, maybe, maybe a year or
- so older, and, um, he was saying -16
- (Knocking at the door) 17
- 18 MS. JOLENE GOOGOO: -- I just wanted to
- 19 tell you --
- 20 MS. DEBBIE BODKIN: Oh. I'm going to get
- 21 up (inaudible). Okay, sorry. Go on.
- MS. JOLENE GOOGOO: So, he took me to the 22
- side of the building and said that, um, "I just wanted to 23
- 24 let you know that, um, I heard about your sister after, I
- 25 heard about your sister and stuff like that," and he said,

- 1 "And I just wanted to tell you that," he said, "I was
- 2 there, um, at [Mother's Boyfriend]'s that day that, that
- 3 happened to your mother." [And he said, "I just wanted to
- 4 tell you that she didn't fall, that she did get pushed."
- 5 And I said, "(inaudible) said, "(inaudible) oh my God." I
- 6 said, "Would you be willing to, like, testify to that in
- 7 court?" And he said, "No." He said, "I don't want to
- 8 because, "he said, "I'm going to get killed for that and
- 9 stuff." And he said, "Me and my friend were both there,"
- 10 and when, after [Mother's Boyfriend] pushed her, he said
- 11 that we ran away and, "We got scared and we ran away," and
- 12 he said "I just wanted to tell you so that you know."
- 13 And so, and so I felt, kind of, bad for
- 14 him because he was really, felt really bad about it, and I
- 15 don't want to put him in that spot. So I didn't really
- 16 push that to go forward any further and that. And then I
- 17 heard, um, not long after that, that [Mother's Boyfriend]
- 18 had cancer and he was dying, so -- and the neighbour across
- 19 the road, she heard he died of cancer before. So then he,
- 20 he ended up dying and so. That's it.
- 21 MS. DEBBIE BODKIN: That's sort of the end
- 22 of that chapter, kind of. Okay. Um. Any, any other
- 23 comments you want to make in regards to your sister and
- 24 your mom and what you feel might be some of the causes,
- 25 what cause, um, resulted in the ends of their lives, like,

- 1 the violence and everything?
- 2 MS. JOLENE GOOGOO: And they were just
- 3 really good people, and I think they were, um, both taken
- 4 too soon --
- 5 MS. DEBBIE BODKIN: For sure.
- MS. JOLENE GOOGOO: -- way too soon. 6
- 7 Maybe they were too good for this life and stuff and they
- were -- I don't know, um, yeah. 8 Just...
- 9 MS. DEBBIE BODKIN: Any, any, any
- 10 suggestions you see what things need to change?
- 11 MS. JOLENE GOOGOO: Um. Well, I think,
- 12 um, women should be, like, be heard and be helped more and,
- 13 like, um, things like this probably could be prevented to,
- 14 like, and I -- and you know, to an extent. And, just, um,
- 15 yeah.
- 16 MS. DEBBIE BODKIN: Okay. Okay. Well,
- 17 thank you, again, for sharing all that you have and for
- 18 being such a strong survivor, for going through so much
- 19 that you have.
- 20 MS. JOLENE GOOGOO: Okay. Yeah.
- 21 MS. DEBBIE BODKIN: We'll end this, now.
- 22 And then we'll discuss more about your after care and so
- 23 on. Okay?
- 24 MS. JOLENE GOOGOO: Okay.
- 25 MS. DEBBIE BODKIN: Okay. So it is 1:35
