

1 Prince Albert, Saskatchewan 2 --- Upon commencing on Wednesday, March 28, 2018. 3 MS. FRANCINE MERASTY: This is Francine 4 Merasty with the National Inquiry into Missing and Murdered 5 Indigenous Women and Girls speaking on the record with Mable Charles of Lac La Ronge Indian Band, and she's 6 7 traveled here from La Ronge. We're here in Prince Albert 8 and the date is March 28th, 2018. Mable, you are here to 9 voluntarily give your statement in the matter of your 10 niece, Happy Charles, and your sister Eva Charles. Um, there's only two of us here in the room. Mable, your 11 12 statement will be audio recorded today. Um, you didn't want to have a camera. Can you please confirm that you 13 14 agree with it? 15 MS. MABLE CHARLES: Yes, I agree with it. 16 MS. FRANCINE MERASTY: Mable, what do you want to share with the inquiry? 17 18 MS. MABLE CHARLES: I'm not sure. 19 MS. FRANCINE MERASTY: Well, in your 20 intake, it says you want to share about your niece Happy 21 Charles and your sister Eva Charles. So who do you want talk about first? 2.2 23 MS. MABLE CHARLES: Um, Happy Charles. 24 MS. FRANCINE MERASTY: Okay. So what 25 happened to Happy?

1 MS. MABLE CHARLES: Um, she went missing 2 from Prince Albert on April 3rd last year, 2017, and they've searched, but they have not found her. 3 They 4 searched all spring, all summer, all -- pretty much all fall --5 6 MS. FRANCINE MERASTY: Um-hum. 7 MS. MABLE CHARLES: -- and they haven't 8 found, found her. And then they were going to start searching pretty quick again. 9 10 MS. FRANCINE MERASTY: Yeah. 11 MS. MABLE CHARLES: Um, she was last seen 12 in P.A. on April 1st. She left La Ronge on April 1st, so she was in P.A. for three days and then she went missing 13 14 according on her boyfriend. But I don't know, she could be 15 missing earlier than that. I'm not sure. It's just 16 [Boyfriend]'s word, eh? 17 MS. FRANCINE MERASTY: Yeah. Can you tell 18 me about Happy? How old is she? 19 MS. MABLE CHARLES: She had just turned 20 42. Yeah. She just turned 42 in March last year. 21 MS. FRANCINE MERASTY: And did she have 2.2 children? 23 MS. MABLE CHARLES: She had five, has five 24 children. Four -- three of them are grown up, and one was 17, and the youngest was 8, I think, eight-year-old boy who 25

was in foster care. The rest were on their own. 1 2 MS. FRANCINE MERASTY: Yeah. And how many 3 brothers and sisters does she have? She only has brothers. 4 MS. MABLE CHARLES: 5 She's got four brothers; one older and three younger. 6 MS. FRANCINE MERASTY: Hum. So she was 7 the second person, the second oldest. 8 MS. MABLE CHARLES: No, she's the oldest. 9 MS. FRANCINE MERASTY: Oh, okay. 10 MS. MABLE CHARLES: The oldest, then her brother, her brother Dallas, and then the three boys of 11 Carson's, Carson's three boys. Yeah. 12 13 MS. FRANCINE MERASTY: Oh, I see. 14 MS. MABLE CHARLES: Yeah, yeah. 15 MS. FRANCINE MERASTY: And at the time she disappeared where did she live? 16 17 MS. MABLE CHARLES: Um, she was living in 18 La Ronge in a student apartment. 19 MS. FRANCINE MERASTY: Oh, okay. 20 MS. MABLE CHARLES: And then she came down 21 to P.A. She was just going to be here for a little while 2.2 and then go back to La Ronge, just taking care of her, um, 23 banking, because she didn't get her GST. She had to go 24 straight to the Royal Bank and straighten it out. 25 MS. FRANCINE MERASTY: Oh, I see. So

1 she's been missing less than a year, but it's going to be a
2 year next week?

MS. MABLE CHARLES: Yeah. 3 4 MS. FRANCINE MERASTY: So can you tell me 5 about when she was reported missing and how the б investigation happened? 7 MS. MABLE CHARLES: Um, she was reported 8 missing, geez -- Monday was the third of that year. Four, five, six -- I'm kind of thinking she was reported missing 9 10 on the 6th or the 7th. We didn't know about it until Friday because we were in P.A. Thursday that week -- and we 11 were there at Lake (inaudible) and I had a bad feeling 12 behind me. Somebody kept coughing and I'd look and there'd 13 14 be nobody there. Two times it happened and I had bad 15 Then I went back to La Ronge, and that's when her vibes. 16 boyfriend's mother said that she was missing. And normally 17 she doesn't say, she doesn't care because she always goes 18 back and forth from La Ronge to P.A. Happy, and this time, 19 she, she said that she had to be reported missing, and it 20 was very strange for us, because she's a very cold woman, 21 and she could care less for her. So she was reported 22 missing then, and the police did not voluntarily put the 23 missing person report. It was different from others, they 24 said, requested by the time family. It wasn't a normal one. It was almost as if they were forced to put it, put 25

it on the news. So that really made me mad because they 1 2 should have taken it as a serious thing. 3 MS. FRANCINE MERASTY: And how many days, 4 like --5 MS. MABLE CHARLES: That was about, geez, maybe ten days after they put that bulletin, I think, maybe б 7 more than that. Because it was just --8 MS. FRANCINE MERASTY: After she went 9 missing? 10 MS. MABLE CHARLES: Yeah. 11 MS. FRANCINE MERASTY: Oh, okay. 12 MS. MABLE CHARLES: I think it was about 13 there -- just took, yeah, took quite a while. 14 MS. FRANCINE MERASTY: And what were their 15 investigative efforts? 16 MS. MABLE CHARLES: I have no idea. I 17 don't think they did anything. They didn't question the 18 last person seen with her; and that is her boyfriend. They 19 didn't question him. 20 MS. FRANCINE MERASTY: They still haven't 21 questioned him? 2.2 MS. MABLE CHARLES: They still haven't 23 questioned him. Like, it was going on to May and my sister 24 said, 25 "So when are you guys going to

1 investigate, interrogate him?" 2 And they said, 3 "Oh, we can't really bring him in 4 because he's always drugged out." "Can't you put him in cells 'til he 5 б sobers up?" 7 "No, we can't." 8 I would have forced him to sober up so I could take a statement, but they wouldn't. It was almost 9 10 like they weren't, they could care less. That's what I 11 thought. 12 MS. FRANCINE MERASTY: And who is this 13 boyfriend? 14 MS. MABLE CHARLES: [Boyfriend]. It's 15 just -- I think he's quite a bit younger than her, like, 16 maybe ten years. And they have a son together that is 17 eight years old. Her last child. But the thing is he was 18 placed in foster care with his little brother. And he 19 brings a lot of money that little boy from foster care. 20 And then from the special needs provincial I think they get 21 \$1,500. Yeah, for you -- I think they got her to sign that 2.2 form that says she's FAS. So they get quite a bit of 23 money. 24 MS. FRANCINE MERASTY: Oh, yeah. 25 MS. MABLE CHARLES: Yeah.

1 MS. FRANCINE MERASTY: And is, and is -what's that guy's name? [Boyfried]? 2 3 MS. MABLE CHARLES: [Repeats boyfriend's 4 name]. 5 MS. FRANCINE MERASTY: Is he involved in 6 his child's life? 7 MS. MABLE CHARLES: Oh, not really. Not 8 much. He'll go visit once in a while, but he (inaudible) streets here. He's heavy into drugs. 9 10 MS. FRANCINE MERASTY: And can you tell me, um, things about your niece, Happy, like, how she was 11 12 as a person. Like, her personality? What she liked? 13 MS. MABLE CHARLES: Well, she was quite 14 She had a lot of friends, on the street and off different. 15 the street. Like, she was approachable for a lot of 16 people. They joked around with her and she was easy-going 17 with them. And she's generous. But, um, when she did 18 something, she did it with full force. Like, if she was 19 going to gamble, she'd do it, like, to excess, and if she 20 was going to drink, she'd drink to excess; stuff like that. 21 Everything was full, full speed ahead, I think. 2.2 MS. FRANCINE MERASTY: And "on the street." 23 24 What do you mean by 25 "on the street?"

1	MS. MABLE CHARLES: Um, the people she met
2	on the street, like the ones she mingled with, that she
3	befriended, they were pretty good to her. They talked, and
4	I don't know they a lot of them knew, knew her.
5	MS. FRANCINE MERASTY: But she wasn't
6	was she homeless, or?
7	MS. MABLE CHARLES: Um, pretty much
8	homeless most of the time. When she was living in P.A.
9	before she came to La Ronge, she was living on the street.
10	MS. FRANCINE MERASTY: Oh, okay.
11	MS. MABLE CHARLES: She'd find a hot spot
12	to go and sleep, a register or something like that.
13	MS. FRANCINE MERASTY: Yeah.
14	MS. MABLE CHARLES: And she, she found a
15	place that was good for her, like our house, [Boyfriend]
16	would go over there and wreck it for her. And he had a
17	place to stay. His mother always grabbed him to go home,
18	but she did not want Happy there.
19	MS. FRANCINE MERASTY: Oh, okay.
20	MS. MABLE CHARLES: So Happy was always
21	left out in the cold, and that was a pattern for I don't
22	know how many years she's been doing that. But she talked
23	about sleeping in alleys and places where there was a vent
24	coming with hot air, until she got chased away. So just
25	really struggling for home. So most of the time she

1 probably didn't even sleep.

2 MS. FRANCINE MERASTY: Yeah. And how long 3 was she homeless? 4 MS. MABLE CHARLES: Oh my God, she's been 5 homeless forever. She's been homeless for a long time. I think when the little boy was about two. б 7 MS. FRANCINE MERASTY: Yeah. 8 MS. MABLE CHARLES: I think that's the last time she had a place of her own. Two, three. So that 9 10 he's nine, now, so about six, I guess, since the last time she had a place. And then she went to our house, but that 11 only lasted a couple of months because he messed it up for 12 13 her. 14 MS. FRANCINE MERASTY: Um-hum. 15 MS. MABLE CHARLES: Yeah. 16 MS. FRANCINE MERASTY: Do you know 17 anything about her life growing up at home? 18 MS. MABLE CHARLES: Yeah. She was -- she 19 grew up with her, um, grandparents, like, her grandparents 20 took her because my sister was young. And then they helped 21 out with her and periodically they'd give her back to try and live with her mom, and she'd go back and forth between 2.2 She couldn't decide where she wanted to live. 23 the two. So 24 she was usually back and forth and her grandmother died when she was nine, and that's when she started smoking and 25

other things. 1 2 MS. FRANCINE MERASTY: Yeah. 3 MS. MABLE CHARLES: -- when she was nine 4 years old. 5 MS. FRANCINE MERASTY: Did she experience any kind of domestic violence or violence in the home? 6 7 MS. MABLE CHARLES: I don't think so. Her parents weren't drinkers. 8 9 MS. FRANCINE MERASTY: Okay. Did she qo to 10 the residential school? 11 MS. MABLE CHARLES: No, nobody did. We 12 didn't go to residential school, so they didn't go. 13 MS. FRANCINE MERASTY: Yeah. 14 MS. MABLE CHARLES: Yeah. 15 MS. FRANCINE MERASTY: And you've said her youngest child would -- or is in foster care. Were any of 16 17 her other children in foster care? 18 MS. MABLE CHARLES: Yeah. They were the 19 three older ones. The one that wasn't in foster care was 20 the one I took in, the youngest girl. She's 18 now, but 21 the other three were in foster care until - geez - I think 2.2 2007, maybe 2005. And then they were going to be sent 23 south, so we grabbed them and we took them. Jena took some 24 and I took some. 25 MS. FRANCINE MERASTY: Can you tell me

some things about Happy, like, what her strengths were? 1 2 MS. MABLE CHARLES: Her strengths. She's got -- she was quite spiritual and she was also good with 3 4 traditional, preparing traditional food, like, um, ducks and stuff like that, filleting fish. She enjoyed those 5 things, being out in the bush. б 7 MS. FRANCINE MERASTY: Um-hum. And she 8 was friendly with people. 9 MS. MABLE CHARLES: Um-hum. 10 MS. FRANCINE MERASTY: Yeah. 11 MS. MABLE CHARLES: And she was available, 12 like, if people needed her for something, she'd jump at it and go help them. 13 14 MS. FRANCINE MERASTY: Yeah. 15 MS. MABLE CHARLES: Always a good listener if you had problems. 16 17 MS. FRANCINE MERASTY: What do you think 18 would you have helped Happy? 19 MS. MABLE CHARLES: I don't know. 20 Probably a wilderness camp where she'd get counselling from 21 Elders, traditional stuff, like her grandmother used to be. I think that would have helped her, and older (inaudible). 2.2 23 MS. FRANCINE MERASTY: Um, do you have 24 anything else more to say about Happy? 25 MS. MABLE CHARLES: Um, she was, um, I

think she started last - for the fall before - she was 1 2 going, um, I think she was going on a road to recovery. Like, she was cut off methadone, so they put her --3 4 (inaudible) pill of some kind (inaudible) and she took that daily. And she was really -- I've never seen her like that 5 before, since she started drugging, and she was calm and б 7 just in good spirits, like, it calmed her down that pill. 8 And it wasn't like the methadone where they're running around seeming to look, like, for more drugs. She was 9 always interested. She would just stay home with her kids. 10 Like, she went to live with them last fall. And she did 11 things with them. And December -- early December -- her 12 little brother brought her here to come get that medicine 13 because she ran out, and when they went to the doctor, they 14 15 refused it. She got cut out. Like, [Boyfriend] went and 16 told that doctor that she was using, but she wasn't. And 17 the doctor believed him, so he cut her off. I think some 18 female doctor. And then my nephew said, 19 "Did they take a pee test?" 20 And he said, 21 "She was in there too short to be, to

22have take taken a pee test. I don't23think so,"

he said. So they took their -- the guy'sword for that. And from there he, he took off the La Ronge

2	her to sober up and get clean. And like, she was doing it
3	for I think she was clean for about three months. And
4	that was a really good thing, if it had worked. And then
5	the time she disappeared, like, a few days before she came
6	to P.A because she came to P.A. April 1st - a few days
7	before that, we had texted her, we had messaged her to come
8	to P.A
9	MS. FRANCINE MERASTY: Yeah.
10	MS. MABLE CHARLES: and then when I
11	confronted him in May - when I saw him downtown - he said,
12	"I never told her to come here. I
13	told her to stay in La Ronge."
14	And I said,
15	"No, you told her to. I know you
16	did."
17	But he didn't know I read messages, and
18	he kept denying that he told her to come. I didn't want
19	her to come here because she didn't have a place to stay.
20	But he was telling her to come
21	MS. FRANCINE MERASTY: Um-hum.
22	MS. MABLE CHARLES: yeah, because I
23	don't think she would have come if he hadn't told her to
24	other than getting her, her Royal Bank thing done.
25	MS. FRANCINE MERASTY: Yeah. So where do

2 MS. MABLE CHARLES: Um, in the beginning we first started at, um, the last place she was at. Down 3 4 the hill from there, like, P.A.G.C. And we went down 5 there. And they were checking all the railroad tracks all the way to SIAT -б 7 MS. FRANCINE MERASTY: Yeah. 8 MS. MABLE CHARLES: That way. Yeah, we went over there. All the way over there. And then they 9 10 went to Westside, all the way out the west, and then they went, we covered, I think we covered the whole city. We've 11 12 seen a lot of needles, we've seen this and that. And then they started searching in the forks, and then north, south. 13 14 They went everywhere. Yeah. And went -- they even went to, um, LT area because an old lady felt the vibes there. 15 16 So they went and searched, but they didn't find nothing. 17 MS. FRANCINE MERASTY: Where's LT area? 18 MS. MABLE CHARLES: LT? It's by 19 Christopher Lake or Waskesiu. Going to Waskesiu there's, 20 there's a restaurant there called LTCL (ph). 21 MS. FRANCINE MERASTY: Yeah. 2.2 MS. MABLE CHARLES: That's where that one 23 woman kept crying, she said, every time she passed. So she 24 wanted them to search but, but they never found nothing. And I think somebody went to search halfway house, too, 25

because they heard noises over there, some woman screaming 1 2 in the bush. Periodically, they'd stop there and they'd hear somebody screaming. So, yeah. They searched quite a 3 4 few places. 5 MS. FRANCINE MERASTY: So who was the last б person that was seen with her? 7 MS. MABLE CHARLES: That was [Boyfriend]. 8 MS. FRANCINE MERASTY: Oh, and what does 9 he have to say? 10 MS. MABLE CHARLES: He said he left her at, I think he said YWCA. He left her by YWCA and he went 11 to -- well this was nighttime. I think he said he went to, 12 I think he said he went to Canadian Tire area. He went to 13 14 Canadian Tire and by the time, when he came back -- oh, 15 they were supposed to meet at Canadian Tire or they were supposed to meet somewhere else. And she wasn't there. So 16 17 he come back and look for her, but she wasn't there where 18 he left her. 19 MS. FRANCINE MERASTY: Um-hum. Um-hum. 20 MS. MABLE CHARLES: So did, I don't know. 21 He does -- he made sure he was seen in the Tim Horton's, 2.2 Tim Horton's -- that video there that shoots those people -23 - camera --24 MS. FRANCINE MERASTY: Yeah. 25 MS. MABLE CHARLES: -- at about an hour

after. He made sure he was walking there. So he was 1 2 visible in the video, in the camera thing. Security camera, yeah. But in that, um, P.A. Did I say P.A.G.C.? 3 I meant P.A.C.I. 4 5 MS. FRANCINE MERASTY: Um-hum. б MS. MABLE CHARLES: P.A.C.I. that's where 7 -- not P.A.G.C., P.A.C.I. The video there, it shows there, 8 like, in the little thing like this there, um, the police say they look like, she looks like she's taking a leak. 9 10 But when you look at her, she looks like she's hiding from something or someone, and then she comes around. And then 11 we see her over here by the grounds, by the yard, the 12 playground, I guess, and she's standing about here, but 13 14 it's such a faded picture, and like this. And then you can 15 see a taller figure. So we couldn't get a figure -- we 16 couldn't see who it was. It was like she was talking to 17 somebody. 18 MS. FRANCINE MERASTY: Yeah. 19 MS. MABLE CHARLES: Um-hum. But it looked 20 like she was scared or something, the way she was acting. 21 Yeah, I didn't really like that investigator. The 2.2 investigators, they didn't seem to take is seriously and 23 they were looking through, um, the treaty numbers 24 (inaudible) numbers. And they said she used her treaty number in La Ronge April 13th, or something. And then we 25

1 figured it out. It was a white woman that was using her 2 number.

3 MS. FRANCINE MERASTY: Um-hum. MS. MABLE CHARLES: Yeah. So that got her 4 5 off track, and she was told to quit using it. But she still kept using it and making everybody mad because it was б 7 -- they were thinking that she was using her own number, 8 but that woman was using it. 9 MS. FRANCINE MERASTY: Um-hum. 10 MS. FRANCINE MERASTY: Do you want to talk 11 about your sister Eva? 12 MS. MABLE CHARLES: Yeah. I could, I could talk about her. Yeah, Eva left for Vancouver in 13 14 spring of '79, in May of -- no, we left her Easter '79. 15 MS. FRANCINE MERASTY: Yeah. 16 MS. MABLE CHARLES: -- she went over there 17 to try and get work because she wasn't getting any work in 18 La Ronge. But she went with a friend of hers, and they 19 took off and um --20 MS. FRANCINE MERASTY: How did they get 21 there? 2.2 MS. MABLE CHARLES: Her friend had a car. 23 She was already working there. She was some postmaster, 24 you know, those mail delivery --25 MS. FRANCINE MERASTY: Yeah.

1 MS. MABLE CHARLES: -- that's what she 2 was, but um --MS. FRANCINE MERASTY: And how old was 3 4 she? 5 MS. MABLE CHARLES: 24. She had just turned 24 when she moved there. And her friend was same б 7 age. But her friend had been living there for about three 8 or four years because she went there. And she always talked a lot about Vancouver, so she got her to go with 9 10 her. And then she stayed there, she found a job and lost it maybe a month and a half. And by the time she was there 11 two months I think they parted ways. And then she became, 12 13 I think she became a street person. 14 MS. FRANCINE MERASTY: Your sister? 15 MS. MABLE CHARLES: Yeah. She never said 16 much, but she did talk about Friendship Centre she kept 17 going to over there in the city. And, um, she never found 18 another job after that. She was more of a person that 19 wanted to visit than a person that would --20 MS. FRANCINE MERASTY: Yeah. 21 MS. MABLE CHARLES: -- kind of waste time 2.2 working. She liked to visit and talk to people and stuff 23 like that. Money, she didn't care about money. And, yeah. 24 MS. FRANCINE MERASTY: So what happened to 25 her?

1 MS. MABLE CHARLES: She was, um, murdered 2 in a disco dance hall. 3 MS. FRANCINE MERASTY: Yeah. 4 MS. MABLE CHARLES: She was stabbed in the back by a guy -- I don't, I'm not even sure if that was her 5 boyfriend or what. But it was a white guy that stabbed her 6 7 in the back. He spent five years, I think, in jail. He 8 got convicted for it and sent to jail. 9 MS. FRANCINE MERASTY: In the '80s. 10 MS. MABLE CHARLES: '79. 11 MS. FRANCINE MERASTY: Oh, in '79. The 12 same year she moved there. 13 MS. MABLE CHARLES: She was only there --14 she died September 15th, '79. She was only there four 15 months -- five months, yeah. She was only there --16 MS. FRANCINE MERASTY: Oh, wow. 17 MS. MABLE CHARLES: -- yeah. 18 MS. FRANCINE MERASTY: Can you tell me 19 something about her, like, how, like, her background? 20 MS. MABLE CHARLES: Well, she grew up the 21 same as me. With didn't have no liquor at the house. My 2.2 parents didn't drink. They used to drink, I think, before, 23 but they were so scared of us getting thrown into foster 24 care or residential school, so they totally quit. And then my dad didn't even go to (inaudible) he stayed behind. 25

1	Because my mom didn't speak English, and she was scared to
2	get us taken away, so he stayed home a moment. He'd fish
3	and stuff, but he didn't go out much to do any money-making
4	things because he was too worried. And then, um - yeah. We
5	survived, but, um, she started drinking early, too. She
6	was about 13 when she started drinking.
7	MS. FRANCINE MERASTY: Yeah.
8	MS. MABLE CHARLES: And I don't know why.
9	The other kids that we hung out with weren't drinking much,
10	except the kids from residential school that come in.
11	They'd drink all summer. I think that might have been who,
12	who introduced her, and then, and then she became addicted
13	and she just she was doing good in school, she was
14	almost done high school, but she took off to (inaudible)
15	Lake, and it was almost like she was attracted to people
16	that were, like, abusive. That's who she stayed with, and
17	the ones that were good were not worth it, I guess. And
18	that's the same pattern I see, I saw in Happy. The same
19	general thing.
20	MS. FRANCINE MERASTY: How was her
21	personality?
22	MS. MABLE CHARLES: Her personality was,
23	it was the same. Like, friendly and approachable, but the
24	ones if you said to her family, boy, she'd go fighting.
25	She attacked people. A lot of people were respectful of

her, not scared of her, but they didn't want to get her mad 1 2 because she was a scrapper. MS. FRANCINE MERASTY: Yeah. 3 MS. MABLE CHARLES: Yeah. 4 5 MS. FRANCINE MERASTY: So when she had б died, did they bring her back to La Ronge? 7 MS. MABLE CHARLES: Yeah. They did, 8 actually. They sent her by, um, train, I think -- by bus. I think it was train. And exact -- that's -- my mom had 9 10 sent her money --11 MS. FRANCINE MERASTY: Um-hum. 12 MS. MABLE CHARLES: -- um, about a week, a few days before she passed away. Sent her money. And the 13 14 way they said things was, um, my mom said to tell her come 15 back in (inaudible). 16 MS. FRANCINE MERASTY: Um-hum. 17 MS. MABLE CHARLES: So I said, 18 "Yeah, my mom told you to come back in the fire truck." 19 20 I guess that's what they call the train, 21 eh? And she started laughing, and that's how her body came 2.2 back, actually. But she didn't come back alive. And they 23 didn't find the money that she had been sent. Eh? There 24 was nothing. I think she had \$15 on her. All her money 25 was gone, too.

1 MS. FRANCINE MERASTY: And what had 2 happened to her friend? Like, they weren't hanging out 3 anymore? 4 MS. MABLE CHARLES: No, they weren't 5 hanging out anymore. But when she passed away, she -- that friend came back and she brought a few friends that she had 6 7 made over there. That Eva had made over there. 8 MS. FRANCINE MERASTY: Did they have a 9 falling out or something. 10 MS. MABLE CHARLES: I'm thinking. Yeah. 11 Yeah, they did. Which is terrible to do in a city. 12 MS. FRANCINE MERASTY: Yeah. Especially 13 if you're far from home. 14 MS. MABLE CHARLES: Yeah. 15 MS. FRANCINE MERASTY: Yeah. 16 MS. MABLE CHARLES: Yeah. But she never 17 disclosed much when we'd see to her or talk to her on the 18 phone, she never said anything. She never wanted to worry 19 anybody. 20 MS. FRANCINE MERASTY: And how did your 21 family take your sister's death? 2.2 MS. MABLE CHARLES: Oh, really hard. Um, 23 my mom was really shattered. And --24 MS. FRANCINE MERASTY: Your dad? 25 MS. MABLE CHARLES: No, my sisters and I, 23 we went to the hospital. And I don't know, for some 24 reason, we must have known that it would be the last 25 Christmas we'd all spend together. So I said,

But there's too many Merry Charles, so we 4 5 switched the name to Happy Mary. This was our final Christmas, and stuff. Yeah, they were pretty similar when б 7 you think about. Even their feet were similar. I used to 8 wonder about her, and where did I see those feet before. I said, 9 10 "Oh my God. Eva had those kind of 11 feet." 12 They were kind of, like, um, kind of, like, um, cut off; but they weren't. But that's how they 13 14 looked like. And that's exactly how -- they walked the 15 same, too. 16 MS. FRANCINE MERASTY: Yeah. 17 MS. MABLE CHARLES: Yeah. 18 MS. FRANCINE MERASTY: So what 19 recommendations would you make to the national inquiry? 20 MS. MABLE CHARLES: Oh, you know what I 21 would really want for them to look into - but, maybe that's 2.2 already done - you can't get anywhere with the police, because even the RCMP said that's outside their 23 24 jurisdiction when they were asked for help. If, if there's a way our family could ask for outside agencies to come and 25
