

1 Vancouver, British Columbia 2 --- Upon commencing on Friday, April 6, 2018 3 at 9:24 a.m. MS. DARIA BOYARCHUK: Hi, my name is Daria 4 Boyarchuk, and we're here, um, on April 6th, 2018. It is 5 6 9:24 in the morning, and as a statement gatherer for the National Inquiry for the Missing and Murdered Indigenous 7 Women and Girls, I'm very honoured to have you here, 8 9 Archie, to, um, to be surrounded by you and your family. 10 Because I know, as you told me earlier, you have, you have 11 a lot to share and you have been holding it in your heart 12 for a very long time. And you have also been here to support the statement that your wife has given. And so 13 you've already experienced, you've heard many stories of 14 15 other people, but you haven't had a chance to release your 16 own emotions and to honour your sister. So right now, this 17 is your moment to, um, to share your story and before we 18 begin, I would like to ask you to sign the consent form. 19 MR. ARCHIE POOTLASS: Yes, before we 20 begin, could I, could we -- I like to request we open in 21 prayer. MS. DARIA BOYARCHUK: Okay. 22 23 MR. ARCHIE POOTLASS: It's in our, our --24 MS. DARIA BOYARCHUK: Sure.

DOROTHY POOTLASS: Creator, thank you 7 for this beautiful day, and thank you for the people that are helping us on our journey. I thank you for everything 8 9 that's going to happen here today, and I just pray that 10 you'll give Archie the strength that he needs to do his 11 statement. Thank you for the elder and the support worker 12 that's in the room with us, and our daughter Denise, and 13 the person that's taking the statement. Thank you for everybody that's here. And we pray that you'll just be 14 15 with us and lead us and guide us in everything that we do 16 from this time on. (Speaking Nuxalk). 17 MS. DARIA BOYARCHUK: Thank you, very 18 much. If it, it's okay, I would ask, I would like to ask 19 everyone to introduce yourself, and, um, would you, would 20 you like to start? 21 MS. DENISE POOTLASS: I'm Denise Pootlass 22 Wilson. I'm, um, the daughter of Archie Pootlass. 23 MS. DARIA BOYARCHUK: Thank you. 24 MS. DOROTHY POOTLASS: I'm Dorothy Pootlass, and I'm the wife of Archie Pootlass. 25

1 MR. ARCHIE POOTLASS: I'm Archie Pootlass. 2 My given name, my Nuxalk name is Osencreek (ph). It means, um, power from the sun, from deep within. That's a 3 traditional Chief's name given to me by my, my oldest 4 brother who is the head Chief of our tribe. Um, I come 5 from Bella Coola, predominantly a First Nations community, 6 in the central coast of British Columbia. Um, population 7 is about right now close to 3,000 people, and, um, about 8 1,800 of those people are Nuxalk people, my family. And 9 I'm, um, myself, personally, I'm retired. Um, I was the, 10 11 um, the elected Chief. Probably the longest be serving 12 Chief of our, of our tribe. You know, Chief for 20 years. So, and, um, I did a lot of things there to work with our -13 14 - help our people. And an example is I put a healing plan in place for us back in '90 -- '96. And prior to that I, 15 16 um, built a safe house for women and children. Built a 17 community hall. Sports and recreation activities in our 18 community. And um, I also built a, um, fairly large 19 school, where we offer our language, our culture and our 20 history. And, um, I also, um, added on to the, to the 21 school that, that we built with, um -- I put forward, developed a college where we -- joint venture with other 22 post-secondary institutions like University of B.C. and 23 24 Simon Fraser and Thompson River University. We've developed a good relationship there, and education is key 25

Statement - Public 4 Archie Pootlass (Donna Pootlass) 1 for our healing. So that's just a very quick snap shot of 2 who I am. MS. DARIA BOYARCHUK: Yeah. 3 Thank you. 4 Thank you very much. 5 MR. ARCHIE POOTLASS: Okay. 6 MS. DARIA BOYARCHUK: And could you please 7 introduce yourself? 8 MS. VERA JONES: Hi. My name is Vera Jones. I'm a resolution health support worker for the 9 Indian Residential School Survivor Society. 10 11 MS. DARIA BOYARCHUK: The Indian 12 residential school? 13 MS. VERA JONES: Survivor Society. 14 MS. DARIA BOYARCHUK: Survivor Society. 15 MS. VERA JONES: Thank you. 16 MS. DARIA BOYARCHUK: Thank you. Um, Archie, um, I would like, um, for us to go over the consent 17 18 form. 19 MR. ARCHIE POOTLASS: Yes. 20 MS. DARIA BOYARCHUK: And it is a consent 21 form, as I have mentioned earlier. 22 MR. ARCHIE POOTLASS: Um hum. MS. DARIA BOYARCHUK: That will either 23 24 authorize the inquiry to disclose your voice, your picture, 25 your image, your story, or it will not -- um, the second

1 option, for example, you may not -- the inquiry may not disclosure any information about you or your loved ones. 2 So, um, if, um, if you're comfortable at this point, if you 3 4 could, um, put your initials down here and in the box that you think is most appropriate for you, and sign the name at 5 6 the bottom. Thank you. And Dorothy, if you can, if you can sign as a witness as well. Thank you. And I can fill 7 out the rest, address and everything else. Thank you very 8 9 much. 10 MS. DOROTHY POOTLASS: Okay. 11 MS. DARIA BOYARCHUK: So, Archie, we're 12 here, and we're here to hear your story. And, um, we're here to learn and honour the story of your loved one. 13 14 MR. ARCHIE POOTLASS: All right. Okay. 15 So I'd like to thank you for, for help -- helping us with 16 this. You know, um, (inaudible) [certainly] we've, um, I 17 think we've, um -- well my sister Donna Pootlass, we've 18 been -- she's been missing since 1954, you know, and -- the 19 summer of 1954. And like it, um, she, um, when she went 20 missing, we, um -- either, I think I was about seven years 21 old then. And my dad, he -- we had -- he was married three 22 times. His first wife died of TB, and he had one child 23 with his first wife. And then, um, he was, he married 24 again and with his second wife, he had, um, six children. You know, so that's where, where Donna was, um, from the 25

1 second wife's family. So she was my half-sister. 2 MS. DARIA BOYARCHUK: Um hum. 3 MR. ARCHIE POOTLASS: But Donna had a, a, 4 um, twin brother --5 MS. DARIA BOYARCHUK: Um hum. 6 MR. ARCHIE POOTLASS: -- and his name was 7 Donald (ph), Don (ph). And he passed away, I think it was about 12 years ago. And um, and his -- my dad's third wife 8 9 was my mom, and here he had, um -- my mom and dad had ten, 10 ten children together. And when he passed away, my mom re-11 married and she had four more children. Big family. 12 MS. DARIA BOYARCHUK: Yeah. It is a big 13 family. 14 MR. ARCHIE POOTLASS: Huge family. But, 15 um, now I would like to share with my -- back in 1954 I 16 was, in summer, I was seven years old. And Donna, I 17 believe, she would have been, um, 16, 15 -- yeah, 16 years 18 old, I think. And what, what happened here was, um, I 19 could remember, um, when, um, it was determined that she 20 was missing, I think it was after a couple of days from 21 when she went missing. I don't know the exact date, but it was in the summer of '54, and (inaudible) were in the 22 23 commercial fishing season. There's a huge fleet of, um, 24 gillnetters in Bella Coola at the time. So, um, it was determined that she, that she was missing and probably 25

hadn't seen her for, for a few days and, um, my dad - who 1 was the elected, he was the hereditary Chief, the 2 traditional Chief, but he was also elected Chief counsel -3 and I remember we, um, he had us help him look for her. 4 Some of us went door-to-door and 5 6 throughout the village, and it wasn't very big at that time. So we couldn't -- nobody found her. It didn't take 7 us very long to do that, pass to see if anybody's seen her. 8 No results. So he started looking throughout the mountain 9 native communities. There's two communities there: Bella 10 11 Coola and Hagensborg. So that was about 20 kilometers 12 away. And (inaudible) from, from Bella Coola. And we -he looked around there as well. Yeah, he looked there as 13 well, and, um, we had, um -- he organized a -- the 14 15 community started looking, helping us at that point, and I 16 think he reported to the RCMP, and the RCMP did a little of 17 a search with us, but...

18 And then I remember him going to the, the 19 dock, the government dock, where all the, um, all the 20 vessels, the commercial vessels were, you know, located 21 there, eh? So I know he went boat to boat. There where --22 I remember being with my dad. I can remember walking along 23 the, um, the docs there, looking under the, the big, large 24 dock where we received passenger and freight boats from Vancouver. We looked -- I looked, I remember, with him. I, 25

there was a, a fuel station there, and I remember walking with him towards the fuel station, and I remember him and I looking under the dock and under this huge building and my, all my family was there. I remember my older brother, Darryl (ph), was there. He's the oldest one of us. (Inaudible) [There was no luck,] we couldn't find her. We looked along the docs and we looked everywhere, you know.

And, um, then we went across the inlet --8 9 he went over there, and started looking at the, there's a 10 fishing company across the bay, called Tallheo Cannery, and 11 he went there and he, he -- there was a big fishing fleet 12 there as well at the time. And he -- we had a lot of family there and he, and he went door-to-door there, again, 13 asking if they had seen. No, nobody had seen her. So we 14 15 went back to the -- probably he was there for a good half 16 day looking, looking at the grounds all around the area and that fishing camp. To me, it was a fishing camp. Canadian 17 18 Fish Company (ph).

I think, um, after we searched a little, and I could also remember us going to a freight boat that brought freight in from Vancouver. Um, so the roads weren't very good to (inaudible) [out of Bella Coola yet] and, um, they were just recently being built back in 1954, so, Bella's not -- we -- the only route out was by, by air at Bella Coola or, or by boat. And, um, there was a Road

1 there that within the -- out of Bella Coola Valley, but it wasn't a very good road. But still freight trucks didn't 2 use that, that road, yet. So only, trucks and, and, you 3 4 know vehicles. But, um, we looked in that -- we made some inquiries at the, with the freight company. I think the 5 name of that that vessel that came into Bella Coola was 6 7 called the Canadian Prince (ph). 8 MS. DARIA BOYARCHUK: Canadian what? 9 MR. ARCHIE POOTLASS: Prince (ph). I think that's what -- I remember that's one the vessels that 10 11 came in. And probably -- then probably the freight -- had 12 a freight of passengers, primarily freight, but it had a 13 few rooms for passengers leaving Bella Coola -- lower mainland. And that was the, um, the best mode of 14 15 (inaudible) [transportation] basically at the time in Bella 16 Coola. 17 And, um, he made some inquiries and he 18 talked to the, to the, um, the staff there, the captain

18 talked to the, to the, um, the staff there, the captain 19 and, um, and they, there was never a passenger named Donna. 20 And they asked if there was a possibility that she could 21 hide in that, that, that -- but, it is. (Inaudible) [It 22 is]. She could have hidden (inaudible) [that boat deck]. 23 He said, 24 "It's a two-day trip to Vancouver."

I remember, he said,

1 "No, we -- he doesn't recall."
2 He would -- they normally would get
3 reports of people, if they had a stowaway, I guess.
4 Nothing happened like that. So... anyway.

Probably a week or so the search was 5 6 called off. But people still looked for her, thinking that she might - if she drowned - that she may come to the 7 surface because you know that's what happens; she would 8 9 come to the surface, eventually. And there was a large 10 fishing fleet out there at the time, and (inaudible) [if 11 she did float to the surface, ] she drowned, there would 12 have been, um, somebody would have found her. That fleet was huge and the inlet isn't that big. So that -- he, he 13 14 came to the conclusion that she didn't drown in the inlet.

15 So, but he was pretty stressed out and 16 that. And he was helping our leader, he liked the leader 17 and he took this pretty hard. He just couldn't find her. 18 And I remember that. And I remember us, um - as a family -19 we came together, and there was a lot of tears that day, 20 especially from my, my older sister, my (inaudible) [lost] 21 older sister. She was the second oldest in our family, my 22 mom's family. She took it really hard because her and 23 Donna were pretty close, and I shared with my family that I 24 was going to make the statement today and she said to me --25 which was kind of revealed to us what Donna did. She said -

1 this is her conversation with, with my sister Lorrain (ph) 2 - she says, 3 "I'm going to leave you. I'm leaving now." 4 And Lorrain (ph), Lorrain (ph) was 12 5 6 years old at the time. 7 MS. DARIA BOYARCHUK: How old? 12? 8 MR. ARCHIE POOTLASS: Twelve, thirteen years old. Maybe 13 years old, I think. And she said, 9 10 "I'm leaving. (Inaudible) [I'm going 11 to leave you now]." 12 But Lorrain didn't understand what that was all about (inaudible) physically leave Bella Coola 13 (inaudible) [but she did]. So when it was determined that 14 15 she was missing, lost, and (inaudible) [Lorraine] took it 16 really hard, her and my dad. (Inaudible) [Bawled their 17 eyes out]. I, I remember that. And so did my older 18 brother. He was pretty close to her, too. The oldest in 19 our family. And her twin brother, her twin brother, he 20 took it really hard as well. And her biological brothers, 21 the same mother. I, I can remember the pain that was resonating in our family, you know, and, um, but I kept, I 22 kind of still visualize what her twin brother was doing. 23 24 He just couldn't believe it. She did not share with any of her biological family members what she was doing, only to 25

my sister, who was her half-sister. (Inaudible) [Told her 1 2 that she was going to] come back and (inaudible) [that she was going to get her, pick her up and] leave together. So 3 I don't recall -- I was pretty young then, too. 4 5 But I don't recall any, too much support 6 from the (inaudible) [, on the] investigation from the 7 RCMP. And I asked my older brother and my sister who, who was really close to Donna. She said, she said, she said, 8 9 um -- or, um, I asked if the RCMP helped with the search and I remember they did have a few conversations with my 10 11 dad, like, they did look, but it wasn't a very strong 12 effort, I think - in my opinion. I was pretty young then. And I asked my brother this morning if he remembers, if he 13 14 recalls the search. He said, 15 "Only what we did." 16 And I said, 17 "What about the RCMP?" 18 And he said, 19 "Well, maybe they were there, but 20 maybe." 21 But he doesn't remember (inaudible) 22 [anything] too (inaudible) was, at the time, in those years 23 there were, relationships were very poor. There was no

25 But, um, even today, we really need to work at the

relationship at all with our community, not like today.

1 relationships. So, um, we came to the conclusion 2 (inaudible) [my brother] and I, my sister, the efforts weren't really that strong from the, um, police services. 3 But we're asking you to help us with this. 4 5 If you, um, look at, research the archives see if you could find anything about their reports and share that with us. 6 Because we really need to know. Being a leader and knowing 7 how governments operate, I do know that, um, RCMP do have 8 9 records of deaths and stuff like that. Churches have 10 records, you know, but our biggest source right now is 11 Indian and Northern Affairs. So we're asking you to help 12 us there as well, because any information about Donna - if there is any information - I, I strongly believe she's 13 still here. I believe she's alive. I know that she's 14 15 here.

16 So when her brother, two brothers, passed away, she got word. She was -- our community is pretty 17 18 small, and a few people said after -- a couple of days 19 after our, our brother was buried at our cemetery, there 20 was a woman standing by his grave. So we feel that may 21 have been Donna. We didn't get the information right away. 22 As soon as I got it, I went straight there to see if the 23 vehicle, the woman was still there, and I immediately went 24 into the valley to look for that lady, because I heard that there was a lady standing over his grave, singled out only 25

his grave. So, you know, I, I feel that the only other 1 person that he would know that come to show respects to him 2 would have been his, his twin sister. We know this, our 3 4 family (inaudible) [where] this was reported to us. 5 I called a couple of friends up in a 6 neighbouring village, Algatcha (ph), to see if they know of anybody passing through that looked like my brother, like 7 her twin brother, and no one, no, nobody's seen anything. 8 That's an example that -- but we know that she's still her 9 with us. Yeah. 10 11 And when my brother, my brother -- her 12 oldest biological brother now, he was the Chief, head Chief, traditional Chief -- he, when he passed, the same 13 scenario. This time, my wife seen a vehicle in front of 14 15 our house, our house -- or a truck, a pick-up truck. It 16 went slowly past, stopped, paused in front of our place. 17 So, I mean -- she told me -- she said, "There's a vehicle, there's a vehicle 18 19 outside." 20 I thought maybe a friend from up country. 21 So I immediately went out the door and by the time I got 22 out there, the vehicle was gone, the vehicle had left. I 23 just went to get a jacket and put my shoes on, and 24 (inaudible) [it was leaving]. So I followed it, and I 25 missed it. (Inaudible). That was after my brother -- the

oldest brother, half-brother -- he passed away. That was,
 that would have been her biological brother. His name is
 Lawrence (ph). He was our Chief. But we didn't see that
 vehicle around there long. Knew, knew the valley, knew how

6 And a relative of mine, he's, um, his wife 7 is from Mount Currie, and she knew, she knows that we are looking for, for our sister. And we thought maybe Mount 8 Currie, and (inaudible) [it's known] to that. Her uncle, 9 10 his name is [Uncle 1]. He left Bella Coola, I think it was just before Donna. Everybody thought he drowned. 11 12 (Inaudible) [He drowned.] It was about, um, I think about 13 20 years ago. He's still inaudible) [He showed up, in] Mount Currie. His, um -- they contacted his daughter. Her 14 15 name is [Uncle 1's Daughter]. And some of our (inaudible) 16 [, word] back to ask if that [Uncle 1], if [Uncle 1] is 17 still alive and that he had a relationship -- that was a, 18 his, um, my dad's second wife was [Uncle 1]'s sister. So 19 [Uncle 1] was an uncle to Donna. So they had a good, they 20 had a very good relationship. He went missing shortly 21 after Donna. And it was -- we were told that Donna and 22 [Uncle 1], her uncle [Uncle 1], connected (inaudible) [with 23 each other]. And now his membership, he transferred his membership to Mount Currie. He's now with Mount Currie 24 First Nation. And the, the -- somehow his daughter 25

1 connected with him. Her name was [Uncle 1's Daughter]], 2 and they, they got together and she went to visit him, and 3 she didn't -- she (inaudible) [over]looked at Donna there. 4 He probably wouldn't have shared anything. There's confidentiality and they had that kind of relationship. 5 So, um, we believe that our sister is still alive. 6 7 And there's a few other stories that I could share, but I think, um, my, um, my mom may have had -8 9 - she may have, um, traveled to Vancouver. She may have 10 had her room paid by Donna at a hotel, (inaudible). And, 11 um, her breakfast. The story is she went to pay her 12 breakfast and this is what she shared with us, she said somebody paid about her breakfast, but there was nobody 13 there in the restaurant. Somebody paid for her breakfast. 14 15 You know, and then, um, she went to check-out and her room 16 was paid for. You know, and she said, 17 "Well, I didn't pay for my room. 18 (Inaudible) [I'm going to pay for it 19 right now]." 20 And the desk clerk told her, 21 "No, your room is paid for." 22 And she says, "(inaudible)." [No I don't -] 23 24 She says, 25 "I don't know nobody here in

Statement - Public Archie Pootlass (Donna Pootlass) 1 (inaudible) [Boston Bar]. I have no 2 friends here. I have no family here. 3 So who would have paid my room? And 4 there's nobody else traveling with 5 us." 6 So my brother said to me that it's 7 probably my sister. I believe it's my sister. 8 MS. DARIA BOYARCHUK: When did your mother 9 go to Vancouver? 10 MR. ARCHIE POOTLASS: You had -- it was 11 about 25 years ago, 20-25 years ago. She'd travel, 12 frequently travel to Vancouver. And that was the only time that she ever had her room paid for, and breakfast. She 13 never experienced that. It's the one and only time she, 14 15 she did. 16 And she has -- she stopped there a few times, and went to that same restaurant, but they did look 17 18 at the kitchen, they looked at the kitchen to see who was 19 there, after she left. After breakfast, she looked at the 20 kitchen. There's people in the background, but she, she 21 glanced, eh? She said she glanced there. Then she left 22 and she went to, she went to the kitchen -- or the 23 restaurant again to see if there was anybody there she 24 recognized. (Inaudible) [Nobody.] t[T]hey were native people there in that kitchen, but was it Donna? May have -25

- Donna may have left just briefly. So that's what she 1 2 thinks. You know, personally, my daughter in 1973, or no -- 19 --3 MS. DOROTHY POOTLASS: '89. 4 5 MR. ARCHIE POOTLASS: (Inaudible) [When 6 you went through]. 7 MS. DOROTHY POOTLASS: 1989. 8 MR. ARCHIE POOTLASS: 1989 through, 9 through -- little waitress there spoke to her, little 10 waitress. (Inaudible). 11 MS. DOROTHY POOTLASS: We were just, um, 12 going through to, um, to Mount Currie and Pemberton to go pick some pine mushrooms, and, um, and this was, um, I 13 14 think it was around the end of September or -- no, or maybe 15 beginning of October. Um, we stayed in Cache Creek the 16 night, and then we carried on with our trip, and we stopped 17 at the restaurant there. And, um, and, um, there was four 18 of us there, and I was looking at my, looking at the menu, 19 and we were going to have breakfast at the restaurant. 20 And, and then the waitress - I didn't notice - but my 21 partner at the time, he was kind of nudging me and he said, 22 "I think she's talking to you." 23 And I said, 24 "Oh." 25 But he goes, but she's calling you

And then he came back and then he -- we gave him 6 information and he went back to Chilliwack, and when we got 7 that information from him we -- he said he was going back 8 to Chilliwack, and then we told him we were going to hook 9 up with him right away, we're coming down. So we sent my 10 11 oldest brother, um - his name is Darryl - drove our oldest (inaudible) [half] brother with him, Donna's biological 12 brother, his name is Arthur (ph).
