

--- Upon commencing on Monday, October 16, 2017 2 3 MS. MARIE AUDREY GIRARD: So, this is Marie Audrey from the National Inquiry into Murdered and Missing 4 Indigenous Women. I am today with my colleague, Caitlin. 5 Can you just state your name and your position, please? 6 7 MS. CAITLIN HENDRICKSON: Hi there, this is Caitlin Hendrickson with the National Inquiry. I am the 8 9 statement gathering team lead here in Winnipeg. 10 MS. MARIE AUDREY GIRARD: And, today, we are with Dorothy and her family. I will ask you to state your 11 name, and tell us from which nation you are from, and from 12 where you are visiting us this morning. 13 14 MS. DOROTHY STARR: My name is Dorothy Starr. I am from Fort Alexander (indiscernible). And, the 15 16 reason I am here for is because my son is missing. MS. CAITLIN HENDRICKSON: Can I get you to 17 state your name, as well, please? We're just going to go 18 19 around and ensure that everybody is on the record. MS. JENNIFER GUIMOND: My name is Jennifer 20 21 Guimond. I'm here for my brother, Chris. 22 MS. CAITLIN HENDRICKSON: Thank you. 23 MS. STEPHANIE STARR: My name is Stephanie Starr. Again, I'm here for my brother, Chris. 24 25 MS. CAITLIN HENDRICKSON: Thank you. Could

you introduce yourself? 1 2 MS. LISA HARTWICK: Sure. My name is Lisa 3 Hartwick (phon). I'm here for health support for the 4 family. MS. MARIE AUDREY GIRARD: So, we are here 5 today for you to share your story. So, would you like to 6 7 tell us about the story you would like to share with us, that you would like the Commissioners to know today, 8 9 please? MS. DOROTHY STARR: Yes, I do. Okay. 10 Where do I start from? I'll talk about my son, the day he went 11 missing. 12 MS. MARIE AUDREY GIRARD: Okay. 13 MS. DOROTHY STARR: 14 That was 2015, April 7th. Okay. He always -- he always phoned wherever he was at. 15 16 When he got to work, he would phone me. When he was leaving from work, he would phone and tell me he was on his 17 way home. And, he usually talked to me until his bus came. 18 And, when he got off the bus, he would ask if I needed 19 20 anything from the store. It was always like that. So, I 21 knew something was wrong when he didn't show up on that 22 evening on the 7th of April. It's no phone call, nothing. So, it was 23 either the second or third day, finally, as I was asking 24 25 around, phoning around for him. I phoned the police. They

1 came the next day, I believe. And, I told them that I 2 haven't heard from my son. I gave them all the 3 information. And, it was that day he went out to get stuff he needed for fishing. He was supposed to leave that 4 Friday to go fishing with my brother, Chris, but he never 5 showed up. He said he was on a bus when I last talked to 6 him, on his way back to my place. And, that was the last I 7 heard of him. 8

And, from there -- well, I kept phoning the 9 10 police. Then, [Detective A] -- I can't remember her last name -- what I know is she was the one that took that case. 11 What bugs me most of all is last spring, I think it was, we 12 would meet with [Detective S]. She was the head boss for 13 the detectives, I guess. So, I went there with my youngest 14 daughter, Bobbie, and my son, Sean, and my granddaughter 15 16 was there, too, Cassidy, and the reports that she was reading, none of it was really done, what she put on the 17 report, her report. She never -- a lot of stuff she didn't 18 do that she said she did, she didn't. 19

20 And, that's what I told that [Detective S] 21 straight out. I says, "All the stuff that's written, most 22 of it is bull." And, she couldn't really look at me after 23 that. She kept looking around, looking at the other kids, 24 the kids. But, she would not -- like, I'm looking at you 25 straight, right now, and that's what I did to her. She

1 couldn't look at me.

2 And, I found out she is no longer there. 3 And, this person that's supposed to be taking over, [Detective D] -- see, I can't remember his name either. 4 But, I leave messages for him to call me. Since last 5 summer, was it, we had that meeting in Sagkeeng? 6 7 **UNIDENTIFIED SPEAKER:** Mm-hmm. MS. DOROTHY STARR: Okay. I think I heard 8 from him once or twice. 9 10 UNIDENTIFIED SPEAKER: That was this past 11 month. MS. DOROTHY STARR: And, that's about a 12 month ago I finally -- a month and a half ago, I guess, my 13 14 brother phoned me and he says -- well, he wanted my brother's phone number, Norman Guimond, that knew who was 15 16 threatening my son. I don't know if he ever called him, but about a month ago or so, he finally called my brother. 17 He was asking him for information, what kind of information 18 he can give to. And, actually, my brother got angry with 19 him, and told him, "Why don't you learn to do your job? 20 I'm just a regular person. I don't know everything. It's 21 22 your job to know what you're supposed to be looking for." So, I guess my brother is angry, too, and he 23 got angry at him, you know, wanting information from him. 24 25 He can't even go anywhere. He's in a wheelchair. But,

1	anyways, that's been going on like that. The last time I
2	heard from him was that last meeting we had in Pine Falls.
3	I think he phoned once. And, I leave numerous messages for
4	him. I don't hear from him.
5	MS. CAITLIN HENDRICKSON: Sorry, what year
6	did your son go missing?
7	MS. DOROTHY STARR: April 7 of 2015.
8	MS. MARIE AUDREY GIRARD: And, you mentioned
9	that your son was being threatened. Do you have any
10	information about that? Do you know who was threatening
11	him?
12	MS. DOROTHY STARR: Apparently, the woman he
13	was with family.
14	MS. MARIE AUDREY GIRARD: So, the family of
15	your son's girlfriend was threatening him?
16	MS. DOROTHY STARR: Yes.
17	MS. MARIE AUDREY GIRARD: And, do you know
18	if it has been on for a long time? Do you know a little
19	bit about it, what happened?
20	MS. DOROTHY STARR: No. He didn't really
21	tell me nothing. But, the strange thing was before this
22	happened, she would get a phone call, and then she would go
23	lock herself in the bathroom. And you would hear her
24	arguing with him all night long. He would tell her, "Shut
25	up, I need to sleep. I've got to go to work in the

1 morning." 2 We'd hear her picking arguments, this and 3 that. But, when the phone calls started coming in for her, she would lock herself in the bathroom and -- I don't know. 4 I don't know what she was so secretive about. Even Chris 5 would ask her, "What was that about?" "Nothing for you to 6 know", she would say. So -- but -- oh geez, I guess I'm 7 getting confused. 8 9 MS. MARIE AUDREY GIRARD: No problem. No 10 problem. MS. DOROTHY STARR: But ---11 MS. MARIE AUDREY GIRARD: Who was his 12 13 girlfriend? [Girlfriend]. 14 MS. DOROTHY STARR: MS. MARIE AUDREY GIRARD: And, do you know 15 16 who in her family was threatening him? UNIDENTIFIED SPEAKER: Her brothers. 17 MS. DOROTHY STARR: Her brothers. 18 19 UNIDENTIFIED SPEAKER: And, her dad, I think. 20 21 MS. DOROTHY STARR: Yes. 22 MS. MARIE AUDREY GIRARD: Do you know their 23 names? MS. DOROTHY STARR: I don't know the guys' 24 25 names, but I know the dad's name is [Girlfriend's Father].

1 MS. MARIE AUDREY GIRARD: And ---2 MS. DOROTHY STARR: I think the only one 3 that was decent with him there was the mom. She always stuck up from him when her old man would start saying mean 4 things to Chris. But, Chris would just walk away. 5 MS. MARIE AUDREY GIRARD: And, would you 6 7 like to give us some information about Chris? How was your son, his relationship with the family? Tell a bit about 8 him as well? 9 10 MS. CAITLIN HENDRICKSON: Maybe what are some of his strengths? What was he like growing up with 11 you, and ---12 MS. DOROTHY STARR: Well, he went back and 13 forth to me and their dad when their dad was alive. 14 He liked hunting, he liked fishing. Stuff like that he was 15 taught to do. And, he liked being in the water, doing 16 stuff in the bush, hunting, whatever. What else? 17 MS. CAITLIN HENDRICKSON: Do you have a 18 19 favourite memory of Chris? MS. DOROTHY STARR: Yes. 20 21 MS. STEPHANIE STARR: He's done a lot of 22 crazy things. MS. CAITLIN HENDRICKSON: What kind of crazy 23 things? Anything you want to share? 24 25 MS. STEPHANIE STARR: He was mostly a good

1 quy. Like, he was very helpful, loved people. He did a lot of side jobs for, you know, people that he knew. And, 2 3 he was just -- like, he'd be out there to help you. Do you know what I mean? 4 5 MS. CAITLIN HENDRICKSON: Sorry, can you just state your name? 6 7 MS. STEPHANIE STARR: Stephanie. MS. CAITLIN HENDRICKSON: Just so that the 8 9 camera knows who was speaking. 10 MS. STEPHANIE STARR: But, yeah, I miss him a lot already. 11 MS. MARIE AUDREY GIRARD: Of course. 12 MS. STEPHANIE STARR: There's a lot of 13 14 things in the past that personally, like, sibling rivalry, stuff like that. But, you know, we always kind of forgave 15 16 each other, you know, no matter how mad we would get at each other. 17 MS. MARIE AUDREY GIRARD: Mm-hmm. 18 MS. STEPHANIE STARR: The last two to three 19 years of his life, he was finally beating a severe 20 addiction he had for a long time. And, our relationship 21 22 was improving because, you know, he was cleaning himself up, bettering himself. And then all this came about. You 23 know, he's just gone. It hurts. 24 25 MS. MARIE AUDREY GIRARD: And, you were

telling about his siblings. Do you have other ---1 MS. STEPHANIE STARR: Yeah, we have others. 2 3 Yeah, there's four boys, three girls. MS. MARIE AUDREY GIRARD: And, would you 4 like to let us know a little bit about your family, about 5 your other sons and daughters? 6 7 MS. DOROTHY STARR: Oh, that's a lot to go through. 8 MS. MARIE AUDREY GIRARD: Well, I want you 9 10 to feel really comfortable. I don't want to ask questions that you don't want to answer. 11 MS. DOROTHY STARR: Actually, it's my 12 grandkids that are making it big. Okay. Chris has two 13 14 sons, one daughter, and -- okay. Jenn, she had four kids, three boys, one girl. And, she lost one when the boy was 15 16 about 12 years old. It was by hit and run. Okay. What's the next one? Stephanie has two daughters; they are 20 and 17 21. I have to think. And then Sean has one son and two 18 daughters. That's the youngest boy. And, Brad. I'm not 19 too sure about Brad. Two girls. Tim never had any. 20 21 MS. DOROTHY STARR: No, Tim didn't have any. 22 MS. STEPHANIE STARR: We lost my brother, 23 Tim, a long time ago, too. MS. DOROTHY STARR: 1993. And, that one 24 25 wanted to be a priest, I guess. He knew the Bible, so he

1 would just flip a page to what he wanted. He used that 2 book a lot on her and Sean when they started arguing. He 3 would sit down and take out his Bible. But... MS. CAITLIN HENDRICKSON: Would you like to 4 let us know what happened to Tim exactly? 5 6 MS. DOROTHY STARR: Pretty well the same 7 way, I guess, because of a female. MS. STEPHANIE STARR: It was about a woman. 8 9 It was a jealousy thing. It's a shame to lose two brothers 10 the same way. MS. CAITLIN HENDRICKSON: You mentioned 11 Chris has children? 12 13 MS. DOROTHY STARR: Yes. He has two sons, 14 and one girl. MS. CAITLIN HENDRICKSON: And, how old are 15 16 they? MS. DOROTHY STARR: [Daughter 1] just turned 17 21, I believe. And, how old are -- Chris ---18 MS. STEPHANIE STARR: I don't remember. 19 MS. DOROTHY STARR: [Son 1] is the same age 20 as Tasha. So, Tasha is 27. So, [Son 1] ---21 22 MS. STEPHANIE STARR: [Son 1] is somewhere 23 just beyond, beyond his other one. 24 MS. DOROTHY STARR: Thirty-four. 25 MS. STEPHANIE STARR: Thirty-one.

1	MS. DOROTHY STARR: Thirty-one?
2	MS. STEPHANIE STARR: They're the same age
3	(indiscernible).
4	MS. DOROTHY STARR: Shirley would be 34.
5	MS. CAITLIN HENDRICKSON: So, they were
6	already adults when he disappeared?
7	MS. STEPHANIE STARR: Yes.
8	MS. CAITLIN HENDRICKSON: And, how have they
9	dealt with it since?
10	MS. DOROTHY STARR: I don't even see the
11	kids.
12	MS. CAITLIN HENDRICKSON: Okay.
13	MS. STEPHANIE STARR: [Son 2] was living in
14	Manitoba.
15	MS. DOROTHY STARR: Or B.C.
16	MS. STEPHANIE STARR: I don't remember last
17	where he was. I just now he's back here in Manitoba.
18	MS. DOROTHY STARR: [Son 1] lives out here.
19	Last time I seen him, he already had five kids.
20	MS. MARIE AUDREY GIRARD: So, when you said
21	you had a big family, that's true. That's a big family.
22	MS. DOROTHY STARR: It's the grandchildren
23	that are making it.
24	MS. CAITLIN HENDRICKSON: So, you are a
25	great grandmother, too?

1	MS. DOROTHY STARR: Great grandmother, yes.
2	MS. CAITLIN HENDRICKSON: Any great greats?
3	MS. DOROTHY STARR: Not yet. But, my great
4	ones are just starting to grow now. My kids only had,
5	what, at most she had four. She is the one with the
6	most kids. Steph had two. Bobbie had one. Chris three
7	no, four. Sean has three. It's the grandchildren that are
8	making us old.
9	MS. CAITLIN HENDRICKSON: If we can go back
10	to Chris, how old was he when he disappeared?
11	MS. DOROTHY STARR: Forty-eight.
12	MS. CAITLIN HENDRICKSON: Forty-eight?
13	Okay. And, there was some mention of struggling with
14	addiction. How long did that go on for?
15	MS. DOROTHY STARR: Oh, geez, he was quite
16	young when he got involved in it. But, he cleaned himself
17	up. It's about three years?
18	MS. STEPHANIE STARR: About three years
19	before he went missing. He was turning his life around.
20	He was just making so much improvements.
21	MS. CAITLIN HENDRICKSON: And, how did he
22	what was he doing that was helping to address that for him?
23	MS. DOROTHY STARR: He spent more time with
24	the family.
25	MS. STEPHANIE STARR: Getting more jobs,

1 like I said, working for people (indiscernible), and doing side jobs for people. He would be busy with that stuff. 2 3 He would go to church. He was doing a lot of things to better himself. 4 MS. MARIE AUDREY GIRARD: And, you 5 mentioned, Dorothy, that Chris was threatened by his in-6 7 laws. Are you aware of any history of violence between Chris and the family, or if ---8 MS. DOROTHY STARR: 9 No. 10 MS. STEPHANIE STARR: Not officially. Like, we never really witnessed anything, but there is someone 11 else I know of, she knows that family as well. She says 12 13 they are not good people. They are people that will do 14 things. She says they're just not good to be around. They're bad people, just don't want to be involved with. 15 16 MS. CAITLIN HENDRICKSON: Where did they live? 17 MS. STEPHANIE STARR: Here in the city. 18 19 MS. CAITLIN HENDRICKSON: They lived in Winnipeg? So, they were living together? 20 MS. STEPHANIE STARR: Apparently, oh yeah, 21 22 with her dad or something. 23 MS. CAITLIN HENDRICKSON: Oh, okay. MS. MARIE AUDREY GIRARD: And, after Chris 24 25 went missing, I was wondering if you received any support

1 with the police. You told us that the police was not --2 you didn't have all the information. But, did you have any 3 other support? MS. DOROTHY STARR: Just the family. 4 MS. STEPHANIE STARR: We -- the police did 5 say they searched and whatnot, but a lot of times that we 6 7 were out, Jenn did more searching, I think, than any of us, but never saw nothing go on about -- never heard nothing 8 about them actually doing anything. There were no -- there 9 10 was no actual physical evidence of seeing anything that they were doing. And, it was us that were searching. 11 MS. DOROTHY STARR: There was no search, 12 there was no dogs, there was no reports on anything 13 14 (indiscernible). Where would they have an idea to go look, they never went and looked. 15 MS. CAITLIN HENDRICKSON: And, was there any 16 history of violence between himself and his girlfriend, 17 like specifically partner violence? 18 MS. DOROTHY STARR: Well, there was one time 19 I went -- well, Chris says, "Mom", he says, "I'm going to 20 21 go play Bingo." So, we went to Bingo. And then we were 22 waiting for a bus, and I don't know what was going on, she was hitting him. "Ouch", he says, "Leave me alone." And 23 then she -- oh, okay. I remember what she was mad about. 24 25 Tylenol 3s.

1	MS. STEPHANIE STARR: She wanted pills?
2	MS. DOROTHY STARR: She wanted pills, but
3	Chris wouldn't buy them for her. So, she started getting
4	mad at him and hitting him.
5	MS. CAITLIN HENDRICKSON: So, how long were
6	they together before he disappeared?
7	MS. DOROTHY STARR: Oh, geez, maybe a year
8	and a half.
9	MS. JENNIFER GUIMOND: Well, she was
10	supposed to have been the one to help him get out of his
11	addiction. That's what I heard anyways. I don't know.
12	MS. DOROTHY STARR: Yes. But, it was
13	actually I mean, he was trying to stop her from taking
14	those pills. You know how skinny she was.
15	MS. CAITLIN HENDRICKSON: Go ahead.
16	MS. DOROTHY STARR: No, just yes, she was
17	addicted to those pills.
18	MS. MARIE AUDREY GIRARD: If you let me go
19	back, just a little bit back, you were talking about Chris'
20	father. You said at that time, earlier, the father wasn't
21	there. Can you tell us a little bit about the family and
22	the dynamic of the family as well? Just for us to know
23	have a good idea of who is who, and what Chris is doing, to
24	have, like, a complete perspective?
25	MS. DOROTHY STARR: Okay. Well, he was

1	close to his dad. And, especially Chris and Jenn, they
2	were close to him. And, the other ones, they were small
3	when we separated. So, it's the two older ones that were
4	close to their dad, and they would go spend time with their
5	dad, too. And I believe that's why when he turned 18, 17
6	to 18
7	MS. JENNIFER GUIMOND: Well, I was
8	(indiscernible). But, anyways, yeah, we stayed with Dad
9	back on and, Chris always did the hunting, the fishing
10	with them, and my uncle Clifford. He would always go with
11	them. Just about 14 was when Chris stayed more in the city
12	after that. Yeah.
13	MS. CAITLIN HENDRICKSON: Sorry, can I
14	clarify, when did you separate from their father?
15	MS. DOROTHY STARR: 1975.
16	MS. CAITLIN HENDRICKSON: Okay. And, where
17	did you live?
18	MS. DOROTHY STARR: I moved into the city.
19	MS. CAITLIN HENDRICKSON: So, you lived in
20	Winnipeg?
21	MS. DOROTHY STARR: Yes.
22	MS. CAITLIN HENDRICKSON: And, where did he
23	live?
24	MS. DOROTHY STARR: In Sagkeeng.
25	MS. CAITLIN HENDRICKSON: Okay.

1	MS. DOROTHY STARR: The dad.
2	MS. CAITLIN HENDRICKSON: Just to understand
3	where the kids were when you were apart.
4	MS. DOROTHY STARR: Oh no, the kids were all
5	with me, but the dad stayed behind. Well, we separated.
6	MS. CAITLIN HENDRICKSON: Do you mind if I
7	ask why you separated?
8	MS. DOROTHY STARR: There was quite a bit of
9	violence going on, alcohol.
10	MS. CAITLIN HENDRICKSON: So, there is some
11	history of your children witnessing that?
12	MS. DOROTHY STARR: Well, especially the
13	two, yeah.
14	MS. CAITLIN HENDRICKSON: Thank you. Did
15	you have any support around that, when you separated?
16	MS. DOROTHY STARR: Not really, just always
17	family members.
18	MS. CAITLIN HENDRICKSON: Yeah. It's got to
19	be difficult moving into a city and
20	MS. DOROTHY STARR: Yeah, but I had my
21	sister-in-law living out here. There's two of them. So,
22	the younger one, Margaret, was the one that helped me get
23	settled in.
24	MS. MARIE AUDREY GIRARD: And, do you think
25	well, I will just go maybe a little bit away from that

1 topic. I would like to know, like, in the perfect world, when Chris disappeared, how you would have liked the police 2 3 and the support to be? What would have been the best scenario that you have? Remember, we talked a little bit 4 about the investigation? 5 6 MS. DOROTHY STARR: Oh yes. 7 MS. MARIE AUDREY GIRARD: I would like to go a little bit more details about that. Like, what would 8 have been the perfect, for you, perfect situation, and how 9 10 would you answer that? MS. CAITLIN HENDRICKSON: And, what would 11 have been helpful? 12 MS. MARIE AUDREY GIRARD: What would have 13 14 been helpful for you? What kind of support? MS. DOROTHY STARR: Like I say, if they 15 16 would have done what they are supposed to do. But, I know for a fact they didn't know what she said they did. 17 18 MS. JENNIFER GUIMOND: Meaning the search 19 party. Searching. He was ---20 MS. DOROTHY STARR: 21 MS. JENNIFER GUIMOND: (Indiscernible). 22 And, going to the areas where you suggested that he was last. 23 24 MS. DOROTHY STARR: Yes. 25 MS. JENNIFER GUIMOND: Because, we were in

1 the whole area, there was five of us on a search, on a group. We never seen anybody in those areas to help us. 2 3 Because we had the Bear Clan help us, too. We got them involved. Just for a while though, eh? 4 MS. DOROTHY STARR: Yes. 5 MS. MARIE AUDREY GIRARD: So, how long were 6 7 you searching on yourself? MS. JENNIFER GUIMOND: Yes. We did it from 8 9 April to snowfall, eh? 10 MS. STEPHANIE STARR: Yes. MS. JENNIFER GUIMOND: April to snowfall. 11 And, we went right along the whole Red River, on each side. 12 We went in different areas, such as, like, Pembina Highway. 13 14 Like, in the last areas where he said he was, we went and searched the train tracks. We even went on the perimeters 15 16 of the city. And, you know, how if somebody did do something, they may have just dumped him somewhere. So, we 17 went along all of the perimeters, most of the perimeter. 18 And, we did that all summer. 19 MS. STEPHANIE STARR: And, we never found 20 21 nothing. 22 MS. JENNIFER GUIMOND: We never found 23 nothing. MS. MARIE AUDREY GIRARD: You never received 24 25 information or any leads that could tell you what happened?

1 MS. DOROTHY STARR: No. 2 MS. JENNIFER GUIMOND: Even when we did find 3 something odd, we tried to report it to that detective, 4 [Detective A], but she wouldn't respond to anything. She wouldn't take it down seriously. Because, actually, there 5 was one time I was taking -- we were doing a search from 6 the Red River Bridge, the Louise Bridge, from bridge to 7 bridge. We stopped one night at this area, then we start 8 9 there in the morning. 10 The next morning, we started at that point, but we didn't go under the bridge. When we last looked it 11 was clear, but the next morning, we came back, there was 12 13 blood splattered, and there was car tracks. There was, like, an evidence of something that went on there the night 14 we left. And, we tried to report it to the detective the 15 next day, but she says, "Oh, that's just rust leaking from 16 the bridge." 17 MS. DOROTHY STARR: And, there was no rust. 18 19 MS. JENNIFER GUIMOND: There was no rust, and that thing looked like whatever was bleeding was 20 21 dragged down to the river. Like ---22 MS. STEPHANIE STARR: A trail. MS. JENNIFER GUIMOND: A trail of blood. 23 And, there was rain that night, but that's under the 24 25 bridge, so it didn't get washed away. And, she was trying

1	to say that was blood you know how blood coagulates? It
2	was starting to look like that, but she was saying it was
3	rust from the bridge. But, that bridge didn't have rust.
4	It was a painted bridge.
5	So, we just left it at that. She wouldn't
6	take note of it or nothing. So, we went along our way, and
7	just did our search again, and we searched for another two
8	kilometres that way. But, things like that, we tried to
9	let her know about. And, she wouldn't she would just
10	brush it aside, and just that was it.
11	MS. MARIE AUDREY GIRARD: So, you have the
12	impression that many things you told the police you didn't
13	get taken seriously?
14	MS. JENNIFER GUIMOND: They didn't take it
15	seriously.
16	MS. MARIE AUDREY GIRARD: They didn't really
17	investigate that?
18	MS. JENNIFER GUIMOND: No.
19	MS. CAITLIN HENDRICKSON: How did his
20	girlfriend respond to his disappearance?
21	MS. STEPHANIE STARR: She was very shady
22	about it.
23	MS. DOROTHY STARR: Yeah.
24	MS. STEPHANIE STARR: The night he didn't
25	come home, the next day she went to her parents, or

1 something like that? 2 MS. DOROTHY STARR: No, she took off. That 3 morning ---MS. STEPHANIE STARR: That morning. 4 MS. DOROTHY STARR: --- Chris was doing 5 laundry and then, "Why is [Girlfriend] still in bed?" "Go 6 get her up", he says. "I tried to wake her up", he says, 7 "she didn't want to get up." So, I went in her room, all 8 of her stuff was gone; she was gone. She took whatever she 9 10 could take, I guess. And, Chris looked surprised. "What a little shit", he says, "What's going on?" I said, "I don't 11 know. I didn't even see her leave. I thought she was 12 still sleeping." "Oh well", he says, "Let her go to her 13 14 dad, maybe she misses her dad or something." And so, around 12:00 that day he says, "Mom, 15 can you finish doing the laundry?" I said, "Okay." I was 16 going to go with him. He says he wanted my grandson to go 17 with him, but he didn't want to go. So, I said, "I'll go 18 with you." "No", he says, "that's okay. But, you can 19 finish my laundry." So, that's what I did. And, that was 20 the last time. That was the last time. 21 22 MS. STEPHANIE STARR: But, how she acted the day after he went missing, she called my mom asking her to 23 help ---24 25 MS. DOROTHY STARR: Yeah.

1	MS. STEPHANIE STARR: [Girlfriend] was
2	asking my mom to help [Girlfriend] move Chris' electronics,
3	his movies, anything that was worth money like that, she
4	wanted over at her parents' place. And, she was asking my
5	mom to help her do it. Why would she do something like
6	that if
7	MS. DOROTHY STARR: And, she didn't even ask
8	for his clothing, nothing. Just all the electronics.
9	MS. STEPHANIE STARR: Just the electronics
10	and, you know, like, something you'd probably be able to
11	just sell on the street or something. She was, like I
12	don't know what the word is I'm looking for.
13	MS. CAITLIN HENDRICKSON: So, what you're
14	saying is, the morning before he disappeared, she had moved
15	her things out?
16	MS. DOROTHY STARR: No, that she moved
17	her stuff out the morning that Chris went missing.
18	MS. CAITLIN HENDRICKSON: Okay.
19	MS. STEPHANIE STARR: It was that evening he
20	didn't come home.
21	MS. CAITLIN HENDRICKSON: Okay.
22	MS. STEPHANIE STARR: Right? But, it was
23	like after he went missing, it was a day or so after he
24	was
25	MS. DOROTHY STARR: About two yeah,

1 two/three days later.

2 MS. STEPHANIE STARR: Yeah. She called 3 requesting my mom for his stuff. MS. MARIE AUDREY GIRARD: Okay. So, you 4 have a feeling that there is known information that the 5 6 police hasn't been able to access. You think that people 7 know stuff ---MS. STEPHANIE STARR: Yes. 8 MS. MARIE AUDREY GIRARD: --- that police 9 10 never really investigate into? MS. STEPHANIE STARR: Yeah, exactly, because 11 my mom or family members would find out little clues here 12 and there, or hear something, and then would say, "Well, 13 14 this is what we heard"; you know? She would call, leave messages, to kind of give direction, like, "This is what 15 16 I'm hearing." But, she never was taken seriously. Like, calls were never really being returned. Stuff like that. 17 So, I mean, how can we help, when we're trying to help, but 18 they're not really doing -- we feel like they're not 19 20 doing... 21 MS. MARIE AUDREY GIRARD: Why do you think, 22 in your opinion, they're not taking this seriously? MS. JENNIFER GUIMOND: Because he's Native. 23 24 MS. DOROTHY STARR: Yeah. Exactly. 25 MS. STEPHANIE STARR: That's the biggest

1 reason, we believe, why this case was just kind of just 2 shoved aside and not taken seriously about it. 3 MS. MARIE AUDREY GIRARD: And, do you know 4 if [Girlfriend] and [Girlfriend]'s family have been investigated, and have been cooperating with the 5 investigation? 6 7 MS. DOROTHY STARR: Well, [Detective A] said that she did. But, she says all [Girlfriend] did on 8 9 camera, she said all she did was crying and crying. And, I 10 even asked [Detective D], the one that took over that case, supposedly, I asked, when I talked to him, "Have you talked 11 to those people?" "Oh, they had nothing to do with it. We 12 13 talked to her. We talked to the family. Good, nice 14 family", he says. Little does he know. MS. CAITLIN HENDRICKSON: I'm just 15 16 wondering, can you tell me what police force were you dealing with? 17 MS. DOROTHY STARR: The police, Winnipeg 18 19 Police. MS. CAITLIN HENDRICKSON: Winnipeg Police? 20 21 MS. DOROTHY STARR: Yes. 22 MS. MARIE AUDREY GIRARD: Would you like to 23 take the break while they are gone? **UNIDENTIFIED SPEAKER:** She's gone to check 24 25 the parking.

We made a whole bunch of ---MS. MARIE AUDREY GIRARD: Sorry, we just put 11 the recorder off. So, I don't know if you want to just 12 13 wait for your sister to be back and tell it? MS. JENNIFER GUIMOND: Okay. We'll wait for 14 her to get back. 15 MS. MARIE AUDREY GIRARD: And, if you want 16 to take a small break. If you're hungry, would you like 17 something to eat? 18 19 MS. JENNIFER GUIMOND: Where are you allowed 20 to smoke? --- Upon recessing at 10:57 21 22 --- Upon resuming at 11:22 MS. MARIE AUDREY GIRARD: So, this is Marie 23 Audrey with Dorothy, Jenn, Stephanie, and Lisa, and 24 25 Caitlin. It is 11:22, and we are continuing this

2 So, thank you for being back with us. I 3 will maybe have a few questions for you personally. Can you tell me more a little bit about yourself, about how was 4 your youth, and about your family a little bit? Just for 5 us to know a little bit about you and your path. 6 7 MS. DOROTHY STARR: I don't have a pet. MS. MARIE AUDREY GIRARD: Path. Sorry, my 8 9 -- this is my big accent; sorry. Sorry for that. 10 MS. CAITLIN HENDRICKSON: Also, one thing that we forgot to mention with the tissues here, if you are 11 sharing any emotion, it is absolutely welcome here. If you 12 13 use a tissue to dry your tears, we are collecting them in 14 these paper bags, and from there, we're taking those tears to the fire to release them in there. Just so you know. 15 16 We forgot to go over that earlier. So, anyway, back to what Marie was asking. 17 18 MS. DOROTHY STARR: Okay. About myself? 19 MS. MARIE AUDREY GIRARD: Mm-hmm. And, your early life. 20 MS. DOROTHY STARR: My early life? I was 21 22 raised by my grandmother. Is that the part you're talking about? 23 MS. MARIE AUDREY GIRARD: Yes. 24 25 MS. DOROTHY STARR: Okay. I was raised by

1	my grandmother. Actually, I wasn't the only one. There
2	was other siblings or grandkids. Because our moms
3	passed away. Mine passed away when I was six months old,
4	and my brother was two. It was me and Louis on my mother's

6	And, okay, where do we go from there? Well,
7	we went to school. Me and (indiscernible) walked to school
8	every day. But, my grandmother pulled me out when I was in
9	grade four. She said she did not want to raise another
10	lazy one in the family.
11	MS. CAITLIN HENDRICKSON: Did anyone in your
12	family attend residential school?
13	MS. DOROTHY STARR: I don't think so. Not
14	that I know of.
15	MS. CAITLIN HENDRICKSON: Okay. Can I ask
16	you, do you know anything about the circumstances around
17	your mother's passing?
18	MS. DOROTHY STARR: As far as I know, I
19	guess she had TB. That's all I know.
20	MS. CAITLIN HENDRICKSON: Oh, okay. So, you
21	left school in fourth grade, and then your grandmother
22	raised you?
23	MS. DOROTHY STARR: Well, she, as I say,
24	pulled me out of school because she didn't want another one
25	like my sister. Well, we called each other brother and

1 sister, because we were all raised by the grandma. 2 MS. MARIE AUDREY GIRARD: So, how old were 3 you, sorry, for grade -- what? Nine or ten? 4 MS. DOROTHY STARR: Around there, I quess, 5 ten. MS. CAITLIN HENDRICKSON: And, where did you 6 7 grow up? 8 MS. DOROTHY STARR: In Sagkeeng, on a 9 reserve. 10 MS. MARIE AUDREY GIRARD: And, what were you doing after your grandmother pulled you out of school? 11 Like, what was a normal day for you? 12 MS. DOROTHY STARR: Well, I mean, I quess it 13 was a normal thing, learning to clean house, how to clean, 14 how to work in the bush, because we used to -- me and my 15 16 grandmother used to cut wood to sell. And, hunting. MS. CAITLIN HENDRICKSON: So, very 17 traditional. 18 19 MS. DOROTHY STARR: Yes. It was mostly partridges and rabbits we were hunting for. The males hunt 20 for the bigger stuff. And, we basically grew up on 21 vegetables, wild meat, stuff like that. That was always 22 23 good. MS. MARIE AUDREY GIRARD: Are you still 24 25 eating the same thing today?

1 MS. DOROTHY STARR: I wish I could. If I 2 have the chance, yes, I do. MS. CAITLIN HENDRICKSON: It's always nice 3 to have those traditional foods; right? 4 MS. DOROTHY STARR: Yes. That's ---5 MS. CAITLIN HENDRICKSON: That's the nice 6 thing about the meals here, is that they're very specific 7 about making sure that they're traditional meals. In 8 Smithers, we had moose and all sorts of other things. 9 They 10 were so good. So, I'm hoping that's on the menu. MS. STEPHANIE STARR: Deer is good, too. 11 MS. DOROTHY STARR: But, other than that, my 12 grandmother was guite strict. If you did something wrong, 13 14 you couldn't go anywhere, couldn't hunt. But, it was always my brother that used to sneak me out. 15 16 MS. CAITLIN HENDRICKSON: There's always one 17 in the family. MS. DOROTHY STARR: Yes. And, he would lie 18 for me, too. But, he would pay for it. He would get home 19 6:00 in the morning, and try and sneak in, or sleep in the 20 vehicle. Bang, "Get up, you're not sleeping. Go and do 21 your chores." And, yet, we never learned. When the 22 evening came along, (indiscernible). "I just want to go 23 get my car fixed. I have something to be fixed." 24 25 MS. MARIE AUDREY GIRARD: And, until what

age are you living with your grandmother? 1 2 MS. DOROTHY STARR: Eighteen. 3 MS. MARIE AUDREY GIRARD: Eighteen? Okay. 4 Can you tell us more about what happened after you turned 18, and you were not living with your grandmother anymore? 5 MS. DOROTHY STARR: I got married. 6 7 MS. STEPHANIE STARR: To our dad. MS. DOROTHY STARR: But, I pretty well 8 9 stayed at his mom's or at my grandma's until we built our 10 own little log house. 11 MS. CAITLIN HENDRICKSON: How long were you married before you separated? 12 13 MS. DOROTHY STARR: Eleven years. MS. CAITLIN HENDRICKSON: And, you know, you 14 talked about some tough things about your relationship that 15 16 led to your separation. And, I know it would be hard to talk a little bit more in detail, but it is information 17 that would be important for the Commission to know, because 18 19 one of the things that we're looking for are patterns. You know, we are looking at intergenerational trauma and 20 violence. And so, if you could give us some more details 21 22 around the facts that led to your separation from your husband? 23 MS. DOROTHY STARR: Well, I used to drink, 24

too. And, just before I turned 21, he got me to go into

1	the bar, and he knew the people. So, I started drinking,
2	too. But then after a while, all we did was fight, argue,
3	physical fighting. And, that's where I decided, okay as
4	soon as he started picking on the kids, that's where I draw
5	the line.
6	MS. CAITLIN HENDRICKSON: So, was Chris
7	subjected to physical violence from your husband?
8	MS. DOROTHY STARR: Well, my dad would
9	babysit the kids at my grandma's. So, they didn't really
10	see that. They heard us argue, but physical fighting, I
11	don't think they seen it.
12	MS. CAITLIN HENDRICKSON: Okay. I was just
13	asking if your husband had ever been violent with Chris or
14	any of the other kids?
15	MS. DOROTHY STARR: Well, in a way, I guess,
16	yeah. That was his way of disciplining, I guess.
17	MS. MARIE AUDREY GIRARD: Okay. Thank you
18	for sharing. We are aware this is not easy information to
19	share. So, are you still after your separation 11 years
20	after, were you still in contact with him when you came to
21	the city?
22	MS. STEPHANIE STARR: It was just for us.
23	MS. DOROTHY STARR: Because I wasn't going
24	to hold the kids against him. And, the kids had their own
25	rights to where they want to be. I tried to be fair that

1 way.

MS. MARIE AUDREY GIRARD: So, if I 2 3 understand well, when you separated, and sorry if I misunderstood, you came to the city, and then the children 4 decided if they wanted to stay with you or with their 5 father? 6 7 MS. DOROTHY STARR: Well, they would go visit their dad. 8 9 MS. STEPHANIE STARR: Summer holidays. 10 MS. DOROTHY STARR: Yeah. Because through the school years, they can't leave the school. 11 MS. MARIE AUDREY GIRARD: So, they would be 12 13 staying with you and ---14 MS. DOROTHY STARR: Yeah, but when summer holidays came along, that's where they would be. 15 16 MS. MARIE AUDREY GIRARD: I see. I see. Okay. I understand. And, do you have any other questions 17 about this? 18 MS. CAITLIN HENDRICKSON: No, I don't think 19 20 so. 21 MS. MARIE AUDREY GIRARD: So, thank you for 22 sharing about your personal experience. I will maybe go back to Chris. 23 24 MS. DOROTHY STARR: Okay. 25 MS. MARIE AUDREY GIRARD: To know a little

1 bit about -- a little bit more about him, because I think that's why we are here today, as well. 2 3 MS. DOROTHY STARR: Yes. MS. MARIE AUDREY GIRARD: So, I know you 4 described him a little bit, but I would like to know maybe 5 a few things before he went missing, if you have any 6 7 memories that you would like to share with us, and to tell us what happened a little bit, a little bit more in detail. 8 I know, for instance, that [Girlfriend] moved the day after 9 10 that Chris went missing, but ---MS. DOROTHY STARR: No, she moved -- she 11 left -- took off that morning, the day Chris went missing. 12 MS. MARIE AUDREY GIRARD: Yes. Uh-huh. So, 13 14 if you have, like, to tell us, like, a little bit about Chris the day before he went missing, what he was doing, if 15 16 you think that anything was abnormal, apart from what you 17 already told us. MS. DOROTHY STARR: Everything was normal 18 19 with him. He was happy to leave to go fishing. We always We played Crib. 20 played cards. 21 MS. MARIE AUDREY GIRARD: And, were his 22 children living with him at the moment? 23 MS. DOROTHY STARR: No. MS. MARIE AUDREY GIRARD: They were adults; 24 25 right?

1	MS. DOROTHY STARR: Yes.
2	MS. MARIE AUDREY GIRARD: So, when they were
3	younger, were the children living with Chris?
4	MS. DOROTHY STARR: No.
5	MS. MARIE AUDREY GIRARD: No, they were
6	living with their mother?
7	MS. DOROTHY STARR: Or foster homes, yeah.
8	MS. MARIE AUDREY GIRARD: Okay. So, they
9	have been all the three of them have been in foster
10	family?
11	MS. DOROTHY STARR: Chris' oldest daughter,
12	she was brought up by her
13	UNIDENTIFIED SPEAKER: Foster mom? Foster
14	mom, I guess.
15	MS. DOROTHY STARR: Yeah, I guess.
16	MS. STEPHANIE STARR: [Son 2] is living with
17	his mom's mom, the grandma. And then now the youngest -
18	[Daughter 2] is the oldest or, is she younger?
19	MS. JENNIFER GUIMOND: No, [Daughter 2] is
20	the youngest.
21	MS. STEPHANIE STARR: She's been in care
22	since she was
23	MS. JENNIFER GUIMOND: yeah, under CFS
24	care, and stuff like that. And, little [Son 1], he was
25	with his mom.

1	MS. STEPHANIE STARR: Yeah, he was with his
2	mom, but maybe he's one of the five kids, maybe seven now.
3	MS. CAITLIN HENDRICKSON: Did you have any
4	connection to them, even though they were not with Chris?
5	MS. DOROTHY STARR: No, just [Son 1] I
6	would run into him sometimes when I would go down to
7	MS. STEPHANIE STARR: [Son 1] she is talking
8	about.
9	MS. CAITLIN HENDRICKSON: Okay. Thanks.
10	MS. DOROTHY STARR: At that Giant Tiger on
11	Ellis, I believe it is.
12	MS. CAITLIN HENDRICKSON: So, right around
13	the corner?
14	MS. DOROTHY STARR: Yeah, that's the right
15	one. I usually meet up with him there. Last time I seen
16	him, he gave me his phone number, and I dropped that phone
17	number somewhere. So, I've got to go back there, if I run
18	into him, especially on child tax day or I can't even
19	remember when (indiscernible).
20	MS. MARIE AUDREY GIRARD: So, if I
21	understand well, [Son 1] wasn't with the mother for he
22	got separated from the mother early? So, he wasn't with
23	the mother for many years?
24	MS. DOROTHY STARR: No.
25	MS. MARIE AUDREY GIRARD: Okay.

1	MS. CAITLIN HENDRICKSON: Do they all have
2	the same mother?
3	MS. DOROTHY STARR: No.
4	MS. STEPHANIE STARR: No.
5	MS. JENNIFER GUIMOND: All different moms.
6	MS. CAITLIN HENDRICKSON: Okay. Do you know
7	anything about his relationships with them?
8	MS. JENNIFER GUIMOND: [Son 2]'s mother,
9	Cheryl, she was my best friend at the time because,
10	actually, I was the one that brought them together. Yeah,
11	well, she was my best friend. She did everything with me,
12	anything. And, I helped with Chris' son, [Son 2], the
13	first few years, two/three years. And, I was only 15 and
14	16 myself when I was helping her. Even when I was 13 and
15	stuff, I'd help her as much as I could.
16	MS. CAITLIN HENDRICKSON: So, she was really
17	young when [Son 2] was born?
18	MS. JENNIFER GUIMOND: Well, before she even
19	got pregnant with Chris' child we were friends, so, yeah.
20	But, I never got, like, close to the other women that he
21	had kids with. No, just Cheryl.
22	MS. MARIE AUDREY GIRARD: And, you were
23	saying that [Son 2] live with his grandmother?
24	MS. JENNIFER GUIMOND: Yeah, now. Yeah. It
25	was a decision that the mom had made, because she was no

INTERNATIONAL REPORTING INC.

1	longer with Chris at the time. And, I guess, she felt
2	she might have felt it was a bit much for her, still, so
3	she asked her mom to take over. And, she had him since.
4	Now, he's got his own girlfriend, and I think they're
5	having a baby. But, we don't have much contact with him.
6	Like, we tried, but I think I don't know why he doesn't
7	want to, but that's just there is no connection anymore.
8	MS. CAITLIN HENDRICKSON: And, how did Chris
9	feel about his children, and not really being able to be a
10	parent to them?
11	MS. JENNIFER GUIMOND: Guaranteed, you know,
12	he'd miss them and stuff like that but in a sense, in a way
13	he knew they should be where they were at, I think.
14	MS. CAITLIN HENDRICKSON: He understood his
15	limitations.
16	MS. JENNIFER GUIMOND: I think so.
17	MS. CAITLIN HENDRICKSON: And, during this
18	time, was he struggling with his addictions?
19	MS. JENNIFER GUIMOND: That was one of the
20	times, yes.
21	MS. MARIE AUDREY GIRARD: So, if I
22	understand well, before he went missing, he wasn't in
23	contact with his children at that time?
24	MS. STEPHANIE STARR: Well, he well,
25	[Daughter 3] once in a while. Yeah, [Daughter 3]. [Son 2]

is -- as we mentioned, there should be, but -- the other 1 ones, [Son 1] and [Daughter 1], I'm not too aware of that, 2 3 if there has been any contact. MS. DOROTHY STARR: And, even I tried to 4 contact Child and Family in Sagkeeng ---5 MS. STEPHANIE STARR: To get a hold of her, 6 7 like ---MS. DOROTHY STARR: Yeah, to get a hold of 8 9 [Daughter 1]. 10 MS. STEPHANIE STARR: But, there was no help 11 from them on that part. MS. CAITLIN HENDRICKSON: They don't want to 12 give you contact information? And, they wouldn't contact 13 14 them to say that you were looking for -- okay. That's really too bad. 15 16 MS. JENNIFER GUIMOND: Yeah, it is. MS. DOROTHY STARR: Even Jerome was looking 17 through Internet, looking for her. 18 19 MS. STEPHANIE STARR: On Facebook and stuff, 20 yeah. 21 MS. DOROTHY STARR: But, there's nothing. 22 MS. MARIE AUDREY GIRARD: And, how old is 23 [Daughter 1], 17? MS. JENNIFER GUIMOND: She's 21. 24 25 MS. MARIE AUDREY GIRARD: Twenty-one, sorry.

1 MS. DOROTHY STARR: She's the same age as Marsh, eh? 2 MS. JENNIFER GUIMOND: Yeah. And, she's 3 4 only months older than Paige. MS. MARIE AUDREY GIRARD: So, when was the 5 last time you could see [Daughter 1]? When was the last 6 7 contact with [Daughter 1]? 8 MS. DOROTHY STARR: Oh jeez, when she was 9 about ---10 MS. JENNIFER GUIMOND: Four? DOROTHY STARR: Five. 11 MS. JENNIFER GUIMOND: Four to five, yeah. 12 MS. DOROTHY STARR: Because she came over 13 14 there, back home, for Halloween that one weekend, I remember. She was just small. 15 16 MS. CAITLIN HENDRICKSON: So, as part of our truth-finding protocol with the Inquiry, part of what the 17 Commissioners can do is they can request records to see if 18 19 there is anything further that needs to be looked into. 20 So, just around the police investigation when you said that you were dealing with Winnipeg Police, is that something 21 22 that you feel that we should be looking into, is looking at 23 those police reports, and seeing how they conducted their investigation? 24 25 MS. JENNIFER GUIMOND: Definitely.

And so, they will take a look at 8 9 that, and as part of our forensic review team, they can --10 I don't know if it will get referred to them, but it will definitely -- it is definitely something they can request. 11 MS. MARIE AUDREY GIRARD: And, do you think, 13 14 in your opinion, is there any other people in your family that would like to give their statement in relation to what 15 16 happened to Chris? Someone that would be willing to talk here, share their truth with us? 17 18 MS. STEPHANIE STARR: Meaning? 19 MS. MARIE AUDREY GIRARD: Somebody else in 20 you family, or around Chris' disappearance? 21 MS. CAITLIN HENDRICKSON: Anybody that knew 22 him, friends ---Oh, he had friends. 23 MS. STEPHANIE STARR: All those friends don't say nothing, though. We know words 24 25 are -- you know, things are being said, but nobody is

So, we took a picture of him, and then she made at least
500 copies of these pictures of him.

To Portage and Main, to Mountain and Main, that strip, all the way down on those light poles, we put all those posters up. We went down Burrows, Alfred, like, all the streets coming back. And, we go up to (indiscernible), going up and down.

Like, is it somebody who couldn't stand to see Chris' face up there, 8 you know? And, we tried to talk to that detective about 9 10 those posters. We figured maybe we could strike a nerve, you know, putting up all these posters. We did hit a 11 nerve. Somebody ripped them all down. And, the 12 investigator never tried to look back at it. 13 14 And, there's cameras down the streets, apparently, so that would probably show who was ripping 15 those pictures down. But, we figured that would be some 16 kind of information to see who was ripping them down, give 17 us an idea that whoever's nerve it's striking -- you know 18 what I mean? 19 But, nothing was ever done or said about it. 20 21 So, I just left it alone, too. And, we always look back 22 just to see, like, are we just seeing things that those pictures are gone down? And, it only took them a month to 23 be ripped down. So, I don't know. 24 25 MS. STEPHANIE STARR: Like, slow us down, or 8 side track us, or just delay things, it felt like. 9 10 MS. JENNIFER GUIMOND: Delay, yeah. MS. STEPHANIE STARR: We still have some. 14 Ι still have some. 15 16 MS.
