I researched, networked with the designers, provided a budget report to the executive on the cost and implementation of the program. I developed SOG's for the program and created a training video on DISC for more than 1600 police and civilian members.

On occasion I have also been required to act in an undercover capacity to purchase illegal drugs and acted in an undercover capacity in illegal gaming investigations. I have also acted in an undercover capacity in a number of bawdy house, escort/escort agency investigations utilizing the internet.

Lead investigator and case manager on Project "ICE" that led to the shutting down of the largest escort agency in Winnipeg. The agency ran for more than 10yrs in the City of Winnipeg and employed more than 50 escorts at one given time. The investigation encompassed a 9mth period, that led to numerous search warrants across Canada and the arrest of 5 key persons with links to other organized crimes.

I also participate in some activities, lectures and counselling sessions with the women involved in the sex trade.
