It is respectfully submitted that the subject matter of these United Nations Optional Protocols, and the General Comments of the Committee on the Rights of the Child bear on, and inform, the subject matter of the Part II hearing "International Human Rights Law as a Foundation for the Inquiry's Work and Recommendations". Consideration of these materials will, in our respectful view, assist the Commission in fulfilling its mandate.

The Optional Protocol on the sale of children, child prostitution and child pornography is an international human rights treaty expanding on the obligations of States who have signed and ratified

the United Nations Convention on the Rights of the Child. Canada has ratified this Optional Protocol and is, therefore, bound to respect and implement it. While Canada has not signed or ratified the Optional Protocol on a communications procedure, it also informs the international framework of children's rights and was referenced by Mr. O'Soup in his evidence.

General Comments of the Committee of the Rights of the Child are meant to assist State Parties in the interpretation and implementation of various aspects of the United Nations Convention on the Rights of the Child (UNCRC). The UNCRC was entered as an exhibit by Mr. O'Soup. These documents are connected to his testimony to assist the Commissioners in understanding Canada's obligations under the UNCRC.
