NOTICE OF MOTION

- The Association of Native Child and Family Services Agencies of Ontario ("ANCFSAO") requests that the Commissioners of the National Inquiry into Missing and Murdered Indigenous Women and Girls ("National Inquiry") hear this motion, within 10 days, for the following relief sought by ANCFSAO from the National Inquiry:
 - a. Issuance of information regarding the reasons for the deferment of the funding application brought by ANCFSAO to the Commission Counsel for the National Inquiry; and
 - b. Issuance of a Contribution Agreement to ANCFSAO for funding retroactive to April 1, 2018 to ensure that ANCFSAO can reimburse counsel for work that has already been completed, and to ensure that ANCFSAO can meaningfully participate in the National Inquiry going forward, including at each of the recently-announced additional hearings.
- 2. ANCFSAO, as a party with standing in Parts I, II, and III of the National Inquiry, has the right under s. 26 (c) of the Legal Path: Rules of Respectful Practice for the National Inquiry to bring a motion before the Commissioners.
- 3. ANCFSAO indicated in its application for standing and funding that it would not be able to fully participate in the National Inquiry without funding from the National Inquiry.

- 4. This relief is sought by ANCFSAO because on July 14, 2017 the Commission Counsel advised ANCFSAO that its application for standing had been granted and that the Commissioners would recommend that funding be granted to ANCFSAO. On August 17, 2017 ANCFSAO was noted as the only party granted standing at the National Inquiry whose application for funding was deferred. Despite attempts made by counsel for ANCFSAO to request additional information regarding this deferment, ANCFSAO has not received a decision from the Commissioners regarding its application for funding.
- 5. ANCFSAO requested the Commissioners' guidance regarding ANCFSAO's role with respect to the deferment and obtaining a final decision. In letters to the Commission Counsel, dated October 18, 2017 and January 3, 2018, counsel for ANCFSAO inquired about further documentation or information that could be provided to the Commissioners to facilitate a timely determination of the funding application.
- 6. In accordance with the principles of procedural fairness and transparency, ANCFSAO requests that the reasons for the deferment of funding for ANCFSAO be provided. ANCFSAO also seeks a Contribution Agreement for funding to ensure its meaningful participation in the National Inquiry.
- 7. Counsel for ANCFSAO has completed many hours of preparatory work in anticipation of representing ANCFSAO at the National Inquiry. This work was completed with the belief that funding could be forthcoming once the reasons for the deferment were addressed.
- 8. ANCFSAO has been unable to meaningfully participate in the hearings which have taken place as part of the National Inquiry thus far. ANCFSAO has only been able to appear at two hearings: the Knowledge Keeper and Expert Hearings on Racism, held June 11 to 13, 2018 in Toronto, and the Institutional Hearings on Police Policies and Practices, held June 25-29, 2018 in Regina. ANCFSAO's counsel was able to appear at the Toronto hearing because they are located in Toronto and so had minimal travel costs. They were able to appear in Regina because they were also acting for another party which agreed to

front the travel costs. In both cases, counsel has not been paid for the hearing time spent representing ANCFSAO.

- 9. ANCFSAO will be unable to participate further in the National Inquiry without funding.
- 10. In support of this motion, the ANCFSAO relies on the Affidavit of Theresa Stevens, affirmed July 31, 2018, and its exhibits.
