C. Academic Profile

1. RESEARCH STATEMENT

I am a respected international leader in the field of Indigenous health research. My career has been focused on addressing inequities in the health of Indigenous peoples in Canada by bridging gaps in health knowledge and practice. My foundational contributions have included the development of guidelines for health professionals working with Indigenous peoples (PMID 23682204 - 142 citations); improving population based Indigenous health assessment and response, particularly for infants and children (PMID 16782494, 64 citations; 16966664, 72 citations; 20524380, 21 citations); and Indigenizing of knowledge translation theory and practice (PMID 15736639, 76 citations; 18281419, 30 citations). Recent innovations have included the application of respondent driven sampling to produce previously unavailable population based health needs assessment data for urban Indigenous populations in Canada (PMID 25011988, 26680428); identification of best practices in Indigenous maternal, infant and child health (PMID 26745867); and the development and testing of new approaches to training health professionals working with Indigenous peoples (PMID 25016481).

I aim in all aspects of my work to meet the dual criteria of scientific excellence and Indigenous community relevance. Since my arrival in Toronto in 2007, I have acquired over \$16 million of peer-reviewed funding as principal investigator (\$10.6 million over the past 5 years) and have negotiated and implemented applied health research partnership agreements with > 25 Indigenous organizations/communities.

I have published over 100 peer-reviewed scholarly articles, monographs, book chapters, and reports (>50 as first author) on the topic of Indigenous health and have one of the highest index factors in this field. I have published in high impact international journals including Social Science and Medicine, the Lancet, the American Journal of Public Health, and the CMAJ. I have also supported trainees in publishing in international journals such as BMJ Public Health. My recent discussion paper "First Peoples, Second Class Treatment: the Role of Racism in the Health and Wellbeing of Indigenous Peoples" was featured on CBC's the National and downloaded > 4500 times the week of release. In the past 5 years, I have presented > 75 times as an invited speaker regionally, nationally, and internationally to diverse audiences.

Tangible Indigenous community impacts of my research work include: contributing to the development of the Toronto Birth Centre (www.torontobirthcentre.ca) which incorporates Indigenous knowledge and practice into its day to day operations; substantive funding increases for Dedwadadehsnye's Health Access Centre following the release of the Our Health Counts health assessment report (www.ourhealthcounts.ca); and preservation and application of Indigenous oral history knowledge in the area of reproductive, child, and family health (ie. first Métis baby book; nine documentary films).

I have recruited a world class cadre of Indigenous health researchers, seconded health practitioners, students and staff to St. Michael's Hospital (SMH) and developed a highly productive Indigenous health research unit – the Well Living House (www.welllivinghouse.org), which is uniquely co-governed by a counsel of Indigenous grandparents and SMH. I have formally supervised over 50 trainees over my career including medical students, residents, graduate students and post-doctoral fellows – many of whom are now leaders in Indigenous health research, education, practice and policy.

I have had the good fortune of being able to collaborate internationally with Indigenous health scholars from Australia, Hawaii, New Zealand, and the United States since the beginning of my research career.

Evidence of the international scope and reputation of my work includes multiple international research collaborations, grants, publications, and conference presentations. For example, I was lead author and editor of the Indigenous Children's Health Report, an international collaborative review of Indigenous children's health in Canada, Australia, US, and New Zealand vetted by 22 Aboriginal health stakeholders at an international meeting hosted by SMH. This report has been cited in over 50 newspapers, 10 radio programs, and 5 TV programs, and was used as evidence to support the renewal of Aboriginal child program funding at the federal level in 2010. It is also extensively cited in a recent report on Aboriginal maternal child health released by the Health Council of Canada. In 2010 I led an international review of Indigenous birth outcomes with Indigenous health colleagues from Australia, New Zealand, and Hawaii and from 2010 to 2014 I was the Canadian principal investigator for a CIHR funded health literacy intervention that tested a new model of educating Indigenous patients about their cardiovascular disease medications. This intervention was very successful and we have published the protocol and are in the process of finalizing our publication of results. I have also helped organize and participated as a presenter in international Indigenous health meetings, including the International Network for Indigenous Health Knowledge; the Competencies for Indigenous Public Health Evaluation and Research Network; and the Pacific Region Indigenous Doctors Congress.

Closer to home I have supported the development of the new Waakebiness Bryce Institute for Indigenous Health at the DLSPH, by acting as co-chair of the ad hoc faculty committee tasked with developing the business plan (which was subsequently approved); recruiting a network of elders, knowledge keepers, Indigenous health researchers and community leaders to support the Institute and participate in a planning meeting in the fall of 2014; and participating on the hiring committee charged with recruiting the Institutes first permanent director

My outstanding health research accomplishments were recognized in 2012 with a National Aboriginal Achievement/Inspire Award and in 2015 when I was named a Top 20 Pioneer of Family Medicine Research by the Canadian College of Family Physicians.

2. TEACHING PHILOSOPHY

Similar to my research approach, at the foundation of my teaching philosophy is the same commitment to respect and apply both Indigenous community-based knowledge and practice and cutting edge public health sciences to the practice of public health. I draw on critical decolonizing adult education methods and encourage open dialogue, group discussion, self-reflexivity, and practical application of new concepts. Students and trainees that I supervise and/or participate in my classes are actively exposed experientially to Indigenous knowledge and practice through class and meeting processes; interactions with Indigenous knowledge keepers and elders; reading and lecture materials; and field trips to Indigenous communities/organizations. In addition to supporting students to deepen their understanding of diverse Indigenous knowledge and practices, students are exposed to the real time application of Indigenous knowledge and practice to public health research, policy and practice through practical examples.

For example, in the Advanced Applied Indigenous Health Research Methods class (CHL 7001, which I designed and which has now been turned into a permanent course offering) during the first half of the course students were exposed to a variety of high quality Indigenous knowledge and practice teachings through guest lectures, reading material, and media. They were supported in identifying key principles of Indigenous knowledge and practice that they could apply to their own research. The second half of the course provided practical examples of how these principles could be applied using specific protocols to their research (i.e. research agreements, specific research and analytic methods, knowledge dissemination strategies). Classes were held in the form of a discussion circle with sharing and reflections from each student at the beginning and end of each class. Students are overall highly appreciative of both the approach and the content and have shared that this is one of the few opportunities they have at DLSPH to be both exposed to Indigenous knowledge and practice and also to get practical advice on the specific protocols, methods and tools that can facilitate high quality Indigenous public health research, policy and practice. This is evidenced in my teaching appraisals.

In addition to teaching Advanced Applied Indigenous Health Research Methods class (CHL 7001) three times and working with Dr. Michelle Firestone to get it approved as a permanent course offering, key teaching contributions since my arrival at the University of Toronto/Saint Michael's Hospital in 2007 include:

- the formal supervision of over 50 research trainees at different levels of training and from different disciplines at the Well Living House;
- recurrent contributions as a guest lecturer on the topic of Indigenous health in the DLSPH (CHL5105, CHL5421); the Global Health Certificate Post-graduate Program; the Aboriginal Health Medical Student Elective Course; and Aboriginal Health 5350.
- the development of a funded educational research program in the area of Indigenous cultural safety training – for which I am now in the process of implementing a 3 arm RCT that would test an innovative cultural safety training program for health care providers at SMH
- the delivery of over a dozen lectures and workshops and three webinars to health and public health professionals, students and other interested stakeholders across the country on the topic of Indigenous culture safety over the past 2 years.

The Well Living House Action Research Centre for Indigenous Infant, Child, and Family Health and Wellbeing provides undergraduate and graduate students as well as post-doctoral fellows with a unique and enriched training environment which also supports simultaneous exposure to high quality Indigenous knowledge and practice and cutting edge health equity and public health sciences. This is achieved by the integration of Indigenous knowledge and practice into our day to day work; active involvement of the Counsel of Indigenous Grandparents and Indigenous community research partners; and the enriched applied health research environment of the Centre for Urban Health Solutions where we are situated. Over the past 9 years I have supervised and/or advised over 50 trainees in this context (primary supervisor or co-supervisor of 11 post-doctoral fellows, 9 CIHR/SSHRC funded; supervisor or advisor for 8 PhD students; supervisor for 4 MPH practicum students; supervisor for 5 resident physicians; supervisor for 4 medical students and 4 undergraduate students). Of the post-doctoral fellows I have supervised almost all currently now hold faculty/full time research scientist positions in the area of Indigenous health and/or health equity.

In summary, I have a unique and highly sought after teaching approach which is extremely popular with students and which has supported dozens of learners at different career stages and from different disciplines in acquiring essential knowledge, skills and experience for future success as public health researchers, educators, practitioners, and policy makers. I have also developed an educational arm to my research program that is focused on identifying best practices in Indigenous cultural safety training for health and social service professionals and I am a highly sought after speaker on the topic of racism, cultural safety and Indigenous health.

3. CREATIVE PROFESSIONAL ACTIVITIES STATEMENT

Over the course of my career, in addition to my research, clinical practice, and teaching contributions I have worked consistently to promote and support Indigenous health and public health careers, with a focus on individual and collective support for Indigenous physicians, Indigenous midwives, and Indigenous public health professionals. Since residency I have been an active participant in Indigenous physicians associations both nationally and internationally. This started with membership in the Native Physicians Association of Canada (NPAC), was followed by successful advocacy to refund a national Indigenous physicians association when the federal funding for NPAC was discontinued, and culminated in the successful start-up of the Indigenous Physicians Association of Canada, for which I was the inaugural vice-president. I have also participated in the Pacific Regional Indigenous Physicians Congress (PRIDOC) – attending, presenting at meetings and supporting their organization. I have formally and informally mentored dozens of Indigenous medical students, residents, and peer physicians. I was the first family physician chair of an SOGC Committee as chair of their Aboriginal Health Committee from 1999-2002. For this work I was awarded the prestigious SOGC President's Award. More recently, I was an inaugural member

of the Indigenous Working Group of the College of Family Physicians of Canada and chaired this group from 2012-2015. I co-led the production of a fact sheet on Systemic Racism during my term as chair.

Though my work at the SOGC, as well as local initiatives in Toronto and Six Nations, my research program, and my clinical work, I have supported the revitalization of Indigenous midwifery in Canada for the past 18 years. I supported the early development of the Birthing Centre at Six Nations as a consultant and have been advocating and organizing for enhanced access to holistic maternity care for Indigenous women in Toronto since 1996. I have formally and informally supported Indigenous midwives in clinical practice, research, and policy. Working in partnership with Seventh Generation Midwives Toronto (SGMT) we were able to get funding for a birth visioning meeting that paved the way for SGMT to be the successful lead agency in the development of the Toronto Birth Centre, which has an Indigenous governance process. Since 2007 I have been practicing part time as a consulting family physicians at SGMT. I have also worked with international Indigenous public health research collaborators from Australia, Hawaii, New Zealand, and the United States to create the Competencies in Indigenous Public Health Research and Evaluation (CIPHER) group and hosted an international meeting during my sabbatical in Hawaii in 2010.

As part of my Indigenous knowledge translation work, in addition to scholarly papers, community reports, and other publications I have lead the development and delivery of innovative Indigenous research gatherings and media productions. For example, in 2005, working in partnership with multiple regional and national Indigenous organizations, including the National Aboriginal Health Organization and the National Collaboration Centre for Aboriginal Health, I hosted the first Indigenous Knowledge Translation summit at the First Nations University of Canada. This included a peer reviewed abstract driven series of presentations; panel presentations by respected Indigenous knowledge keepers; an evening event featuring a multi-course meal of traditional Indigenous food, a curated art show, musical performances, and storytelling; and the production of an interactive DVD and meeting report. This was all part of a CIHR funded operating grant entitled Knowledge Translation and Indigenous Knowledge. In 2013, as part of another CIHR operating grant entitled Indigenous Knowledge Networks for Infant, Child and Family Health I supported the production of 7 short digital stories by the community participants in this project who were Indigenous prenatal, birthing, and infant-toddler health promotion workers, managers, and service providers. In the same year I also supported the production of a short film documenting our CIHR funded meeting planning and dissemination meeting regarding the development of an Indigenous birth centre in Toronto. This film and the meeting report were subsequently part of a successful funding submission to the Ontario Ministry of Health and Long Term Care. Over the past year I have supported the production of a brief documentary film on Racism and Indigenous Health that was produced as part of our international meeting linked to the release of the report First Peoples, Second Class Treatment: The Role of Racism in Indigenous Health and Wellbeing in Canada. This seven minute video will be used in trainings and orientations for health care professionals at St. Michael's Hospital and across the province.

With respect to the professional practice of public health, I have made substantive contributions throughout my career in the advancement of better Indigenous health measurement systems. I have worked with international Indigenous public health research collaborators in Australia, New Zealand, and the United States to examine Indigenous health measurement and program evaluation in the four countries, generally and with a focus on infant and child health status and programming. I uncovered significant problems with the measurement of birth outcomes for First Nations, Métis, and Inuit in Canada and co-chaired a national committee that included members from First Nations and Inuit Health Branch and the Canadian Perinatal Surveillance System of Health Canada that had the mandate to try and address this situation. Upon my advice, the Canadian Perinatal Surveillance System adopted a new Aboriginal demographic indicator as one of their recommended indicators. My published reviews of Indigenous infant mortality in Canada and birth outcomes and child health outcomes internationally have helped unmask persistent and striking Indigenous/non-Indigenous health inequities.

More recently, our team has uncovered strong evidence that Statistics Canada has been underestimating the size of Indigenous populations in southern urban centres by 200-400% and also dramatically underestimating the prevalence of poverty among this same population. I have been actively disseminating these findings to local, provincial and national health planning and policy making tables. I am a member of the National Statistics Council of Canada and a strong advocate for enhancing Indigenous health and social information in partnership with communities.

I am also a published poet. Most recently Indigenous author and scholar Dr. Neal McLeod has accepted 2 of my poems for an anthology he is editing entitled: *Cîhcêwêsin: New Poetry from Indigenous Saskatoon* which is currently in press.
